6. Approval of recommendations issued by AGRI Coordinators during their meeting of 18 June 2020

1. EXCHANGE OF VIEWS WITH RAPPORTEURS CONCERNING THE CAP LEGISLATIVE PROPOSALS - STATE OF PLAY & NEXT STEPS

Decision: *For the CAP Strategic Plans: the Coordinators endorsed the Chair's proposal to send a letter to ENVI giving them one week of reflection about their decision to leave the negotiating table.*

If ENVI stick to their decision and doesn't provide any solution as regards the shared competences, then AGRI will keep on negotiating, aiming to a majority in plenary.

For the Horizontal regulation/CMO: the Coordinators agreed to organise a last round of Shadow meetings to agree on potential Plenary amendments.

Finally Coordinators confirmed their will to aim for a vote in Plenary in October II session.

1.2. REPORTING ON THE 2ND TRILOGUE ON THE CAP TRANSITIONAL REGULATION

Outcome: *Ms Katainen briefed the Coordinators on the negotiations on the CAP*

transitional regulation.

Both legislators agreed to move to 2 years transition period, while the Commission was not able to decide on this point.

The target now is to get a deal with the Council on 30th June.

The Coordinators endorsed Ms Katainen's approach in the negotiations.
