## **6. FOR INFORMATION**

### **6.1. Revised EP Rules of Procedure as of 1st November 2023**

An updated version of the EP Rules of Procedure has been adopted by the plenary on 13th September 2023, and it entered into force on Wednesday 1st November 2023. It is based on the 14 point reform plan “Strengthening integrity, independence and accountability”, presented by President Metsola, and the Bureau adopted implementing measures on 16th October 2023.

The changes concern in particular the Code of Conduct for Members regarding

integrity and Transparency (Annex I of EP RoP).

This update come with new obligations for Members, which are related to the activities of Committees.

**A) Obligation for Rapporteurs - "*legislative footprint*"** concerns the declaration of inputs to report or opinion (Article 8, Annex I, RoP)

- Rapporteurs shall list the entities or persons from whom they received input on matters pertaining to the subject of the file;
- this declaration became mandatory and has to be included in all tabled file (reports and opinions);
- Without this declaration, the file will not be accepted (by the responsible committee or the plenary services).

**B) Obligation for Members - conflicts of interest** (Article 3, Annex I, RoP)

- Before being appointed as Chairs, Vice-Chairs, Rapporteurs, Shadow Rapporteurs, participants in inter-institutional negotiations or in delegations, Members have to declare whether or not he/she is aware of having a conflict of interest in the exercise of their duties (filling an e-form);
- Members received a guide summarising their new obligations, including how to meet them, and implementing measures by the Bureau;
- The new rules **do not concern current** rapporteur/shadow/participants to delegations. However, if there is a change of MEP or his/her awareness changes in the course of the exercise of their duties, he/she has to inform the President or the respective Chair;
- If a Member declares to be aware of having a conflict of interest, there are different procedures:
  - For office holders (*Chair or Vice-Chair*): the Member can take up the office only if the committee decides that the conflict does not prevent the Member from exercising the mandate;
  - For *rapporteurs*: the appointment is possible only if the respective committee agrees (with a vote);
  - For *shadow rapporteurs or participants in inter-institutional negotiations*: the appointment is possible with the agreement of the political group. However, the committee can oppose with a vote.

On this basis:

- Members who have not filled the declaration cannot be appointed as Chairs, Vice-Chairs, Rapporteurs, Shadow Rapporteurs or participants in inter-institutional negotiations. Therefore, before publishing the information, the committee secretariat requests also the confirmation that the appointed Members have filled the e-form;
