Baineann na hathruithe go háirithe leis an gCód Iompair do na Feisirí maidir le hionracas agus trédhearcacht (Iarscríbhinn I de Rialacha Nós Imeachta PE). Tagann oibleagáidí nua do na Feisirí leis an nuashonrú sin, oibleagáidí a bhaineann le gníomhaíochtaí na gCoistí.
