European Parliament resolution on the situation in Kosovo

The European Parliament,

- having regard to its previous resolutions on Kosovo,
- having regard to the President-in-office's call for the immediate end to violence in Kosovo,
- having regard to the Presidency statement on riots in Kosovo made in the Permanent Council of the OSCE,
- having regard to Rule 37(2) of its Rules of Procedure,
- A. alarmed by the worst outbreak of violence in Kosovo in five years, which resulted in dozens of deaths, about a thousand people injured and the destruction of several hundreds of houses and schools, churches, monasteries and other buildings throughout Kosovo,
- B. deeply concerned for the thousands of members of the Serbian community in Kosovo who are reported to have fled their homes as a result of the violence,
- C. concerned at reports of attacks against religious institutions in Serbia itself and Kosovo,
- 1. Calls for an immediate end to the violence which has claimed lives and caused injury to large numbers of civilians, KFOR soldiers and UNMIK civilian police;
- 2. Considers that the immediate priority is that calm be restored in Kosovo and that violence stops now and is not allowed to escalate;
- 3. Extends condolences to the people of Kosovo and the families concerned;
- 4. Condemns the recent attacks and the killings of Serbs in Kosovo, as well as the destruction of religious buildings and shrines;
- 5. Calls on all local leaders to act responsibly at this dangerous moment and to use all their influence to bring an end to the violence and restore calm;
- 6. Demands that the Albanians in Kosovo allow their Serbian compatriots who fled to areas under KFOR protection to return to their homes;
- 7. Demands that both sides dismantle all parallel paramilitary and organisational structures in Kosovo;
- 8. Calls on the political leaders both in Pristina and in Belgrade to participate in and facilitate a thorough police investigation into the incidents that led to the clashes;



- 9. Expects the UN to transfer in the near future a substantial part of its current powers in Kosovo to the Kosovo Government;
- 10. Strongly supports the efforts of the Special Representative of the UN Secretary-General, Harri Holkeri, to calm the situation;
- 11. Underlines the importance of pursuing the direct dialogue between Belgrade and Pristina;
- 12. Instructs its President to forward this resolution to the Council and Commission and to the Government of Serbia and the Kosovo Government.
