As a consequence of and in addition to the above proposed amendments, the provisions (rules and annexes) of the Rules of Procedure listed in this amendment should be amended so as to replace 'political group (or groups)' throughout with 'political **and national** group (or groups)' or 'political **or national** group (or groups)', as appropriate.

Justification

Different Member States of the European Union have their own specific needs and priorities which need to be discussed across party lines, often in consultation with the Ambassador of their country to the European Union and his staff. The current practice of having meetings of national delegations of specific political groups does not exhaust the scope of concerns that may be relevant to a particular issue from the point of view of the interests of individual countries. For such consultations across political boundaries to be effective, the national groups should have an appropriate status and the necessary technical facilities (rooms, staff, etc.) in Parliament.

Participation in a national group should not prevent a Member from belonging to a political group of his or her choosing or from remaining non-attached. For this reason, the current reading of Chapter 4 of the Rules of Procedure is inadequate.
