European Parliament resolution on the crackdown on the right to education and education rights activists in Afghanistan, including the case of Matiullah Wesa (2023/2648(RSP))

The European Parliament,

- having regard to its previous resolutions on the situation in Afghanistan, in particular that of 24 November 2022,
- having regard to the Council conclusions on Afghanistan of 20 March 2023,
- having regard to the UNICEF call on de facto authorities to allow girls to return to secondary school in Afghanistan of 21 March 2023,
- having regards to the comment by the UN Human Rights spokesperson on Afghanistan on 29 March 2023,
- having regard to Rule 144 of its Rules of Procedure,
- A. whereas women and girls have faced growing restrictions to their fundamental rights since the Taliban takeover in access to education and employment, and freedom of movement; whereas women have been virtually erased from all areas of public life;
- B. whereas girls over 12 years old are denied an education in Afghanistan; whereas female students are banned from attending seventh grade and above; whereas this is a violation of the fundamental right to education as enshrined in the Universal Declaration of Human Rights;
- C. whereas Matiullah Wesa is head of the Pen Path organisation, which campaigns for the re-opening of schools for girls and women in Afghanistan and calls for their full access to education;
- D. whereas Matiullah Wesa was detained on 27 of March 2023 after evening prayers when leaving a mosque in Kabul by a group of armed men who claimed they represented the General Directorate for Intelligence;
- E. whereas on 29 March 2023 a Taliban representative confirmed that Matiullah Wesa was arrested and subject to investigation for illegal activity, which was not further elaborated;
- F. whereas international organisations have expressed alarm by ongoing arbitrary arrests and detentions of civils society activists in Afghanistan who speak out against discriminatory policies against girls and women;
- 1. Calls on the de facto authorities of Afghanistan to immediately and unconditionally release Matiullah Wesa from detention as well as other campaigners indiscriminately detained; demands that his rights need to be respected, including access to family members and legal representation;

- 2. Reminds its condemnation of the de facto authorities for their restrictions on the exercise of women and girl's rights, in particular the ban on secondary education for girls; reminds the Taliban's un-kept promise that women's access to education would be restored; calls on the Taliban to urgently reverse their repressive decisions on restricting women's and girls' education and to restore their full, equal and meaningful participation in public life;
- 3. Expresses strong support for the courageous and necessary work carried out by such activists and campaigners like Matiullah Wesa and his organisation; calls on the European Commission to consider how it can support the valuable work of activists campaigning for girls education in Afghanistan;
- 4. Calls on the EEAS to exert diplomatic pressure directly or indirectly with the de facto Taliban authorities to secure the release of Matiullah Wesa and other campaigners indiscriminately detained;
- 5. Instructs its President to forward this resolution to the Council, the Commission, the VP/HR and the EU Special Envoy for Afghanistan.
