## SHORT JUSTIFICATION

The Commission has proposed a regulation amending the regulation setting up the European GNSS Agency (GSA). The proposal is primarily addressing governance issues linked to security accreditation but also brings the GSA regulation in line with the Common Approach on decentralised agencies agreed in July 2012 by Parliament, Council and Commission. Furthermore, and from a budgetary perspective most relevant, are the changes proposed to the legislative financial statement to reflect the new tasks for GSA deriving from the future GNSS regulation (Regulation on the implementation and exploitation of European satellite navigation systems; COM (2011) 814). The Commission proposal for the future GNSS regulation foresaw an overall amount of EUR 7 897 million at current prices for the 2014-2020 MFF period.

After the political agreement on the next Multiannual Financial Framework, the Commission adopted on 10 July 2013 a Communication on "Programming of human and financial resources for decentralised agencies 2014-2020"(COM(2013) 519) which foresees a total EU contribution to GSA of EUR 200,2 million for the years 2014-2020. This amount is 2% lower than the EUR 204,3 million the Commission had previously considered for the Agency's needs in order to fulfil its tasks as indicated in the legislative financial statement of the present draft regulation.

Your Rapporteur is seriously concerned about the Commission's general approach in the Communication and requests that the Commission present, an explanation as to how Agencies shall fulfil their tasks in the future.

Another aspect of concern is linked to the fact that from 2014 onwards the Commission will stop directly supporting Type II European Schools and that it will be up to the Agencies concerned (like GSA) to provide the necessary funding. The Commission claims that the appropriations provided so far will be transferred to the budgets of the Agencies concerned. But given the overall reductions of appropriations as a result of a lower multiannual financial framework, Agencies will face massive difficulties in providing this funding for Type II European Schools. As a consequence, Agencies such as the GSA will find it even harder to attract qualified temporary staff from all Member States.

Finally, your Rapporteur wishes to underline the problem the GSA is facing due to the correction coefficient that is applied to remunerations of the Agency's staff. Currently this factor is calculated on the average for the Czech Republic, which bears no relation to the actual costs of living in the metropolitan area of Prague.
