

Stresses that, in accordance with Article 6 of the EGF Regulation, it should be ensured that the EGF supports the reintegration of individual redundant workers into employment; reiterates that assistance from the EGF must not replace actions which are the responsibility of companies by virtue of national law or collective agreements, nor measures restructuring companies or sectors;

Stresses that the intervention criteria as defined in Article 2 of the original Regulation (EC) No 1927/2006 allow for clearer differentiation, compared to the revised version of 2008, as to the scope of the EGF vis-a-vis other, more longterm, programmes to achieve economic growth and labour market stability; reiterates that assistance from the EGF must not replace actions which are the responsibility of companies by virtue of national law or collective agreements, nor measures restructuring companies or sectors:
