- put a regular point on Ukraine on the agenda of Coordinators' meetings to get up-to-date regular information on the developments from the budgetary point of view;
- organise a dedicated workshop to look into the short- and long-term budgetary implications of MFA;
- write a letter to INTA/CCC Chair on the Commission's use of the urgency procedure in relation to the MFA, its inherent risks in terms of budgetary exposure, and BUDG's role, following publication of the forthcoming proposal.

### **3.3. HERA letter - proposal Article 122**

The Coordinators endorsed the draft letter to President Metsola detailing the outcome of the budgetary scrutiny procedure for HERA and decided to consider the possible budgetary implications of the recent gas proposal under Article 122 TFEU at their next meeting.

### **3.4. International pledges**

The Coordinators decided to mandate the Chair to send the draft letter to President Metsola asking her to request from the Commission President more exhaustive and timely communication to the budgetary authority in case of Union pledges at international conferences.

### **3.5. Draft calendar of committee meetings in 2023**

- BUDG is invited to the AFET hearing on ‘Recovery, reconstruction and resilience of Ukraine: assessing the feasibility of a Marshall Plan-style facility and of enhanced coordination of defence related support’.
- The BUDG hearing on ‘Financial impact of the war in Ukraine: current and future challenges for the EU budget’ ***will no longer cover RePowerEU. A separate hearing on RePowerEU will be requested to take place in the first half of 2024.*** This hearing would be organised jointly with ECON.
- BUDG has asked to be invited to the SEDE hearing on the European Peace Facility (***confirmation by SEDE received after the closing of the written procedure***).
