1. CHAIR'S ANNOUNCEMENTS

1) Feedback from Exchange of views in the Conference of Presidents on HERA/Article 122 TFEU

The Chair reported about the exchange of views on Article 122 proposals at the meeting of the Conference of Presidents during the November part-session.

2) Update on Ukraine package

The Chair reported on the agreement reached by the ECOFIN Council on 6 September, and on the next steps in Parliament.

3) Meeting with incoming Director-General for Budget

The new Director-General of DG BUDG will be invited for an exchange of views during the coordinators' meeting on 30-31 January.

4) BUDG requests for expertise in 2023

The Policy Department will circulate to the political group advisors an initial list of possible topics for expertise that could be useful to the committee in 2023. A brainstorming meeting with political group advisors, the BUDG secretariat and the Policy Department will be held in the second week of January to further discuss and shortlist the preferences among these initial ideas. The Coordinators will be invited to provide the proposals by their groups by the end of the third week in January, so that Coordinators can take a final decision at our meeting of 30-31 January.

2.2. Budget 2023 - Post-Mortem

(in the presence of the rapporteurs for the 2023 and 2024 budgets)

The Coordinators discussed relevant features of the 2023 budgetary procedure and implications for 2024. Political groups may send further feedback in writing to the secretariat by close of business on 11 January 2023.

2.3. Interinstitutional NGEU and payments meetings

The Coordinators tasked the secretariat with examining with the Council and Commission whether payments and NGEU meetings could henceforth be merged, though leaving open the possibility of returning to separate meeting in future if judged necessary.

2.4. Proposal for a Regulation of the European Parliament and of the Council establishing a Single Market emergency instrument - opinion in the form of a letter

The Coordinators agreed to put the draft opinion to the vote at the BUDG meeting of 12 January 2023.

2.5. Follow-up of the meeting on the European Court of Auditors Special Report 09/2022 on "Climate spending in the 2014-2020 budget" - 7 November

The Coordinators approved the draft letter to be addressed to Commissioner Hahn asking for a follow-up of the 7 November meeting on the European Court of Auditors Special Report 09/2022 on "Climate spending in the 2014-2020 budget in the form of a joint Coordinators' meeting between BUDG, CONT and ENVI, in the presence of DG BUDG and DG CLIMA, and asking for appropriate Commission representation at future meetings, beginning with the workshop organised by the Policy Department on the role of EU budget in international climate finance next year.

The Coordinators further agreed that, following the joint Coordinators' meeting and the workshop, a further joint committee meeting could be organised with the European Court of Auditors to discuss its report on the performance of the EU budget.

2.6. European Parliamentary Week 2023

The Coordinators endorsed, in principle, the preliminary list of topics set out in Annex 2.6 "EPW thematic focus", subject to agreement by the other committees involved (ECON and EMPL) and the Swedish Parliament.

The Coordinators endorsed the following proposed topics for the BUDG inter-parliamentary committee meeting (the titles have been shortened to fit the draft agenda:

- Topic I: "Climate change, energy, inflation: what role for the Multiannual Financial Framework and Own Resources, and how to best create synergies with national interventions?"
- Topic II: "Support for Ukraine - national and EU budgetary crisis response: how can parliamentary scrutiny be sufficiently preserved?"

The Coordinators mandated the Chair to liaise with the other committee chairs to finalise the programme.

A written procedure will follow for proposals for speakers.

2.7 Mission to Moldova

The Coordinators approved the composition of the delegation for the BUDG mission to Moldova, which will take place from 21 to 23 February 2023.
