### **Feedback on CCC reflection day on 7 March and CCC exchange of views with President Metsola on 14 March**

On 7 March, the Chair attended a Conference of Committee Chairs (CCC) reflection day entitled "Towards a more modern and efficient Parliament", which focused on improving committee cooperation and the challenges related to proposals under Article 122 of the Treaty on the Functioning of the European Union and the application of the urgency procedure in Parliament (Rule 163). There was a follow-up exchange of views in the CCC with President Metsola on 14 March on the same topics.
