BUDG/ECON Coordinators' consultation: RRF WG planning 2024 // 34th RRF WG

Since no objections were raised to the proposals included in the BUDG/ECON Coordinators consultation of 22 November 2023, the following has been decided:

- 1) The last RRF meeting foreseen in the RRF annual work programme for 2023 is exceptionally not taking place in 2023. The topics foreseen to be covered in this meeting will be included in the next RRF WG meetings.
- 2) Two more RRF WG meetings will be organised until the end of term:
 - a. 1st RRF WG in January 2024 (invited speaker: Commission)
 - i. Commission presentation on the state of play, followed by an overview of the lessons learned from the RRF for the future of EU strategic investments
 - b. 2nd RRF WG in March 2024 (invited speaker: Commission, Europol, EPPO, ECA)
 - i. Commission presentation on the state of play, followed by an in-depth discussion of the independent evaluation report on the RRF implementation (COM is legally required to present the report by 20 February 2024)
 - ii. Discussion with Europol, EPPO and ECA on their latest findings with regard to the RRF implementation (incl. the ECA special report on RRF absorption, if available)

As requested by the Greens, the Commission will be asked to provide a note on the planning of payments for the different Member States per year until 2026, including an indication of delays, where relevant, and the underlying reasons before the next RRF WG meeting.

Referrals on "one substance, one assessment" package

As no objections were received by the deadline of 15 December COB, BUDG requested rule 56+ for the referrals on the "one substance, one assessment" package.

Input to the ECA work programme for 2025+

As the secretariat received no additional suggestions for the ECA's 2025+ work programme by the deadline of 12 January COB, the initial ideas from the Secretariat will be put for decision in the coordinators' meeting on 24 January.

Referrals on the "Defence of Democracy" package

On 12 December 2023, the Commission adopted the so-called "Defence of Democracy" package. The aim is to enhance transparency and democratic accountability of interest representation activities on behalf of third countries which are aimed at influencing policies, decision making and the democratic space.

As no objections were received by the deadline of 12 January COB, BUDG will not issue an opinion for the referrals on the "Defence of Democracy" package.
