The transactions subject to audit by the European Court of Auditors in the section concerning migration and security of Chapter 8 "Security and Citizenship" of its Annual Report 2018 represent EUR 1.5 billion excluding decentralised agencies, or approximately 1% of the EU budget.

Most of the expenditure for migration and security is from two funds: the Asylum Migration and Integration fund (AMIF) and the Internal Security Fund (ISF). The management of most AMIF and ISF funds is shared between the Member States and the Commission. The objective of AMIF is to contribute to the effective management of migration flows and to bring about a common EU approach to asylum and immigration. The ISF aims to achieve a high level of security in the EU. It has two instruments: ISF Borders and Visa and ISF Police.

The audit scope for this MFF heading does not allow for a quantified conclusion on the level of error. The Court, nevertheless, highlights one main issue where there is scope for improvement. It concerns the controls on procurement.

Regional policy is part of Chapter 6 in the European Court of Auditors' Annual Report entitled "Economic, social and territorial cohesion". The main policy instrument is the European Regional Development Fund (ERDF).

In 2018, payments reached EUR 39,5 billion. In 2018, the Commission accepted accounts with expenditure for 248 out of 419 approved Operational Programmes (OPs) (around EUR 11,9 billion). These accounts came from 202 assurance packages submitted by all 28 Member States for the 2014-2020 programming period. In addition, the Commission closed or partially closed 217 OPs (around EUR 11,7 billion) from the 2007-2013 programming period. The audit population (around EUR 23,6 billion) consisted of the expenditure included in these assurance packages for the 2016/2017 accounting year (2014-2020 period) and the expenditure certified by certifying authorities and underlying audit authorities' final control reports for 2007-2013.

The Court examined the following for 'Economic, social and territorial cohesion' in 2018:

- a sample of 220 transactions, designed to be statistically representative of the full range of spending under MFF sub-heading 1b, which the audit authorities had previously checked;
- the work done by audit authorities to validate the information contained in the 24 assurance/closure packages, also using the sample of 220 transactions;
- the Commission's audit work, after the acceptance of the accounts, to check regularity aspects of the 2014-2020 assurance packages;
- the Commission's work when reviewing and validating the error rates reported in the 2018 assurance/closure packages. ECA also looked at the relevance and reliability of the regularity information in the AARs of DG REGIO and DG EMPL and its inclusion in the Commission's Annual Management and Performance Report (AMPR).

The Court has quantified the estimated level of error at 5,0%. DG REGIO claims the residual error rate to be 1,9%.

Background

The Members of the European Court of Auditors shall be appointed for a term of six years. In accordance with Article 286(2) of the TFEU the Council, after consulting the European Parliament, shall adopt the list of Members drawn up in accordance with the proposals made by each Member State.

The following candidates have been proposed by the Member States:

- **Alex Brenninkmeijer**, Candidate nominated by Netherlands
- **François-Roger Cazala**, Candidate nominated by France
- **Joelle Elvinger**, Candidate nominated by Luxembourg
- **Klaus-Heiner Lehne**, Candidate nominated by Germany
- **Nikolaos Milionis**, Candidate nominated by Greece

Appointments to the ECA are submitted to Parliament's plenary on the basis of a report from CONT, which takes into account the primary law requirement of Article 286(1) of the TFEU: "*the Members of the Court of Auditors shall be chosen from among persons who belong or have belonged in their respective States to external audit bodies or who are especially qualified for this office. Their independence must be beyond doubt.*", as well as other considerations.

A. Procedure

According to Rule 129 (1) of Parliament's Rules of Procedure, "*candidates nominated as Members of the Court of Auditors shall be invited to make a statement before the committee responsible and to answer questions put by members. The committee shall vote on each nomination separately by secret ballot.*"

I. Questionnaires and statements

In preparation for the hearing, each **candidate** has been asked, in both cases, i.e. a first appointment and a renewal of mandate, to answer the **questionnaire** prepared by CONT.

II. The hearing

The hearing will take place according to the timetable set out in the draft agenda. Each candidate will be invited to make an opening statement (5 minutes) and the remainder of his hearing will be devoted to replies to questions from Members 40 minutes in case of a first mandate, and 25 minutes in case of renewal.

III. Evaluation, votes and adoption of draft report

Once all the hearing have been completed, the committee will hold an evaluation of the candidates and then proceed to vote on each nomination. Evaluation, votes and adoption of draft report **will be in camera**.

According to Rule 129 (1), the committee shall vote by secret ballot. The vote may be carried out by means of the electronic voting system in accordance with Rule 192. Members should indicate for each candidate whether they give a favourable opinion, a negative opinion or abstain.

B. The report

The format of opinions on candidates for membership of the Court of Auditors is defined as follows¹:

- a) each recommendation on each nomination shall be submitted in the form of a report, to be adopted on the basis of a majority of the votes cast, with the report merely indicating the nomination;
- b) the report shall consist of:
 - i. citations summarising the circumstances of the referral to Parliament;
 - ii. recitals outlining the procedure to the competent committee;
 - iii. operative text which may only consist of a favourable opinion or an unfavourable opinion;
- c) citations and recitals shall not be put to the vote;"

These strict rules on procedures, before the Committee on Budgetary Control and in plenary sitting, adopted by Parliament **do not allow any amendments** to be tabled to the draft report.

The draft report will be finalised, according to the outcome of the evaluation and the vote in committee. The candidate's curriculum vitæ and the answers to CONT questionnaire or summary shall be annexed to the report.

The report for plenary will state that Parliament delivers either a favourable or a negative opinion on the appointment of the candidate.
