In his draft report, Joachim Kuhs welcomes the fact that the Court of Auditors finds the EU accounts for 2019 to be reliable and that the Court concluded that revenue was free from material error in 2019, but deeply regrets, however, that for the first time in four years the Court had to issue an adverse opinion on the legality and regularity of the expenditure underlying the accounts. The rapporteur also expressed his concern that outstanding commitments have continued to grow, reaching EUR 298 billion at the end of 2019.

The Rapporteur calls on the Commission to closely follow payment needs and take action, within its institutional remit, with a view to ensuring the availability of payment appropriations taking into account the risk of insufficient payment appropriations and the extraordinary needs arising from the COVID-19 pandemic. He calls on the Commission to re-assess, in the context of the COVID-19 crisis, whether the existing mechanisms to mitigate the exposure of the EU budget to risk are sufficient and appropriate and review the target provisioning rates of the guarantee funds covering the guarantees granted from the EU budget. Mr Kuhs also insists that the Commission presents a complete picture of the exposure of the EU budget in the annual 'Report on guarantees covered by the general budget'. The rapporteur calls on the Commission to provide Member States with regular support in selecting the riskiest importers for post-release audits, as well as to revise its procedures in the monitoring of TOR open points and setting deadlines for Member States to address shortcomings.

In the course of the preparation of the European Development Fund (EDF) discharge report for 2018, the Committee submitted written questions to the Member of the European Commission responsible for International Cooperation and Development, Ms Jutta Urpilainen, and to the Director General and Deputy Head of Operations of the European Investment Bank (EIB) for Operations outside the EU, Mr Luca Lazzaroli, on 20 November 2019.

On 1 December 2020, CONT Members held an exchange of views with Commissioner Urpilainen on the findings concerning the EDF chapter of the Court of Auditors (ECA) 2019 Annual Report, in the presence of Mr Baudilio Tomé Muguruza, Member of the European Court of Auditors.

In his draft report, the Rapporteur emphasises the following issues: (i) the adverse opinion of the Court of auditors on the legality and regularity of expenditure, which, with an estimated level of error of 3,5 %, surpassed the materiality threshold and which concern mainly recurring errors; (ii) the absence of reservations for 2019 due, inter alia, to a 'de minimis' threshold, taking away a relevant indicator for the EPs scrutiny of the EDFs' operations.

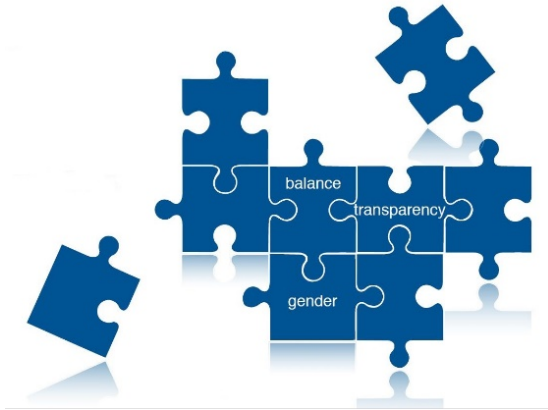

The number of decentralised agencies being subject to discharge for the financial year 2019 is 32, the same as in the previous year. In addition to the draft reports on the decentralised agencies, the Rapporteurs, Mr R. Czarnecki and Mr J. Brudziński will present a horizontal report, with observations from across the agencies. The draft reports are based on the European Court of Auditors' Annual Report on the agencies, and the following documents containing information on the agencies' financial management for the 2019 financial year:

- Reports on the follow-up of the previous year's discharge resolutions;
- Reports on 2019 budgetary and financial management;
- 2019 annual activity reports;
- Answers by the Agencies' Network and by individual agencies to the written questions by the CONT Committee; and
- Oral replies provided in the course of the CONT hearing of 7 January 2021.



Out of the 32 decentralised agencies subject to the discharge procedure, the European Court of Auditors issued a clean opinion on the reliability of the accounts for all agencies meaning that the final accounts present fairly, in all material respects, their financial position at year-end.

The European Court of Auditors issued a clean opinion on the legality and regularity of the payments underlying the accounts for all agencies, except for two agencies, the European Asylum Support Office (EASO) and the European Union Agency for the Cooperation of Energy Regulators (ACER), for which the Court issued a qualified opinion on the legality and regularity of the payments underlying the accounts, mainly caused by procurement related errors.

The draft reports for the other agencies focus, inter alia, on issues related to the reliability of accounts, the legality and regularity of transactions, internal controls, budget implementation, procurement, staff policy, prevention and management of conflicts of interest and transparency.

The Rapporteur, Mr Czarnecki, will present his draft reports on discharge in respect of the implementation of the budget of the Joint Undertakings (JUs) for the financial year 2019. The individual JUs' reports observe various matters needing improvement such as in the areas of budgetary and financial management, in-kind contributions, internal controls, monitoring of grant payments, procurement procedures, and human resources, and look at outstanding issues, efforts, and progress made by the JUs during 2019.

Currently, seven JUs subject to the 2019 discharge are implementing H2020 projects in the areas of transport (CS, S2R, and SESAR), transport/energy (FCH), health (IMI), bio-based industries (BBI) and electronic components and systems (ECSEL), and are planned to be operational until 2024. Fusion for Energy (F4E), created in 2007 for a period of 35 years, under the Treaty establishing the European Atomic Energy Community (Euratom), is responsible for providing Europe's contribution to the International Thermonuclear Experimental Reactor (ITER), which aims to demonstrate that nuclear fusion can provide a viable and sustainable source of energy.

On 12 November 2020, the European Court of Auditors (ECA) published its annual report on JUs issuing a clean (unqualified) opinion on the reliability of the accounts and compliance of the transactions underlying those accounts for all of the JUs, and including observations on various areas for improvement as well as follow-ups on previous years' audit findings. The ECA, as in previous years, drew attention by adding an emphasis of matter to the F4E JU, mainly due to the risk of further cost increases and delays in implementing the ITER project.

On 7 January 2021, the CONT committee held a hearing with JUs, in the presence of the responsible ECA Member, Ms Ildikó Gáll-Pelcz, and the respective Executive Directors of three JUs: Mr Johannes Schwemmer for F4E, Mr Philippe Mengal for BBI, and Mr Pierre Meulien for IMI. In the hearing, held remotely, CONT Members put questions to all the representatives of JUs invited.

This workshop aims to investigate how big data technologies are already being used in the detection and prevention of fraud, corruption, conflict of interest and malpractice, what are their limitations, and how its use could be improved. In addition, on a more theoretical level, it tries to give a glimpse of how data mining and artificial intelligence are able to operate in the budgetary control sphere.

The increasing digitalisation of government services and enhanced transparency rules result in more and more information related to public finances being available on the internet in electronic formats. While fraud is an age-old crime, with the rise of the digital age, criminals are finding new and imaginative ways to deceive public funds and it is often difficult to handle for traditional budgetary control systems. At the same time, the computing capacity and the software availability allows for complex processing of large amount of data in relatively short time. This creates new potential for the detection of fraud and corruption using specialized data analytics techniques such as big data, data mining, and AI technologies on open data. The abundance of open data also represents an opportunity to create reputation systems, which can be used for misuse prevention in a way that was impossible before.



In the first block of the workshop, the presentation by Vitezslav Titl (assistant professor at Utrecht University and affiliated researcher at KU Leuven) will deal with the issues of machine learning: creating algorithm on firms with political connections. Following that, Mihály Fazekas (assistant professor at the Central European University, director & founder of [Government Transparency Institute](#)) will shed light on the questions of detecting corruption in the public sector with the help of big data techniques.

The second part of the workshop will be more practice oriented. Beatriz Sanz Redrado, (Director for Anti-Fraud Knowledge Centre), and Rita di Prospero, (Head of Unit for intelligence and Operational Analysis) from OLAF will present How is OLAF using Big Data technologies to safeguard the EU's financial interests. Petr Suchý (head programmer) will give an example of the use of Big data technologies for transparency by presenting [Hlídač Státu](#), a Czech NGO fighting corruption by connecting public finance data from different public databases, and making it available and searchable. Willem Pieter De Groen (senior researcher and head of unit at CEPS) will present the legal and technical limitations to the use of big data technologies concerning EU funds based on his experiences as a lead researcher for the study on "The Largest 50 Beneficiaries in each EU Member State of CAP and Cohesion Funds".
