1. Appointment of a standing rapporteur on the EU-UK Trade and Cooperation Agreement (TCA)

Decision: Coordinators agreed to send to the Secretariat expressions of interest by 30 March.

2. Public Hearing - The effectiveness and visibility of EDES (Early Detection and Exclusion System) - Rapporteur Cseh (Renew)

Decision: Coordinators approved Ms Cseh's proposal and are invited to send to the Secretariat, by April 9, potential questions to be sent to speakers in advance of the hearing.

3. Opinion to AFCO under rule 56 on European political parties – report 2021 - 2021/2018(INI) - nomination of Rapporteur

Decision: Coordinators decided to draft an Opinion (Rule 56) and give the rapporteurship to S&D (0.5 points). The name of the rapporteur should be communicated to the CONT Secretariat.

4. Contribution for the structured dialogue with the Commission

Decision: Coordinators agreed to send proposals to the Secretariat by 9 April.

5. Public hearings for the second semester 2021

Decision: Coordinators agreed to send their proposals to the Secretariat for a maximum of 2 hearings per group for the second half of 2021 by 9 April 2021.

In his draft report, Joachim Kuhs welcomes the fact that the Court of Auditors finds the EU accounts for 2019 to be reliable and that the Court concluded that revenue was free from material error in 2019, but deeply regrets, however, that for the first time in four years the Court had to issue an adverse opinion on the legality and regularity of the expenditure underlying the accounts. Following the exchange of views with Commissioner Urpilainen responsible for International Partnerships on 1 December 2020, CONT had a discussion on the draft report on 22 February 2021.

In his draft report, the Rapporteur emphasises the following issues: (i) the adverse opinion of the Court of auditors on the legality and regularity of expenditure, which, with an estimated level of error of 3,5 %, surpassed the materiality threshold and which concern mainly recurring errors; (ii) the absence of reservations for 2019 due, inter alia, to a 'de minimis' threshold, taking away a relevant indicator for the EPs scrutiny of the EDFs' operations.

60 amendments were tabled to the draft report concerning, among others, the need for cooperation between the public and private sectors to cooperate in fighting poverty, respect for the rule of law and the need to fight corruption and the emphasis the Commission must put improving its controls on EDF expenditure, both ex-ante and ex-post. Amendments also specifically re-iterated the Court's criticism on the study on the Residual Error Rate by the Commission and called for a continued follow up by the Commission on the Parliament's recommendations regarding the European Union Trust Fund for Africa.

The Committee on Development (DEVE) delivered an opinion on this CONT report on 10 February 2021 for which Mr Udo Bullmann was Rapporteur.

On 12 November 2020 the ECA published its annual report on Joint Undertakings (JUs) issuing a clean (unqualified) opinion on the reliability of the accounts and compliance of the transactions underlying those accounts for all of the JUs. An emphasis of matter is added to the audit opinion of Development of Fusion Energy (F4E), mainly due to the risk of further cost increases and delays in implementing the ITER project.

On 7 January 2021, the CONT committee held a hearing with the representatives of three Joint Undertakings, namely Development of Fusion Energy (F4E), Bio-Based Industries JU(BBI), and Innovative Medicines Initiative 2 (IMI2), in the presence of the responsible ECA Member, Ms Ildikó Gáll-Pelcz. On 22 February 2021, Joachim Brudziński, on behalf of the Rapporteur, presented the draft reports on Joint Undertakings' 2019 discharge to the CONT Committee.

Following the presentation of the main issues highlighted in the draft reports, Mr Brudziński expressed the proposal to grant discharge to all of the JUs. The shadows rapporteurs took the floor and expressed their views, which are also been expressed through the amendments.

There were 135 amendments tabled in total to the eight draft reports, an increase with respect to last year. Amendments addressed mainly issues such as in-kind contributions from private partners, performance and research projects outputs, delays on procedures, gender balance, conflict of interests, transparency and ethics, and objectives for the successors of the JUs operating under Horizon 2020. The majority of the amendments were tabled for the three JUs (F4E, BBI, IMI2) invited to the hearing on January 2021.

The EU Facility for Refugees in Turkey, managing a total of €6 billion in two tranches, provides for a joint coordination mechanism, designed to ensure that the needs of refugees and host communities in Turkey are addressed in a comprehensive and coordinated manner. The Facility focuses on humanitarian assistance, education, migration management, health, municipal infrastructure, and socio-economic support.

The Rapporteur recognises the difficulties encountered in this kind of undertakings, due to different factors such as diversity of the target groups or geographic situation, however, he stresses that the impact of the actions under each strand will achieve more value for money if they are part of an integrated approach. Moreover, the Rapporteur calls on the Commission to implement a strategy for the transition from humanitarian to development assistance and to improve the efficiency of cash-assistance projects.

In the context of the EU Vaccine Strategy, the Commission has concluded eight advanced purchase agreements (APA) of coronavirus vaccines with the relevant pharmaceutical companies. This effort to tackle the pandemic with tangible actions in the area of

EU public health policy recalls the important role of the Committee on Budgetary Control: any effective EU initiative on vaccines requires considerable financial and administrative resources, hence sound financial management and careful scrutiny are key to keep up public trust in the EU's action of support.

Acknowledging parliamentary involvement as an indispensable dimension in this regard, in the recent letter of 17 February, Commissioners Hahn and Kyriakides have provided further details about the financing of the stipulated APAs and anticipated the will to boost research and allocate additional funding for new actions responding the COVID-19 crisis. However, in the meantime, further issues have materialised, concerning the implementation of the APAs, the quantity and quality of the supplies, the compliance with the terms and deadlines of such contracts, the consistency of the approaches adopted by the Member States across the Union. Commissioner for Health and Food Safety has offered further steps towards



transparency and this exchange of view will take advantage of the in depth knowledge and competence on the matter of Mrs Sandra GALLINA, Director-General of the Health and Food Safety (SANTE) Directorate-general, which is also the partner directorate-general of the European Medicines Agency (EMA).

The European Court of Auditors assessed whether EU humanitarian aid for education was effective in helping children and whether it was delivered efficiently by examining 11 projects conducted in Jordan and Uganda between 2017 - 2019.

The EU provides humanitarian aid for children affected by disaster through its Directorate-General for European Civil Protection and Humanitarian Aid Operations (ECHO). In 2019, 10% of the EU's total humanitarian aid was spent on education, amounting to €166 million. An estimated 64 million children in developing countries do not attend primary school. Half of them live in conflict-affected areas. Access to education offers them learning opportunities, and also provides immediate physical protection as well as life-saving knowledge and skills.



The Court concluded that projects were well-coordinated and reached their objectives, but that they did not target enough girls and suffered from inefficiencies due to short-term funding. The auditors therefore call on the Commission to provide more support for girls and to provide long-term funding for education in protracted crises, improved cost analysis and greater sustainability of cash-for-education programmes.

ECA Member João Figueiredo will present to the CONT/ENVI joint meeting the Special Report no 26/2020: Marine environment: EU protection is wide but not deep. The auditors found that EU action so far has not led to a recovery of significant marine ecosystems and habitats, nor to fishing at sustainable levels. The situation is especially problematic in the Mediterranean, where the Common Fishing Policy has not triggered any significant progress and fishing is at more than twice sustainable level. The ECA further found that in the four Member States visited, only limited portions of their funding through the European Maritime and Fisheries Fund were spent on measures directly and less directly related to conservation measures (6% and 8%, respectively).

The ECA recommends the Commission to identify the regulatory and administrative changes necessary to protect sensitive species and habitats, improve protection measures in the Mediterranean, and increase the potential of EU funding.

Ms Joëlle Elvinger will present to a joint meeting of the CONT, BUDG and ENVI the ECA Review 1/2021: The EU's initial contribution to the public health response to COVID-19.

The European Court of Auditors reviewed the role of the EU in its initial response to the COVID-19 pandemic between 3 January and 30 June 2020. It clarified that the competence of the EU concerning serious cross-border health threats gives it a supporting and coordinating role, while the main responsibility in dealing with such crises remains with the Member States. Up to the end of June, approximately EUR 4.5 billion (3% of the EU's annual budget) were allocated to support the Member States' public health related efforts. The Commission and EU agencies further facilitated the supply of medical supplies, promoted testing, treatment and vaccine research, monitored the pandemic, provided risk assessments, and facilitated information exchange between Member States. The ECA concluded that it posed a challenge for the EU to rapidly complement the measures taken within its formal remit, and that these experiences can provide lessons for any future reform of the EU's competences in this field.
