DG SANTE operates under the political leadership of the Commissioner for Health and Food Safety on the basis of multi-annual policies and financial frameworks. The 3rd Health Programme 2014-2020 provides funding for health policy and Regulation (EU) No. 652/2014 provides the financial framework for food safety, animal and plant health. Since April 2020, the Emergency Support Instrument (ESI) has financed measures such as vaccine advance purchase agreements, and procurement of medical equipment and therapeutics to support and complement Member States' Efforts.

DG SANTE pursues its policies with a focus on prudent management and protection of the EU's financial resources. The Director-General is the authorising officer by delegation and has sub-delegated budget implementation responsibilities to Directors and Heads of Unit. DG SANTE's budget in 2020 was dominated by the Emergency Support Instrument to fight the COVID-19 pandemic: commitments of EUR 3 277 million and payment credits of EUR 2 993 million, were almost seven times higher than in previous years. About 93% of the 2020 budget was implemented under direct management, mainly through grants and procurement while 7% was implemented through indirect management, mainly subsidy payments to EU decentralised agencies for their running costs.

In 2020, DG SANTE's average residual error rate amounted to 0,8% leading to an estimated risk at closure of 1,6% and thus, did not exceed the materiality threshold of 2%. Against this background, DG SANTE does not consider it appropriate to make a reservation in the Director-General's declaration of assurance.

The Court of Auditors has not done any relevant audits concerning the Health programme or Food Safety during the last year. Therefore, there will not be a member of the Court of Auditors present at this hearing.

The discharge hearing will be based on information provided in public documents, such as

- the Court of Auditors' 2020 Annual Report, and
- the Annual Report on Performance of the EU budget (to be published by 15 November), as well as
- the Commission's Integrated Financial and Reporting package, and
- the 2020 Annual Activity Report of DG Health and Food Safety

In accordance with the timetable for the discharge procedure, the written questions for this meeting were sent to the Commission on 20 October 2021. The Commission's answers were expected on 3 November 2021, received in the morning of 4 November, and forwarded to CONT Members by the CONT Secretariat.

It is proposed that the hearing with Commissioner Kyriakides proceeds as follows:

- Introduction by Commissioner Kyriakides;
- CONT Rapporteur and shadow rapporteurs will put questions to the Commissioner, followed by answers (the ping-pong system);
- Other Members will question the Commissioner;
- Closing remarks by the CONT Rapporteur.

The European Institutions enjoy administrative autonomy according to Articles 316 and 335 of the TFEU and they are individually responsible for the implementation of their budgets according to Article 59 of the Financial Regulation. Parliament's Budgetary Control Committee takes a decision on discharge to other institutions and bodies on the basis of Rule 100 of Parliament's Rules of procedure.

Following the usual annual procedure, questions related to the 2020 discharge were suggested by CONT Members. The Rapporteur submitted the full set of questions to each concerned Institution. The Q&A catalogue was forwarded to CONT Members on 22 October (and on 26 October for the late replies from CoR and EDPS) and is available on the [CONT website](#).



The questionnaires are focused on the sound financial management at large, as well as on human resources and procurement, the evolution of budget implementation over time, and the efficiency of the implemented controls and evaluation tools. Specific attention is paid to the Covid-19 crisis related measures.

The budget of the Other Institutions is mostly administrative and the Court of Auditors (ECA) indicates administrative expenditure as low risk. According to the findings of the ECA 2020 Annual Report, the expenditure for the financial year 2020 was free from material error. The Secretariat-General of the European Commission is one of the central services of the European Commission, it facilitates its smooth and effective functioning and provides strategic direction.

It is the President's department, at the service of the President, the College and the other Commission departments. It manages the collegial decision-making process and ensures the alignment of EU policies with the political priorities of the Commission. In agreement with the President, the Secretariat-General provides support to the Vice-Presidents in the performance of their role.

As reported in the annual activity report of the Secretary General, 2020 was the first full year of the von der Leyen Commission and of the implementation of the new priorities. It was also marked by the outbreak of the COVID-19 pandemic. The Secretariat-General was at the heart of the Commission's comprehensive response to all aspects of the pandemic, from the immediate crisis response to the longer-term economic recovery plan. This year's report contains a dedicated section on the role of the Secretariat-General in coordinating the COVID-19 pandemic response.



In 2020, the Secretariat-General steered and coordinated, together with the Directorate-General for Budget, the negotiation of the 2021-2027 multiannual financial framework, which was adopted in December 2020, and NextGenerationEU, a temporary instrument designed to boost the economic recovery and support the green and digital transitions. Together, the multiannual financial framework for 2021-2027 and NextGenerationEU form the largest package ever financed through the EU budget, worth around EUR 1.8 trillion.

The Secretariat-General also began to play a central role in the implementation of the centrepiece of NextGenerationEU, the Recovery and Resilience Facility. The newly-created Recovery and Resilience Taskforce supports Member States in the elaboration of their Recovery and Resilience Plans, making sure that these comply with regulatory requirements and that the proposed investments and reforms will provide strong support to a sustainable economic recovery. This role will continue in 2021 with the formal assessment of the draft plans, the preparation of the legal measures for their approval, and the monitoring of implementation.

The discharge hearing will be based on information provided in public documents, such as

- the Court of Auditors' 2020 Annual Report, and
- the new Annual Report on Performance of the EU budget (to be published by 15 November), as well as
- the Commission's Integrated Financial and Reporting package, and
- the 2020 Annual Activity Report of the Secretariat General of the Commission.

In accordance with the timetable for the discharge procedure, the written questions for this meeting were sent to the Commission on 21 October 2021. The Commission's answers were received on 4 November 2021 and forwarded to the CONT Members by the CONT secretariat.

Under Multiannual Financial Framework (MFF) heading 3 - "security and citizenship", a range of policies are covered, whose common objective is to strengthen the concept of European citizenship by creating an area of freedom, justice and security without internal borders.

The most significant area of expenditure concerns the Emergency Support Instrument (ESI). This was set up in April 2020 to help EU Member States address the COVID-19 pandemic by funding, among other things, the cross-border transfer and transport of patients, medical staff and essential medical items; research into and production of vaccines and treatments; and the development, purchase and distribution of testing supplies.

Migration and security also represents a significant share of the budget heading. Spending in this area comes from two funds – the Asylum, Migration and Integration Fund (AMIF) and the Internal Security Fund (ISF). The management of most AMIF and ISF funding is shared between the Member States (or associated countries) and the Commission's DG for Migration and Home Affairs (DG HOME). The objective of AMIF is to contribute to the effective management of migration flows and bring about a common EU approach to asylum and immigration. The overall aim of the ISF is to ensure security in the EU while facilitating legitimate travel and respecting fundamental freedoms and human rights. It operates through two instruments: ISF Borders and Visa and ISF Police.

The transactions subject to audit by the European Court of Auditors in the section concerning migration and security of Chapter 7 "Security and Citizenship" of its Annual Report 2020 represent EUR 6,3 billion excluding decentralised agencies, approximately 3,7% of the EU budget.

The audit scope for this MFF heading does not allow for a quantified conclusion on the level of error.

Ukraine is the second largest beneficiary country of the European Neighbourhood Instrument. Overall, the Commission has committed roughly EUR 5.6 billion to macro-financial assistance (MFA) programmes and EUR 2.2 billion to assistance programmes since 2014. The Commission also guarantees European Investment Bank loans of EUR 4.4 billion. The EU is the largest donor to Ukraine.

Ukraine has been suffering from corruption – particularly grand corruption – for many years. Transparency International defines grand corruption as “the abuse of high-level power that benefits the few at the expense of the many, and causes serious and widespread harm to individuals and society”. In Ukraine, it is based on informal connections between government officials, members of parliament, prosecutors, judges, law enforcement agencies (LEAs), managers of State Owned Enterprises (SOEs) and politically connected individuals/companies

The Court concluded that the EU’s strategy in Ukraine did not specifically focus on the fight against grand corruption, and its impact was difficult to monitor. The EEAS and the Commission regarded corruption as a “crosscutting priority” for which a multi-dimensional approach is needed, rather than as a single “priority sector”. However, they did not develop a focused strategy for targeting grand corruption and the dominance of the oligarchic system.

Grand corruption remains a key problem in Ukraine. Judicial reform is experiencing setbacks, anti-corruption institutions are at risk, trust in such institutions remains low, and the number of convictions resulting from grand corruption is small.

Notably, the Court recommended the EEAS and the Commission to design and implement specific actions that target grand corruption; to assess and adjust the scale of its support for civil society organisations and investigative journalism in order to enhance transparency and foster reform; and to contribute to removing impediments to free and fair competition.
