The reporting Member of the European Court of Auditors, Mr François-Roger Cazala, will present the main conclusions of the Report on the performance of the EU budget - Status at the end of 2020. His intervention will focus on Chapter 1, "Performance framework", while the specific chapters will be discussed in the respective hearings.

For the financial year 2020, the Court of Auditors has, for the second time, split the annual report in two parts. This second part covers the performance of spending programmes under the EU budget. The first part of the annual report was presented to the CONT Committee on 26 October.



According to Article 287 of the TFEU, the ECA draws up an annual report at the end of each financial year. This report, including the statement of assurance (DAS - *Declaration d'Assurance*) concerning the reliability of the accounts and the legality and regularity of the underlying transactions, is considered by the Council and the Parliament in the framework of the discharge procedure under Article 319 of the TFEU.

The presentation of the European Court of Auditors' Annual Report marks the beginning of the discharge cycle related to the year 2020. Upon examination of all relevant documents and a series of hearings with Commissioners in the EU's main spending areas, Parliament will decide in spring 2022 - acting on a recommendation from the Council - whether to grant discharge to the Commission and other EU bodies in respect of the implementation of the EU budget for the year 2020.

The CONT Committee will hold a hearing with Commissioner Gabriel in the context of the discharge procedure for the Commission for financial year 2020.

Research policy is part of Chapter 4 in the European Court of Auditors' Annual Report entitled "Competitiveness for growth and jobs – MFF heading 1a". The Commission's Directorate-General on Research and Innovation, DG RTD, implements EU funds under this policy field, which in 2019 represented 13,9 % of the total EU budget (EUR 24,1 billion in payments).

DG Research and Innovation is responsible for the Horizon 2020 and the Euratom framework programmes. 2020 was the last year of implementation of Horizon 2020 and intensive preparations of its successor Horizon Europe - the largest R&I programme globally, with the agreed budget of EUR 95.5 billion. DG RTD's expenditure is implemented mainly in direct management in the form of grants to public or private beneficiaries participating in projects. DG RTD had a reservation in its Annual Activity Report for 2019, concerning the Seventh Framework Programme, as its residual error rate was above the materiality threshold at 3,52 %, but due to the new "de minimis rule", there are no reservations open in 2020.



In 2020, 64 (i.e. 48%) of the 133 transactions examined contained errors. For this Chapter, the error was estimated by the Court to reach 3.9%. The ECA results indicate that the level of error remains high for research and innovation expenditure, which was the main source of error, especially as regards personnel costs, and much lower for the rest of the sub-heading. According to the ECA, The Commission has taken action to improve the quality of its ex post audits. However, its supervision and review thereof still has weaknesses. It has revised the method for calculating the representative error rate for Horizon 2020, leading to an increase of 0.41 percentage point.

The discharge hearing will be based on information provided in public documents, such as

- the Court of Auditors' 2020 Annual Report, and
- the new Annual Report on Performance of the EU budget, as well as
- the Commission's Integrated Financial and Reporting package, and
- the 2020 Annual Activity Report of DG RTD.

In accordance with the timetable for the discharge procedure, the written questions for this meeting were sent to the Commission on 28 October 2020, answers were received on Wednesday 10 November and forwarded to the CONT Members immediately.

It is proposed that the hearing with Commissioner Gabriel proceeds as follows:

- Introduction by the reporting Member of the ECA, Mihails Kozlovs, who will present the findings of the respective chapters of the Annual Report 2020, and the Report on the performance of the EU budget;
- Commissioner Gabriel will reply to this introduction;
- CONT Rapporteur and shadow rapporteurs will put questions to the Commissioner and the ECA followed by answers (using the ping-pong system);
- Other Members will question the Commissioner and/or the ECA;
- Closing remarks by the Commissioner.

The CONT Committee will hold a hearing with Commissioner Schmit in the context of the discharge procedure for the Commission for financial year 2020.

The area of Jobs and Social Rights is covered under Chapter 5 “Economic, social and territorial cohesion” of the Court’s annual report. In 2020, cohesion represented a 34.3% of the total payments, for an amount of EUR 59.5 billion. Spending under this sub-heading focuses on reducing development disparities between the different Member States and regions of the EU and strengthening all regions’ competitiveness. Specifically, these objectives are implemented through, among others, the European Social Fund (ESF), which aims to encourage a high level of employment and the creation of more and better jobs, including measures through the Youth Employment Initiative (YEI) targeting regions with a high youth unemployment rate.

Responsibility for implementing the multiannual operational programmes is shared between the Commission (including, among others, DG Employment, Social Affairs and Inclusion (DG EMPL)) and the Member States.

Audit authorities had reported quantifiable errors in the assurance/closure packages for 64 of the 213 transactions sampled by the ECA from assurance and closure packages. These errors concerned ineligible costs (43), public procurement (21), accounting and calculation errors (six), state aid (two), and missing supporting documents (one). According to the ECA, the number and impact of the errors detected demonstrate that the controls in place do not yet sufficiently mitigate the high inherent risk of error in this area. This particularly concerns managing authorities whose verifications are ineffective for preventing or detecting irregularities in the expenditure declared by beneficiaries. Other errors are the result of decisions taken by managing authorities themselves.

Regarding the error rates, DG EMPL reported rates of 1.4 % for the KPI and 1.9 % for maximum risk. The ECA indicates that DG EMPL did not take full account of possible errors beyond those detected. If DG EMPL had applied the same approach as DG REGIO, its maximum rate would have been 2.1 %.

The discharge hearing will be based on information provided in public documents, such as

- the Court of Auditors' 2020 Annual Report, and
- the new Annual Report on Performance of the EU budget, as well as
- the Commission's Integrated Financial and Reporting package, and
- the 2020 Annual Activity Report of DG EMPL.

In accordance with the timetable for the discharge procedure, the written questions for this meeting were sent to the Commission on 28 October 2020, answers were received on Wednesday 10 November and forwarded to the CONT Members immediately.

It is proposed that the hearing with Commissioner Schmit proceeds as follows:

- Introduction by the reporting Members of the ECA, Lazaros Lazarou and Pietro Russo, who will present the findings of the respective chapters of the Annual Report 2020, and the Report on the performance of the EU budget;
- Commissioner Schmit will reply to this introduction;
- CONT Rapporteur and shadow rapporteurs will put questions to the Commissioner and the Court followed by answers (using the ping-pong system);
- Other Members will question the Commissioner and/or the ECA;
- Closing remarks by the Commissioner.
