The Members of the European Court of Auditors shall be appointed for a term of six years. In accordance with Article 286(2) TFEU the Council, after consulting the European Parliament, shall adopt the list of Members drawn up in accordance with the proposals made by each Member State.

Appointments to the ECA are submitted to Parliament's plenary on the basis of a report from CONT, which makes its assessment on the basis of the primary law requirement of Article 286(1) TFEU: "*[t]he Members of the Court of Auditors shall be chosen from among persons who belong or have belonged in their respective States to external audit bodies or who are especially qualified for this office. Their independence must be beyond doubt.*".

In Parliament, the procedure is defined in Rule 129 RoP. According to Rule 129 (1), "*[c]andidates nominated as Members of the Court of Auditors shall be invited to make a statement before the committee responsible and to answer questions put by members. The committee shall vote on each nomination separately by secret ballot.*"



In preparation for the hearing, the candidate has been asked to answer the questionnaire prepared by CONT.

The hearing will take place according to the timetable set out in the draft agenda. 30 minutes for renominations and 45 minutes for new candidates.

The hearings will be structured as follows:

- Opening of the hearing by the Chair;
- The candidate will be invited to make an opening statement (4 minutes for renewals and 6 minutes for new candidates);
- The CONT Rapporteur and shadow-rapporteurs will put questions to the candidate using the ping-pong system;
- Other Members will question the candidate (catch-the-eye if time permits);
- Concluding remarks by the Chair.

After all four hearing have been completed, the committee will hold an evaluation of the candidates in camera and then proceed to vote on the appointment of the candidates.

According to Rule 129 (1), the committee shall vote by secret ballot. Members should indicate for each candidate whether they give a favourable opinion, a negative opinion or abstain.

The format of opinions on candidates for membership of the Court of Auditors is defined in Parliament's resolution of 4 February 2014, which implies that amendments cannot be tabled for this report.

The draft report will be finalised, according to the outcome of the evaluation and the vote in committee. The candidate's CV and the answers to CONT questionnaire are annexed to the report.

The report for plenary will state that Parliament delivers either a favourable or a negative opinion on the appointment of the candidate.

Presentation of the special report by ECA Reporting Member Tony Murphy

The European Court of Auditors Special Report focuses on the way the error rate is identified in Cohesion policy, that is both one of the largest parts of the EU budget and a policy area where the risk of irregular expenditure is considered to be high.

The Court examined the work of the Commission on the annual assurance packages of the Member States, which provides the basis for the validation and confirmation of the annual residual error rates reported by the audit authorities. Its analysis encompasses the Commission's reporting in the annual activity reports (AARs) and in the annual management and performance report (AMPR).

- ECA's experience in 4 years of audit on 2014-2020 expenditure indicates univocally that it is not always possible to rely on the Cohesion error rates reported by Member States' audit authorities. Hence, the error rates reported by the Commission's Directorates-General (in their AARs) and by the Commission (as aggregated in the AMPR) are reliable only if the Commission's controls compensate for the limitations of the Member States' audit work;
- The Court's analysis indicates that the deficiencies in the Commission's controls (desk reviews and compliance audit procedures) do not succeed to address the weaknesses of the Member States audits;
- The consequence is that the Directorates-General present the key performance indicators (error rates) as their best estimate of the level of error, but they are indeed not final and represent just a minimum level of error at Directorate-General level and consequently in the annual management and performance report.

The Special Report presents a review of the reservations to the declarations of assurance issued by the competent Commission Directors-General in 2016/2017 and 2017/2018 AARs. It highlights that the error rate detected in the calendar year was always meaningfully increased in the follow up carried out in the following years as a consequence of more Commission's audit work (in 2016/2017 there were 11 OPs included in the AARs reservations to the declarations of assurance, but 49 more, not included in the reservations, were later on identified; in 2017-2018 there were 30 OPs included in the AARs reservations, but 50 more were identified later that were not included in the reservations)

The Courts also points out that relevant safeguard measures are providing a sub-optimal protection to the EU budget (because of the way the net financial corrections are considered by the Commission, or the way the 10% payment retention is designed in the 2014-2020 and in the 2021-2027 regulatory frameworks).

The Commission agrees with some Court's recommendations (on the improvement of the control procedures), maintains that the error rate indicated in the AAR (and in the AMPR) is identified and reported on the basis of all the relevant information available at the time of the signature of the AAR. The Commission highlights that is inherent in the multiannual framework and in the CPR rules the possibility of assessing only at programme closure the regularity of the operations (such as eligibility criteria). Finally, the Commission disagrees on the main recommendation to propose a legislative revision of the rules governing the release of the payment retention (at present possible well before the end of the control cycle).
