In the context of the 2020 Commission discharge exercise, in its 2020 Annual Report on the implementation of the EU budget for the 2020 financial year, the European Court of Auditors highlighted (see page 192, box 7.4) a case where documentation of services provided to unaccompanied minors in an AMIF-funded project in Greece was not satisfactory. According to ECA, the internal rules of the shelters did not include clear indicators for how the NGO was to prove that certain services covered by the standard unit cost (e.g. supervision, organisation of activities, cleaning, meals) had been delivered and were of sufficient quality. The NGO was therefore not able to demonstrate that it had actually provided these services at an appropriate level. Another issue is that young people stayed on in the shelters without proper justification (e.g. schooling, health problems) after reaching adulthood.

This issue was discussed in the CONT Hearing of 9 November with Commissioner Johansson, responsible for Home Affairs, in the presence of ECA reporting member Baudilio Tomé Muguruza. Additional information was requested in written to the Commissioner. This reply, considered confidential by the Commission, was forwarded to CONT Members on 19 November through the platform for secure exchange of documents (N.B. CONT Members are invited to contact the Secretariat if they wish to obtain new copies of this reply).

The answers provided by Commissioner Johansson concerning certain NGO's and their non-compliance with rules were deemed not satisfactory, and the Commission has been invited to provide additional information. Due to the audit nature of this finding, the meeting will take place *in camera*.

The meeting will be opened by the Chair, followed by introductory statements by Mr. Tome Muguruza, Member of the ECA, and Ms. Gminder, Deputy-Director General in DG HOME and head of the Task Force "Migration Management". It will be followed by questions from the 2020 Commission Discharge Rapporteur, Mr Chastel, and Members from the other political groups, which will then be answered by the Commission representatives.

The Rapporteur first welcomes the fact that from the onset of and throughout the Covid-19 pandemic crisis, Parliament has taken often unprecedented decisions aimed at minimising the risk for Members and members of staff, while ensuring that Parliament remains in a position to continue its core activities, while also showing practical solidarity with the host communities.

Secondly, the Rapporteur regrets that ethical and transparency standards applicable to Parliament are often not enforced in a satisfactory manner and considers that Parliament should strive to lead by example with regards to setting Europe-wide ethics and transparency standards.

Furthermore, concerning Parliament's building policy, Mr Freund notably expects more transparent and detailed planning and decision making, including the provision of early information, having due regard to Article 266 of the Financial Regulation.

Finally, the Rapporteur considers that a review of the financial model of the Voluntary Pension Fund would not be sufficient to prevent additional taxpayers money from being used for future payments, and he urges the Secretary-General therefore to also propose measures on adjusting the modalities of the fund, including a further increase of the retirement age and a reduction of pension benefits paid out.

The Secretaries-General of the Other Institutions had received the questions put by CONT Members on 8 October 2021 and the written replies were sent to Members on 22 November 2021.

Discharge hearings were held on 8 November with the Secretaries General and Director-Generals of the Other Institutions. Council did not send replies and was not present at the hearing. On 30 November the discharge hearing was held with the HRVP of the EEAS.

At this meeting, the CONT Members will have an exchange of views on the 2020 budget discharge for Other Institutions based on the draft reports.

The Rapporteur prepared the draft discharge reports based on documents such as the annual activity reports of the different Other Institutions, the related balance sheets and the internal audit reports, on the exchanges of views in the CONT Committee and on the replies given by the institutions concerned. Also the Court of Auditors (ECA) annual report of 2020 has been considered, having specific regard to Chapter 9 "Administration", focused on expenditure on human resources, buildings, equipment, energy, communication and information technology that the Court indicates as being, overall, a low-risk expenditure. However, the analysis of the Court of Auditor (also for 2020 as for the previous years) has not targeted the administrative expenditure of each individual Other Institution, but only the error level of the administrative expenditure at the aggregated EU budget.

The draft reports focus mostly on the issues identified in the financial year 2020 and on the impact of the Covid-19 pandemic on the actions carried out by each of the Other Institution and the EEAS. A particular attention has been devoted to the way the Institutions have succeeded to react to the crisis, having regard to the issues of the business continuity and with a specific focus on staff well-being, staff productivity and work-life balance. The impact of Covid-19 on the budget execution rate is a recurring point, and the overall ratio of the appropriations on the commitments indicates a sensible decrease; the reports focus on the timeliness and effectiveness of the strategies to counter the limitations imposed by the several restrictions on the normal business activities, which includes all the actions and initiatives undertaken by the organisations to review and adapt their internal functioning and work methods in order to continue to fulfil their mission, assessed from the angle of the soundness of financial management, reporting, internal control systems, communication etc.

It is proposed that the consideration of the draft reports proceeds as follows:

- Presentation of the draft reports by the CONT Rapporteur;
- The Shadow Rapporteurs will present their views on the draft reports, followed by, if time allows, a catch-the eye session;

The specific ECA annual report on the EU Joint Undertakings for the financial year 2020 was published on 12 November 2021. The ECA issued unqualified ("clean") opinions on the annual accounts and the underlying transactions for all nine Joint Undertakings. As regards the Fusion for Energy Joint Undertaking (F4E JU), the ECA drew attention with an emphasis of matter to the fact that any changes in key assumptions concerning the estimate of the total cost for completing its delivery obligations for the ITER project and the risk exposure could lead to significant cost increases and/or further delays in the implementation of the ITER project.

On 29 November 2021, the CONT Committee held a hearing in the frame of the annual discharge procedure with the respective Executive Directors of three Joint Undertakings invited, namely the F4E JU, the European High Performance Computing Joint Undertaking (EuroHPC JU) and the Clean Sky2 JU, in the presence of reporting ECA Member, Ms Ildikó Gáll-Pelcz.

The Rapporteurs will present their draft reports on the Joint Undertakings, which observe, among others, issues and facts on budgetary and financial management, including the levels of in-kind and in cash contributions, performance, internal control systems, the adoption and implementation of an anti-fraud strategy, the prevention of conflict of interests, transparency, staff matters, and procurement during the year 2020. They also refer, to some extent, to the impact of the COVID-19 pandemic on the Joint Undertakings' operations.

The shadow rapporteurs and other members will have the opportunity to discuss on the draft reports and on the issues highlighted in them in preparation of the amendments phase and the decision on discharge.
