The protection of the EU's financial interests is a key element of the EU policy agenda to strengthen and increase the confidence of the public and ensure that taxpayer money is used properly. Unfortunately, on a regular basis, different media outlets all over Europe provide their readers with scandals covering fraud, conflict of interest, corruption and other illegal activities detrimental to the EU's financial interests and the citizens' trust in the institutions. Financial and economic crimes, in particular corruption, are a major threat in the private and public sphere and have a disproportionate impact on the poor and most vulnerable, increasing costs and reducing access to services.

In this (draft) report, the Rapporteur stresses the main challenges in cohesion and agriculture policies. Besides underlining the most frequently detected types of fraudulent irregularities, the draft report points out that, as far as the CAP is concerned, evidence shows that there is a clear inequality between fund allocations for big and small farmers, with systemic advantages for the big farms, whose beneficiaries have close ties to the ruling political parties or are themselves members of these.

For the 2021-2027 period, the Union has at its disposal the MFF package, which together with the NextGenerationEU recovery instrument amounts to EUR 1.8 trillion in total of funding over the coming years to support recovery from the COVID-19 pandemic and the EU's long-term priorities across different policy areas. More than ever, it is pivotal to protect taxpayers' money and make sure that every euro from the budget is spent in line with the general principles enshrined in the Treaties and in the Financial Regulation and generates added value.

The present draft report stresses that even though the new MFF uses certain tools such as increased amounts budgeted for special instruments and a budgetary mechanism to uphold the rule of law, there is still space for additional tools to strengthen anti-oligarch practices that could be addressed in the framework of the upcoming revision of the Financial Regulation.

In particular, the Rapporteur stresses the need for the Parliament, Commission, Member States and the other EU institutions (OLAF, EPPO, CoA, etc.) to work closely together to remedy the alarming misuse of EU funds by politically prominent wealthy individuals, elites and big conglomerates.

Based on 140 amendments, a consensus was reached for 25 compromises.

In his draft report, Olivier Chastel regrets that the Court for the year 2020 has again issued an adverse opinion on the legality and regularity of the expenditure side of the budget and at the same time acknowledges that the level of error has remained stable at 2,7 % in 2020, which is the same as for the year 2019. The rapporteur expresses his concerns that the amount of outstanding commitments (RAL) at the end of 2020 reached a new record high of EUR 303,2 billion. He also regrets that the cumulative absorption rate from the European Structural and Investment Funds at the end of 2020 continues to be approximately 7 % lower than under the previous 2007-2013 MFF.

The rapporteur reiterates its deep concerns regarding the situation concerning the rule of law in a number of Member States, which is deeply worrying in its own right and may ultimately lead to serious losses for the Union budget and underlines its requests to the Commission to use all available tools to limit the risk of such losses. He also underlines its strong and repeated requests to the Commission and executive agencies to ensure the protection of the Union budget by making global and systematic use of digital and automatised systems for reporting, monitoring and audit.

Mr Chastel further reiterates the need to simplify rules and procedures, develop compulsory training sessions and practical information for applicants, in particular new applicants, and improve the assistance and guidelines for SMEs, spin-offs, start-ups, administration and payment agencies and all others relevant stakeholders.

The rapporteur also calls on the Commission to continue promoting gender balance and a gender budgeting approach in the allocated funds, and calls on the Commission to urgently develop a gender mainstreaming methodology in order to integrate a gender equality perspective in all policy areas.

The 33 draft reports concerning the 2020 decentralised agencies' discharge will be presented by the Rapporteurs Tomáš Zdechovský and Lefteris Christoforou to the CONT Committee on February 10th 2022.

Out of the 32 decentralised agencies subject to the discharge procedure, the European Court of Auditors issued a clean opinion on the reliability of the accounts for all agencies meaning that the final accounts present fairly, in all material respects, their financial position at year-end.

The European Court of Auditors issued a clean opinion on the reliability of the accounts and the legality and regularity of the revenue underlying the accounts for all agencies. The Court also gave clean opinions on all but three agencies' legality and regularity of payments underlying the accounts. For the European Union Agency for the Cooperation of Energy Regulators (ACER), the European Union Agency for the Operational Management of Large-Scale IT Systems (eu-LISA) and the European Union Agency for Cybersecurity (ENISA). the Court issued qualified opinions on the legality and regularity of the payments underlying the accounts, mainly caused by procurement related errors and irregular delegation of tasks related to payments.

The Rapporteurs tabled draft reports focused on the following topics:

- budget and financial management;
- performance;
- staff policy;

- procurement;
- prevention and management of conflicts of interest and transparency;
- internal control;
- COVID-19 response and business continuity.

Agencies continued delivering on their mandates despite the COVID-19 pandemic. All of them implemented measures to ensure the continuation of key governance processes and the well-being of their staff. While transitioning to a hybrid and teleworking environment, none of the agencies reported serious problems with respect to capacity, connectivity or data security. Day-to-day operations continued without serious disruptions and budget implementation rates remained similar to those of the previous years.

The European Union dedicates around 10% of its budget to external action, providing funding in the form of grants, contracts, and budget support to the EU's partner countries. To increase the impact of the support, the Union also work hand-in-hand with international organisations, private bodies and EU member countries.

Launched in 1959, the EDFs were the main instruments by which the European Union (EU) provided development cooperation aid to the African, Caribbean and Pacific (ACP) countries and overseas countries and territories (OCTs) until the end of 2020. Its primary objective was to reduce and ultimately eradicate poverty. The 8th to 11th EDF programmes are not funded by the EU budget, but were established by an Internal Agreement of the Representatives of the Member States. The 11th EDF has reached its final stage as its sunset clause came into effect on 31 December 2020 and, as from 2021, the EDF programmes will be included in the Union's multiannual financial framework (MFF), however, specific contracts for existing financing agreements will still be signed until 31 December 2023.

The Court of Auditors, in its annual report on the activities funded by the eighth, ninth, tenth and eleventh EDFs for the financial year 2020, concludes that the accounts for the financial year ending 31 December 2020 present fairly, in all material respects, the EDFs' financial position, the results of their operations, their cash flows and the changes in their net assets for the year then ended, in accordance with the provisions of the Council Regulation (EU) 2018/1877 ('EDF Financial Regulation') and the accounting standards for the public sector.

As of the 2021-2027 MFF period, the EDFs, the Development Cooperation Instrument (DCI) and other instruments with the NDICI (Neighbourhood, Development and International Cooperation Instrument) have been incorporated into the Union general budget under heading 4 'Global Europe', which accounts for 6,6 % or EUR 11,4 billion of the Union budget. Such a new set-up entails new institutional responsibilities and tasks, in particular for Parliament as one arm of the budget authority for the annual budget. The Rapporteur expects budgetary transparency, policy coherence and democratic accountability to benefit from those new arrangements.

EU action has had limited impact in advancing fundamental rule of law reforms in the Western Balkans, according to this special report published by the Court. Most of reforms carried out across the region were of a technical and operational nature.

Regrettably, in a context of insufficient political will and a lack of engagement, EU support has been largely insufficient to tackle persistent problems in areas such as the independence of the judiciary, the concentration of power, political interference, and corruption, the Court says. This audit report finds that the EU support lacks impact on justice and human rights and fails to effectively address major flaws related to the judicial independence, state capture and corruption. The report recommends to the Commission and the EEAS to strengthen conditionality, monitoring and support to independent civil society and media in the region.
