The Secretariat had prepared an overview of all the systems used for allocation of files in CONT (Annex II.) Annexed to the note was also an overview of rapporteurs/followers for all types of files during this legislature.

**Decision:**

Coordinators held a discussion on the basis of the material provided on the different systems for allocation of files in CONT.

Coordinators decided not to change the existing system, which was decided for five years in 2019. The current system is based on the d'Hondt system, which is commonly used throughout Parliament.

They agreed that the point system for distribution of files does not have to be applied automatically and that Coordinators can and should discuss on the allocation of the files before deciding on their distribution.

#### ***4. Discharge to other institutions 2020 - Further information from ECA and EESC in form of "drafting suggestions"***

When reports are drafted in EP committees, it is normal that interested parties follow the work. This may result in written input from interested parties. This is a normal part of a democratic process in any parliament. Minor factual issues might only be shared with the secretariat of a committee, while more substantial and/or political suggestions tend to be sent to the rapporteur and or shadow rapporteurs and/or other /all committee Members. For the sake of transparency and in order to ensure an equal level playing field, drafting suggestions from other EU institutions should be shared with all CONT Members, especially when they are made in relation to their own discharge. In the case of the draft discharge report 2020 to the Court of Auditors and to the EESC, the secretariat received substantial contributions. In agreement with the Chair and in order to ensure equal treatment of all CONT Members, the secretariat shared - as usual - the ECA's and the EESC's contribution on their own discharge report with all Members.

##### **Decision:**

#### 4. DISCHARGE 2020: PRESENTATION OF THE COUNCIL RECOMMENDATIONS BY THE FRENCH PRESIDENCY

Presented by **Minister Councillor Claire Cheremetinski**, French Permanent Representation to the EU

On 23 February 2022, Coreper II adopted the recommendation that the European Parliament grant discharge to the Commission for the implementation of the EU's 2020 budget. The recommendation is expected to be finally adopted by the ECOFIN Council on 15 March.

The recommendation has been prepared on the basis of the Court of Auditors' annual report concerning the financial year 2020, including its report on the performance of the EU budget - Status at the end of 2020. In its annual report, the ECA concluded that the revenue for the financial year 2020 is legal, regular, and free from material error. At the same time, the ECA, as last year, issued an adverse opinion on the legality and regularity of expenditure after finding that high-risk expenditure (mainly spending on a reimbursement basis, which is subject to complex rules) is affected by material error and represents over half of the audit population. The ECA therefore, considered that the error in expenditure is pervasive. In the light of the ECA's report on the performance of the EU budget, a separate section of the Council recommendation also covers this issue.



The Council will also adopt recommendations on the discharge to be granted to the Commission for the implementation of the EDF, to the Directors of the EU's decentralised agencies, executive agencies and the joint undertakings for the implementation of their 2020 budgets. These recommendations follow the ECAs 2020 annual reports on EU Agencies and Joint Undertakings.

The recommendations require a qualified majority for adoption by Council.

The presentation by the Council Presidency on the main features of the recommendation will be followed by an exchange of views with the Members of the Committee and the representative from the Presidency.

On 25 January 2022, the Rapporteur presented the draft reports for the Other Institutions and the External Action Service. The presentation was followed by an exchange of views between the Members.

In total 404 amendments were tabled to the eight draft reports. The tabled amendments cover all the areas of interest tackled in the draft reports: human resources (gender and geographical balance), performance and budget execution, internal controls, inter-institutional cooperation and communication, transparency, environmental aspects and the issues related to the pandemic outbreak: the impact of the Covid-19 on the activities carried out by each of the Other Institutions and by the EEAS, and the measures that were adopted to deal with them. A specific attention has been devoted to ethics, integrity and prevention of conflict of interests and to the working procedures and internal rules aiming at strengthening them.

In addition to the amendments tabled to the draft reports, the AFCO, JURI, LIBE and AFET Committees have provided opinions respectively to the discharge of Council (Rapporteur, Antonio Tajani), Court of Justice (Rapporteur, Gilles Lebreton), Data Protection Supervisor (Rapporteur, Ramona Strugariu) and European External Action Service (Rapporteur, Michael Gahler).

Following Shadows Meeting and written consultations, a total of 54 compromise amendments resulted from the continuous exchanges and cooperation between the Rapporteur and the Shadows, and will be put to the vote.

The final voting lists will be circulated on 24 February 2022.

On 12 November 2021, the ECA issued unqualified (“clean”) opinions on the reliability of the accounts and the legality and regularity of the underlying transactions for the financial year 2020 for all nine Joint Undertakings, as well as observed various matters needing improvement. As regards F4E JU, it drew attention, with an emphasis of matter, to the fact that any changes in key assumptions concerning the estimate and the risk exposure could lead to significant cost increases and/or further delays in the implementation of the ITER project.

The CONT Committee held an exchange of views, in the framework of the discharge procedure, with representatives of the Joint Undertakings on 29 November 2021, in the presence of the reporting ECA Member, Ms Ildikó Gáll-Pelcz.

The Rapporteurs presented and discussed their draft reports in CONT Committee on 25 January 2022. The CONT Members tabled a total of 120 amendments to the draft reports. The Committee on Transport and Tourism issued three opinions concerning Clean Sky, Shift2Rail and SESAR. The Rapporteurs and Shadow Rapporteurs have worked on five Compromise Amendments which will also be put to the vote.
