5. Revision of the Financial Regulation following Court judgments on fines

As announced under AOB at the last Coordinators meeting, the BUDG and CONT Chairs met Director-General Koopman at his request on 9 March 2022. Mr Koopman explained the impact on the EU budget of recent Court judgments on competition fines ([Printeos](#); Deutsche Telekom: [FR judgment](#) / [press release](#)).

In cases where the Court (partly) annuls a Commission decision imposing a fine, the Court has ruled that the Commission is required to repay the portion of the fine that had been unduly paid, together with default interest, calculated by analogy as the rate applied by the European Central Bank to its principal refinancing operations, that being 0.05%, increased by three and a half percentage points.

This compound interest can result in very high amounts, such as in the recent Intel case ([judgment](#) / [press release](#)) where an amount of EUR 1.06 billion was deposited for the 11 years' duration of the Court case, and would result in late interest payments for over EUR 500 million if the same logic is applied.

Currently, these late interest payments must be paid from the expenditure side of the EU budget, specifically from Heading 7 - European public administration. This would put enormous pressure on the Heading and on the EU budget in general, requiring, for example, the use of special instruments or reductions of expenditure.

The Commission is therefore planning to propose to amend [Article 48 of the Financial Regulation](#), to allow late interest payments for competition fines to count as negative revenue, thus relieving the pressure on expenditure.

Mr Koopman sought the advice of the BUDG and CONT Chair on this issue, and in particular on whether the proposal for the revision of Article 48 should be part of the overall proposal for revision of the Financial Regulation planned for this spring, or should rather be a separate proposal. The Commission has sent a non-paper about the situation which can be found in *Annex II*.

Keeping the proposals separate would allow - if the European Parliament and Council agree - to deal quickly with the Article 48 proposal, in view of the need to bear late interest payments already next year, while allowing sufficient time for the co-legislators to finalise the "standard" revision of the Financial Regulation, for which Parliament has expressed its priorities in an extensive [resolution](#) from November 2021 prepared by BUDG and CONT.

Decision:

Coordinators decided to accept having two separate Commission proposals for a revision of the Financial Regulation.

6. Approval of programme for a public hearing on 21 April

At their meeting of 27 September 2021, the CONT Coordinators approved the proposal for a public hearing (PH) on the “*Technical Support provided to EU Members States*”. The aim of the hearing is to get a better understanding of the challenges with technical support, how the Commission is supporting Member States in the area of better administration, digitalisation and implementation of the funds and how technical support could be used to prevent problems, such as those discussed in the CONT meeting on the Danube delta or the use of funds in Bulgaria.

The hearing is being organised for the CONT meeting on 21 April.

In *Annex III* Coordinators will find the draft programme, which has been developed by the Secretariat also on basis of the contributions received from political groups.

Decision:

Coordinators approved the draft programme for the public hearing on 21 April.

7. Call for proposals for expertise

In *Annex IV* Coordinators will find an update concerning expertise requests, which were approved by Coordinators last year.

Since the existing programme for expertise has almost been exhausted, the Secretariat is proposing to revert to the issue of new proposals for expertise at the Coordinators meeting on 20-21 April. Political Groups are invited to present proposals for expertise at the latest on 8 April.

Annex V contains an Info Sheet on expertise for parliamentary committees provided by the Policy Departments.

8. LIBE request for an INI report on "Compliance with European values in the use of EU funds"

At the last Coordinators meeting Renew asked for Coordinators to discuss the LIBE request for an INI report on "*Compliance with European values in the use of EU funds*". The file has developed in the following way:

By letter of 8 December 2021, the LIBE committee asked for authorisation of an INI report on "*Compliance with European Values in the use of EU funds*".

By a co-signed letter of 10 December 2021, CONT and BUDG committees contested this request.

By letter of 13 January 2022, LIBE committee reiterated its request and offered to BUDG and CONT cooperation under Rule 57 RoP.

By joint reply of 20 January 2022, CONT and BUDG committees maintained their position that the topic proposed is falling squarely in CONT and BUDG competence.

By letter of 14 March 2022, LIBE insisted on the INI request and offered to cooperate with CONT and BUDG on the basis of Rule 58 RoP.

At the Coordinators meeting on 15 March, the Chair reminded of the earlier discussions on this topic and underlined that LIBE has no competence in relation to EU-funds. All letters to be found in *Annex VI*.

A further joint letter from CONT and BUDG Chairs will be sent to LIBE. In this letter the new CCC Chair will be invited to show the fresh energy of solving conflicts of competence between committees, by inviting committees to respect the distribution of competences under Annex VI.

At the meeting the Chair informed that a further letter from CONT and BUDG Chairs had been sent on 31 March 2022.

- The Chair informed that the BUDG Committee might ask CONT to allow one Member from BUDG to participate in the CONT mission to Poland requested for week 29. Coordinators indicated their approval should such a request be made.
- Renew requested to discuss if the usual CONT practice to allow Commission officials to accompany CONT missions should be maintained.

Coordinators decided to continue with the tradition when CONT is conducting general fact finding missions. Commission representatives can provide useful information and can also be asked to comment on information given by Members States' authorities relating to shared management. The Commission might also benefit of insight gained in a CONT mission in order to decide on possible further audit needs. However, there can be situations where Commission representatives will not be invited, e.g. in order to exclude interference during ongoing audit procedures (like in the case of the mission to the Czech Republic).

- The Chair informed about the EPP fact finding mission to Bulgaria, including the situation concerning the arrest of several former high ranking ministers/officials including former Prime Minister Borissov and the alleged link between EPPO investigations and the arrests. The detention of opposition leaders without any involvement of a prosecutor or a judge raises questions with regard to rule of law standards. However, there are suspected cases of fraud that are currently being examined by the EPPO and by national authorities. The Chair has organised a meeting on 6 April in order to inform participants of the CONT mission to Bulgaria in more detail about the results from the EPP mission.

In his draft report, Olivier Chastel regrets that the Court, for the year 2020, has again issued an adverse opinion on the legality and regularity of the expenditure side of the budget and at the same time acknowledges that the level of error has remained stable at 2,7 % in 2020, which is the same as for the year 2019. The rapporteur reiterates its deep concerns regarding the situation concerning the rule of law in a number of Member States, which is deeply worrying in its own right and may ultimately lead to serious losses for the budget of the Union, and underlines its requests to the Commission to use all available tools to limit the risk of such losses. He also underlines its strong and repeated requests to the Commission and executive agencies to ensure the protection of the Union budget by making global and systematic use of digital and automatised systems for reporting, monitoring and audit.

278 amendments were tabled to the draft report concerning, among others, the general regime of conditionality for the protection of the Union budget, rule of law, projects with European added value, interoperability of IT systems, and the protection of the Union budget against irregularities, fraud and conflict of interest. The rapporteur and shadow rapporteurs have worked on 27 compromise amendments bringing together a large number of amendments.

The Committees on Foreign Affairs (AFET), Agriculture and Rural Development (AGRI), Culture and Education (CULT), Development (DEVE), Employment and Social Affairs (EMPL), Environment, Public Health and Food Safety (ENVI), Women's Rights and Gender Equality (FEMM), Civil Liberties, Justice and Home Affairs (LIBE), Regional Development (REGI) and Transport and Tourism (TRAN) delivered opinions to this CONT report.

The final reports will be voted in the Parliament's Plenary session of May.

Launched in 1959, the EDFs were the main instruments by which the European Union (EU) provided development cooperation aid to the African, Caribbean and Pacific (ACP) countries and overseas countries and territories (OCTs) until the end of 2020. Its primary objective was to reduce and ultimately eradicate poverty.

As of the 2021-2027 MFF period, the EDFs, the Development Cooperation Instrument (DCI) and other instruments with the NDICI (Neighbourhood, Development and International Cooperation Instrument) have been incorporated into the Union general budget under heading 4 'Global Europe', which accounts for 6,6 % or EUR 11,4 billion of the Union budget. Such a new set-up entails new institutional responsibilities and tasks, in particular for Parliament as one arm of the budget authority for the annual budget.

Members tabled 103 amendments to the draft report, based on which the rapporteur and shadow rapporteurs agreed on 18 compromise amendments bringing together a large number of amendments, including as well a number of suggestions from the opinion delivered by the Committee on Development.

Members expect budgetary transparency, policy coherence and democratic accountability to benefit from those new financial arrangements. Moreover, they call on the Commission to redouble its efforts to carry on sample-based on-the-spot controls years after the completion of the co-financed projects to check the continued impact and the performance of the EDF interventions and to take the necessary steps to ensure the long-term impacts of the operations.

The final report is scheduled to be voted in the May Plenary session.

For the 2020 discharge of the EU Agencies, the Rapporteurs have tabled 33 draft reports. A total of 425 amendments to these reports were tabled, with on average around 15 amendments per report. However, 101 amendments were tabled to the draft report of the European Border and Coastguard Agency (Frontex), showing a strong interest across all groups.

Most amendments were related to gender balance, encouraging the agencies to pursue a better representation of women, in particular among senior management, digitalisation, staff policies concerning telework and work-life balance for staff and findings from the Court of Auditors in its Annual reports for the agencies.

In the amendments to the Frontex discharge report, the focus was mainly put on the conditions agreed in the 2019 discharge for the Agency, on a report from the European Anti-Fraud Office concerning the Agency, and on follow-up given by the Agency to the ECA Special Report SR 08/2021 on Frontex's support to external border management and the report of the Frontex Scrutiny Working Group of the Parliament's Committee on Civil Liberties, Justice and Home Affairs (LIBE).

The Rapporteurs and Shadow Rapporteurs have worked on around 35 compromise amendments that will be put to the vote, aimed at reaching political consensus on topics, and a clear, structured text in the final reports. The final reports will be voted in the Parliament's Plenary session of May.

On 14 October 2021, the OLAF Director-General, Mr Itälä, presented in the CONT Committee the Commission's 32nd annual report on the Protection of EU's financial interests (PIF report) 2020.

As every year, the CONT Committee has requested to draw up an own-initiative report based on, among other sources, the PIF report 2020. The Rapporteur, Ms Cseh, will present her draft report in Committee and hear from the Shadow rapporteurs, other Members, and OLAF representatives present.

In her draft report, Ms Cseh highlights, among other things, the different level of transposition of the PIF Directive, the overall detection of irregularities, the adoption at vary degrees of a National Anti-Fraud Strategy, and the role of the Anti-fraud Coordination services.

The draft report observes, moreover, the role of EPPO and OLAF and the overall EU antifraud architecture, the Commission Anti-fraud strategy, the Commission's annual reporting, as well as discusses over digitalisation, and the rule of law and the fight against corruption.

The draft report draws attention also to the risks related to the COVID-19 pandemic and the unprecedented level of attention and control needed in relation to the NextGenerationEU recovery plan.

In 2020, the COVID-19 pandemic did not affect negatively the EIB Group and its ability to remain fully operational, while continuing to conduct its activities in the normal course of business. However, the EIB actions have been redirected to enhance its contribution in countering the consequences of the crisis: their relevance and impact are reviewed in the Report that is presented today, together with the relevant EIB's funding activities in support of the key policy areas of cohesion and climate financing and towards Countries outside the EU.

The draft report considers the role of the EIB's financing actions, acknowledging that the economic consequences of the COVID-19 pandemic have deepened the structural differences across Member States, making the EIB's statutory mission to support cohesion all the more necessary. In the meantime, the Bank has confirmed its position of largest multilateral financier of climate actions (by exceeding in the climate financing the initial target) and the EIB has further progressed in its updating of the environmental and social sustainability framework.

The draft report highlights the importance of ethics and integrity, refers to the new provisions on cooling-off periods and to the work of the Ethics and Compliance Committee. In this area, the Rapporteur has looked into the accountability and transparency of the EIB corporate governance and activities. The draft report builds on the analysis of the compliance function within the Bank and of its complaint mechanism, appreciating the revision of the EIB Group Anti-Money laundering and Combating Financing of Terrorism Framework and the revision of the EIB Group anti-fraud policy, welcoming the cooperation with the Luxembourg Financial Intelligence Unit, OLAF and EPPO and the enhanced provisions for the protection of whistle-blowers.

The Rapporteur also points at still sub-optimal solutions to issues already targeted in previous resolutions, such as the need for a stronger external scrutiny of EIB by the ECA in the light of a revised Tripartite Agreement between Commission, the EIB and the ECA that still does not include the EIB operations financed by EIB's share capital; also the still not fully satisfactory transparency policy on disclosure of projects' data and on the clients' beneficial ownership is indicated amongst the issues where there is room for improvement.

Additionally, the draft report requests addressing the persistent lack of tangible social dialogue within the EIB and the gender unbalance and lack of diversity within EIB Group's governing bodies. Also, additional requests are addressed to the Bank for a comprehensive analysis of the nature of the financial support affected by detected misbehaviour and about the geographical distribution of such cases, to facilitate the identification of systemic weaknesses.

44. FOLLOW-UP ON INVESTIGATIONS OF POSSIBLE MISUSE OF EU FUNDS FOR AGRICULTURE IN SLOVAKIA

On 25 October 2021, CONT Committee held an exchange of views with representatives of the European Commission, OLAF and the Slovak Minister of Agriculture.

The exchange of views was organised as a follow up of alleged cases of irregularities in direct payments and systemic weaknesses in national verification procedures, claims that overlapped on given land plots, and claims for payment on ineligible land, as well as how certain areas that had been claimed for years by some companies were in fact not covered by legally valid lease contracts.

In addition to the specific payment-related findings, investigations uncovered several weaknesses in the control and management system for direct payments in Slovakia. It was found that controls are very limited on whether the disposal of land by an applicant is lawful. Analysis also revealed that the internal verification procedures adopted by the Slovak national authority in charge of the management of agricultural land under State ownership or land without a known private owner should be improved as regards its transparency and legal certainty.

In relation with these cases, both the Directorate-General for Agriculture (DG AGRI) and the Slovak Administration launched their own audits. The Slovak government discovered that previous fraud cases included enormous fees for consultants, intentional reassessments of individual projects, and false assessments of the financial health of the companies benefitting from the payments. The fraudulent activities are alleged to have started back in 2006.

On June 2021, Samuel Vlčan was appointed Minister of Agriculture, nominating Jozef Kiss as the new director of the Paying Agency.

In October 2021, DG AGRI provisionally suspended the accreditation of the Slovak Paying Agency, as a result of corruption cases for which several of its former officials are being prosecuted. The Slovak Agency was recommended to implement 72 remedial measures in order to continue delivering payments to farmers. On 15 October, Minister Vlčan announced that the Paying Agency had regained its accreditation and could restart its activities.

Now, four months after the reinstatement of the accreditation of the Paying Agency, this new exchange of views with the Slovak Minister for Agriculture and the Director General of the Slovak Agricultural Paying Agency, as well as representatives of DG AGRI, aims to clarify the scope and outcome of the reforms carried out.
