### 2. Conflict of interest for Members of the OLAF Supervisory Committee

On 1 August 2022, the CONT Secretariat was informed by the OLAF Supervisory Committee (SC) Secretariat that the Legal Service of the Commission had confirmed the risk of a conflict of interest (CoI) situation affecting one of the newly appointed Members of the Supervisory Committee. The Commission Legal Service had suggested to handle the CoI with a number of measures that were hardly enforceable by the Secretariat of the OLAF Supervisory Committee, hence the latter was exploring the application of Article 15(5) Reg. 883/2013 providing for an intervention by the three Institutions to relieve the SC member who had ceased to fulfil the conditions governing the performance of his duties. The member has however been selected in full compliance with all criteria of the call for interest. Before the matter could be discussed, the member resigned on 12 August 2022. Mr. Thierry CRETIN was automatically appointed, in substitution, as first in order of preference in the reserve list.

#### **Decision:**

Coordinators discussed the situation leading to the resignation of a recently appointed member of the OLAF Supervisory Committee and agreed that it was unfortunate that CONT had not been involved in the process. It was highlighted that the member had fulfilled all requirements to be validly appointed and that his professional activities did not conflict with his appointment. Coordinators tasked the Chair to convey to the OLAF Supervisory Committee their discontent that the way of proceeding seems to indicate that nobody active in private practice would be considered eligible to the OLAF Supervisory Committee.

### 3. Vote on PIF and EIB reports on Monday 5 December

According to the CCC guidelines, Committee votes should not be scheduled on Mondays and Fridays, except in case of urgency subject to a decision by the respective committee Chair.

Because there is very limited Committee meeting slots during fall and in order to ensure a smooth and timely handling of the PIF and EIB INI reports, the Secretariat would like to propose to hold the votes on the draft INI reports relating to PIF and the EIB on Monday 5 December in the afternoon.

**Decision:**

Coordinators decided that the votes on the EIB and the PIF INI reports can be held on Monday 5 December 2022 in the afternoon.

**4. Prolongation of delegation to the Chair to decide on remote Coordinator's meetings**

Coordinators approved that the delegation to the Chair to decide to hold Coordinators meetings in a hybrid format is prolonged until the end of April 2023.

- Mission to Spain to be advanced:** The Chair proposed to move the mission to Spain forward from 3-5 April to 9-11 January 2023 in order to ensure that the results of the mission can be as useful as possible in the Commission discharge and at the same time ensure that the mission takes place well in advance of the upcoming elections in Spain and not during the "Semana Santa" where interlocutors will be difficult to find. Coordinators agreed to the proposal.
- Procedure for the closure of accounts of FRONTEX:** The Chair explained why there needs to be a vote on the closure of accounts for Frontex. This is required by Annex V, Article 5, paragraph 2, lit b) of the Rules of procedure. This vote will take place on 8 November. Coordinators agreed to submit the closure of the accounts directly to the vote.
- Explanation for the postponement of the ARACHNE hearing:** The Chair explained that the ARACHNE hearing had to be postponed from 24 October to 5 December because that Commission had sent out a questionnaire that overlapped with the questionnaire from CONT and Member States were initially informed that it would be sufficient to reply only to the Commission's questionnaire. Meanwhile, Member States have been informed that both questionnaires are complementary and that they should also reply to the EP questionnaire. Coordinators took note of the reason for the postponement.
- Authorisation of mission orders for APAs for the eo. CONT meeting in Luxembourg:** The Chair explained that the Secretariat had just been informed that DG PERS did not authorise all mission orders to APAs for their participation in the extraordinary CONT meeting in Luxembourg on 27 October. The Secretariat worked on finding a solution as quickly as possible. The issue had been resolved

by a positive reply on 26 October.

Not only the European Commission, but all EU institutions, and the Parliament itself (besides other agencies, bodies and joint undertakings) go under the process of parliamentary scrutiny of the implementation of the budget. The European Institutions enjoy administrative autonomy according to Articles 316 and 335 of the TFEU and they are individually responsible for the implementation of their budgets according to Article 59 of the Financial Regulation. Parliament's Budgetary Control Committee takes a decision on discharge to other institutions and bodies on the basis of Rule 100 of Parliament's Rules of procedure.

The aim is to ensure compliance with the relevant legal and regulatory framework requirements, and verify its use in accordance to the principle of sound financial management, namely with the principles of "economy", "efficiency" and "effectiveness".

This year, additionally to the usual Institutions, also the European Public Prosecutor's Office is integrated in this discharge procedure.

In the framework of the annual procedure, questions related to the 2021 discharge were suggested by CONT Members. The Rapporteur submitted the full set of questions to each concerned Institution. The Q&A catalogue was forwarded to CONT Members on 13 October and is available on the [CONT website](#).



The questionnaires are focused on performance, internal controls, accountability and ethics, on human resources and working conditions, resources and procurement, with attention paid to digitalization and environment sustainability. Because the current discharge concerns the year 2021, a specific focus is given, also this year, to the Covid-19 crisis related measures.



The ECA Member will inform the Committee about the Court's findings on a budget that is mostly administrative and, as such, estimated at low risk.

The Recovery and Resilience Facility was established on 19 February 2021. Well before its establishment, the Commission was working on the preparations for the implementation. This allowed the Facility a flying start, with the disbursement of EUR 56,6 billion in pre-financing and a first performance based payment of EUR 10 billion in 2021.

Within the Commission DG ECFIN (as authorising officer) and the Recovery and Resilience Task Force (SG RECOVER) oversee the implementation of the Facility.

Both departments describe in their respective Annual Activity Reports in detail the work they have done for the implementation of the Facility.

The Court of Auditors concluded that, given the complexity of the process and time constraints, the Commission had performed an appropriate assessment. However, given the considerable amounts of financial support involved, and the fact that the Facility follows an entirely new implementation method, the

question remains whether the shortcomings identified by the Court can be sufficiently addressed.

In this special report the Court examines the assessment of the Commission of a sample of six national recovery and resilience plans (RRPs). These RRP detail the measures the Member States are taking to achieve the objectives of the Facility, and define milestones and targets that will be used to measure progress on the objectives. In addition, when milestones and targets have been fulfilled, the Member State can submit a payment request to receive the financial contribution agreed in the payment profile for that Member State.



The Rapporteur has prepared a Working Document, summarising the findings and recommendations of the Court and providing recommendations to the Commission that reflect the Rapporteurs view on the observations of the Court. The working document is available on the CONT Website.

First Vice-President Dombrovskis and Commissioner Gentiloni are jointly responsible for the implementation of the Recovery and Resilience Facility (the Facility). In this hearing the Members of the CONT Committee will examine their role in the implementation of the Facility, both as regards compliance with rules and regulations, based on the Annual Report 2021 of the European Court of Auditors, and on performance. As regards the Performance of the RRF, the Commission provides information on the [RRF scoreboard](#), and also the [Review Report](#) and the [Annual Implementation Report](#) are relevant.



The year 2021 is the first year that the Facility is examined in the discharge procedure. The Facility was set-up under Article 122 of the Treaty on the Functioning of the European Union. This meant that the Parliament had no formal say in the set-up and implementation of the Facility. The Parliament is however fully competent to assess the implementation of the Facility in its annual discharge procedure.

First Vice-President Dombrovskis and Commissioner Gentiloni will present the state of play of the implementation of the Facility, and will also react on the findings of the Court of Auditors on the first disbursement made under the Facility, with a value of EUR 10 billion (and EUR 1,5 billion in cleared pre-financing) to Spain. The Members will question both Commissioners on issues related to compliance, and, more important for the Facility, related to performance.
