Decision:

2. CONT mission to Spain - scope and places to visitbookmark://_Toc119486738/

By written procedure CONT Coordinators agreed to request that this mission to Spain should take place from 20 to 22 February 2023 (week 8). The CONT Chair further proposed to adapt the scope of the mission by dropping the idea of visiting Fusion4Energy in Barcelona which becomes redundant by the inclusion of a visit to Fusion 4Energy in Cadarache, combined with the mission to France. The Chair suggested to visit instead either a region particularly affected by the COVID-pandemic or a project benefitting from RRF funding.

Decision:

After constructive discussion among Coordinators, a consensual draft has been submitted for approval by written procedure which contained already many proposals.

From the further proposals suggested in the written procedure, only the one concerning the digital domain was taken up against the background of the limited

duration of the mission and the support by a majority of Coordinators.

The preliminary draft programme (locations and meetings to request) as agreed can be found in *Annex A*

The final program will be submitted again for approval.

3. Programme public hearing “Cohesion and NextGenerationEU”

The annual programme of committee hearings for the second semester of 2022 included a CONT hearing on "*Cohesion policy investments and NextGeneration EU recovery fund: state of play of the monitoring and controls*". In the written Coordinators' procedure of 27 September, CONT Coordinators decided to postpone this hearing until the first half of 2023, before the deadline for tabling amendments to the Commission Discharge (17 February 2023).

The hearing is scheduled for 23 January 2023. On the basis of a call for proposals to CONT Coordinators and groups, the programme has been prepared.

4. ECA SPECIAL REPORT ON EU SUPPORT TO COAL REGIONS - LIMITED FOCUS ON SOCIO-ECONOMIC AND ENERGY TRANSITION

The reporting Member of the European Court of Auditors, Mr Nikolaos Milionis, will present the main conclusions of the ECA Special Report on **EU support to coal regions - limited focus on socio-economic and energy transition**. To fight the climate crisis, the European Union has committed to reducing its greenhouse gas emissions to net zero by 2050. A fundamental step on that road is phasing out coal – a highly polluting energy source. The EU's Green Deal identified the phasing-out of coal energy production as an essential factor in achieving the 2030 climate change targets and becoming climate-neutral by 2050. Due to the dropping costs of wind and solar power, the inefficiency of the mining process, and EU and national climate policy, this process is already well under way. As of March 2021, half of Europe's coal plants had already shut down or have a closure date.

However, closing a coal mine or a plant has consequences. On the people employed there, their families, the wider community and the economy of the region. It is essential that a coal phase-out is meticulously planned, consulted upon, with all its impacts thought through and high-income economic alternatives found, so the process is socially fair as well as good for the people and the climate. This is known as a '*just transition*'.

A '*just transition*' away from coal inevitably requires a lot of up-front investment in re-training for former coal workers and to create new economic opportunities. Since 2018, the Commission has offered various types of expertise to the coal regions, and in 2020, it made proposals to set up the €19.3 billion Just Transition Fund. The ECA SR conclusions/recommendations cover the main areas impacted by the energy transition in the selected regions, more specifically, job creation, training/education, socio-economic needs and greenhouse gas emissions. Based on the collected evidence, it was concluded that the EU support to coal regions had a limited focus and impact on job creation and energy transition and that, despite overall progress, coal remains a significant source of greenhouse gas emissions in some Member States. Based on these findings, the ECA recommends the Commission to check that the Just Transition Fund is used effectively and efficiently to alleviate the socio-economic impact of the transition to climate-neutrality in coal and carbon-intensive regions and to share good practice for measuring and managing methane emissions. The CONT Rapporteur acknowledges that a successful « just transition » is a complex procedure, but believes that if done right, it can have a net benefit on coal regions in terms of employment, the economy and the environment. He recalls that impacts go beyond employment numbers, as the redundancies



of coal employees will also affect sub-suppliers, as well as the tax revenues in the respective regions, the social security and health insurance systems. Moreover, he considers that if not carefully managed through Just Transition policies and processes, economic changes could result in increased social inequality, worker disillusionment, strikes or civil unrest and reduced productivity, as well as less competitive business, sectors and markets. He therefore calls on the Commission to ensure that plans set out a detailed framework of support for all categories of workers affected directly and indirectly by the transition to a green economy.

JUs are partnerships between the Commission and industry. In some cases, research or intergovernmental organisations and participating states are also involved. The main mission of JUs is to foster the translation of scientific knowledge into marketable breakthrough innovations within a strategic vision that is shared by the industry and research partners. Moreover, JUs should respond to European social challenges currently insufficiently served by industry.

In November 2021, the Council adopted the Single Basic Act, setting up nine JUs to implement actions under the Horizon Europe programme, the multiannual research and innovation programme under the new 2021-2027 MFF, for the period ending on 31 December 2031^[1]. The general aim of the JUs under the Horizon Europe programme is to be more objective-driven and have more ambitious partnerships with the respective industrial sectors than under the previous programmes.

For the financial year 2021, the nine Joint Undertakings subject to the discharge procedure by Parliament are the following:

- The Single European Sky Air Traffic Management Research Joint Undertaking (SESAR 3);
- The Clean Aviation Joint Undertaking;
- The Innovative Health Initiative Joint Undertaking (IHI);
- The Clean Hydrogen Joint Undertaking Clean H2);
- The Key Digital Technologies Joint Undertaking (KDT);
- The Circular Bio-based Europe Joint Undertaking (CBE);
- The Europe's Rail Joint Undertaking (EU-RAIL);
- The European High Performance Computing Joint Undertaking (EuroHPC);
- The European Joint Undertaking for ITER and the Development of Fusion Energy (F4E).

On 15 November 2022, the Court of Auditors (ECA) published its specific annual report on JUs in the form of a single consolidated report on all JUs. The Court has signed off the 2021 accounts of all the EU's Joint Undertakings (JUs), and confirmed the positive results reported in previous years. The new Horizon Europe research and innovation-funding programme sets ambitious goals for the 2021-2027 budget period, and the

auditors call for action to get the Horizon 2020 contribution targets over the line, to address remaining weaknesses in internal controls, and to prepare for new challenges, such as human resources planning and management.

The European Development Fund ('EDF') is the main instrument for providing aid for development cooperation to the African, Caribbean and Pacific States and Overseas Countries and Territories (OCTs). The 11th EDF has reached its final stage as the sunset clause came into effect on 31 December 2020. This clause sets a cut-off date for commitments meaning that as of 2021 no further financing agreements can be signed under the 11th EDF. However, specific contracts for the existing financing agreements will still be signed until 31 December 2023 (and even later for audit and evaluation). Furthermore, the implementation of the ongoing projects funded by the European Development Fund will continue until their completion.

In the context of the new Multi-Annual Financial Framework 2021-2027, the EU cooperation with ACP countries is integrated in the Neighbourhood, Development and International Cooperation Instrument – Global Europe. Similarly, the cooperation with OCTs is now covered by the Overseas Association Decision (OAD). This means that while up to 2021 the EDF programmes were funded by the voluntary contributions of EU Member States, as of 2021 development programmes will be funded through the EU budget. This also implies that the funding of development programmes are subject to the authorisation of the European Parliament and that the transactions have to comply with the EU financial regulations in the same way as other EU funded programmes.



For the financial year ending 31 December 2021, the European Court of Auditors declared that the overall audit evidence indicates that the EDFs' accounts present fairly, in all material respects the EDFs' financial position, the results of their operations, their cash flows and the changes in net assets, in accordance in accordance with the provisions of the Financial Regulation and the accounting rules adopted by the accounting officer. Furthermore, the Court declared that the overall audit evidence indicates that, for the financial year ending 31 December 2021, the revenue of the EDFs was not affected by a material level of error and that EDF payment transactions were affected by a material level of error (the Court estimates the level of error to be 4.6 % based on their transaction testing).

The discharge hearing will be based on information provided in public documents, such as:

- the Court of Auditors' 2021 Annual Report;
- the Report on the implementation of the financial assistance provided under the 11th European Development Fund in 2021;
- the 2021 Annual Activity Report of DG INTPA.

In accordance with the timetable for the discharge procedure, the written questions for this meeting were sent to the Commission on 16 November 2022. The answers, received on 28 November, were immediately sent to all CONT Members.

It is proposed that the hearing with Commissioner Urpilainen proceeds as follows:

In its 2021 Annual Activity Report, DG REGIO reports a particularly difficult year for Member States and their regions: the pandemic lingered and the economic situation continued to be challenging. Despite these difficulties, DG REGIO remarks that cohesion policy continued to deliver on its primary objective of strengthening the economic, social and territorial cohesion by reducing disparities between regions and to deliver on the Union's political priorities, especially the green and digital transition.

DG REGIO reports that funding from the ERDF, the CF and the EUSF helped to reduce the impact of the COVID-19 crisis, foster convergence and make sure no one is left behind. Exceptional flexibility was offered under the Coronavirus Response Investment Initiatives CRII(+), resulting in close to EUR 17.2 billion from ERDF and CF mobilised to counter the crisis and provide support to healthcare, businesses and workers. ERDF and CF investments in climate action are expected to represent EUR 51 billion by 2023 from the 2014-2020 programmes. The Just Transition Funds (JTF), with an allocation of EUR 19.2 billion, aims at alleviating the social and economic impacts of the transition in the regions and territories most dependent on fossil fuels and carbon-intensive industries. The ERDF is also the main investment tool for the digitalisation of industry and SMEs.



The total available envelope for ERDF and CF of more than EUR 350 billion, including national co-financing, was allocated to projects implemented under 2014-2020 programmes. DG REGIO reports that the average residual total error rate (risk at payment) for the 2021 relevant expenditure for all management modes is between 1.9% and 2.5%, a slight improvement when compared to the previous year (2.1% up to 2.6% in 2020). In 2021, the European Court of Auditors reported an estimated level of error of 3.5% for Cohesion spending.

In 2021, 43 ERDF/CF programmes from the 2014-2020 period are in reservation. The reasons for reservations (which may be cumulative) are: significant deficiencies in the functioning of the management and control system (six cases); significant deficiencies in the functioning of part of the management and control system (17 cases); programme residual error rate above 2% (17 cases) and programmes with residual error rates >2% and significant deficiencies in the functioning of the management and control system (six cases).

- the Commission's Integrated Financial and Reporting package, and

Agriculture and rural development account for 97 % of spending on 'Natural resources and environment', heading 3 of the MFF, and is implemented through the common agricultural policy (CAP). Direct payments account for 67 % of spending under MFF3, including the 'basic payment scheme' (€14.8 billion), the 'single area payment scheme' (€4.4 billion), the 'greening payment' (€10.8 billion), and 'voluntary coupled support' (€4.0 billion). Rural development accounts for 26 % of spending under this MFF heading, complemented by agricultural market measures, which account for 4.4 %.



As in previous years, for direct payments which are mainly based on the area of agricultural land declared by farmers, ECA's results indicate that the level of error was not material. For the remaining areas the results of ECA's audit, taken as a whole, indicate a material level of error.

The Court estimates the level of error to be 1.8 %, which aligns with the Commission's own estimates as presented in the AMPR. ECA recommended to the Commission to support the use of new technologies for preventing errors in CAP payments; to perform audits, and ensure monitoring and evaluation, to confirm that measure M21 (*exceptional temporary support to farmers and SMEs particularly affected by the COVID-19 crisis*) funding properly targeted eligible beneficiaries suffering liquidity problems which put at risk the continuity of their farming or business activities.

The discharge hearing will be based on information provided in public documents, such as:

- the Court of Auditors' 2021 Annual Report, and
- the last Annual Report on Performance of the EU budget, as well as
- the Commission's Integrated Financial and Reporting package, and
- the 2021 Annual Activity Report of DG AGRI.

The procurement call was joined by another 14 Agencies (EU-OSHA, eu-LISA, EIT, FRA, CEPOL, EFCA, BEREC Office, ECDC, EUAA, ERA, ACER, EIGE, ENISA, EIOPA) and the collaborative nature of this call vastly contributed to achieving the following objectives:

- Increased the budget of contract offered in order to reap the benefits of economy of scale.
- Attracted enough economic operators to ensure real competition among the tenderers.
- Created a competitive procurement environment capable of delivering high quality tenders at the reasonable price range.
- Attracted pre-eminent operators on the market to tender with us (the record of tenders opened showed, among the others, ICF, Ecorys, IPSOS, Deloitte, CSES, Kantar, PwC).
- This joint procurement not only attracted several candidates to tender but secured enough of them entering into contractual relationship with us and this way ensuring stable pool of contractors available to work with over the next few years period (i.e. 5 on the contractual list).
