## **2. [CONT mission to Spain - scope and places to visit](#)[bookmark:// Toc119486738/](#)**

By written procedure CONT Coordinators agreed to request that this mission to Spain should take place from 20 to 22 February 2023 (week 8). The CONT Chair further proposed to adapt the scope of the mission by dropping the idea of visiting Fusion4Energy in Barcelona which becomes redundant by the inclusion of a visit to Fusion 4Energy in Cadarache, combined with the mission to France. The Chair suggested to visit instead either a region particularly affected by the COVID-pandemic or a project benefitting from RRF funding.

### **Decision:**

After constructive discussion among Coordinators, a consensual draft has been submitted for approval by written procedure which contained already many proposals.

From the further proposals suggested in the written procedure, only the one concerning the digital domain was taken up against the background of the limited

duration of the mission and the support by a majority of Coordinators.

The final program will be submitted again for approval.

### **3. Programme public hearing “Cohesion and NextGenerationEU”**

The annual programme of committee hearings for the second semester of 2022 included a CONT hearing on "*Cohesion policy investments and NextGeneration EU recovery fund: state of play of the monitoring and controls*". In the written Coordinators' procedure of 27 September, CONT Coordinators decided to postpone this hearing until the first half of 2023, before the deadline for tabling amendments to the Commission Discharge (17 February 2023).

#### *Presentation of the special report by reporting ECA Member Marek Opiola*

The reporting Member of the European Court of Auditors, Mr Marek Opiola, will present the main conclusions of the ECA Special Report on **Verification of Gross National Income for financing the EU budget. Risks in data compilation well covered overall, but scope for increased prioritisation of actions.**

The Gross National Income (GNI)-based contributions from Member States is the largest revenue source for the EU budget. In 2021 it accounted for 63% (116 billion) of total EU revenue.

The Commission calculates this own resource as a percentage of Member States' annual GNI. To calculate Member States' contributions the Commission uses GNI forecasts which will be reviewed at a later stage.

The overstatement or understatement of GNI data for a particular Member State does not affect the total amount collected as EU revenue but it will decrease or increase contributions from other Member States.

EU legislation therefore requires the Commission to verify the sources and methods used by Member States to compile their GNI data. The verifications, which are carried out by the **Statistical Office of the European Union (Eurostat)** must ensure that the verification process itself is cost-effective and that Member States pay fair and predictable GNI-based contributions.

The Court examined the most recently completed GNI verification cycle (2016-2019) to assess whether the Commission had managed it effectively and efficiently. The Court found that, overall, the Commission was effective in identifying high-risk issues, but did not address all of them in a timely manner.

As a result of the audit, the Court makes recommendations to help the Commission, through Eurostat: increase prioritisation of high-risk issues; improve the timeliness of the support provided to Member States and better justify decisions to limit the period of application for reservations; and further improve the efficiency of the verification cycle.

The CONT Rapporteur recalls that the Gross National Income (GNI)-based own resource is the main source of financing for the EU budget and it is essential to reinforce the verification cycles for each State to pay its contributions adequately to the European budget. He therefore calls on the Commission to ensure that the



recommendations issued by the Court are implemented for the next verification cycle starting in 2025.

The CONT Committee is organising a public hearing on the state of play of monitoring and controls in the Cohesion policy and in the NextGenerationEU programme.

Both programmes follow a different implementation method, with shared management in Cohesion, and direct management, yet with a major involvement of the Member States, in NextGenerationEU.

Both programmes were negotiated at the same time, however the implementation of Cohesion is off to a relatively slow start, with the late adoption of the Member States' partnership agreements.

These issues will be explored by two panels of speakers. This first panel will take an academic perspective, setting the state by looking into democratic accountability in Cohesion and NextGenerationEU as the fundament of monitoring and controls. This will be followed-up by a second panel of 'practitioners' from the Court of Auditors, the Directorate-General for Regional and Urban Policy and the Directorate-General for Economic Affairs of the Commission.

## **6. ECA SPECIAL REPORT 18/2022 - EU INSTITUTIONS AND COVID-19 - RESPONDED RAPIDLY, CHALLENGES STILL AHEAD TO MAKE THE BEST OF THE CRISIS-LED INNOVATION AND FLEXIBILITY**

The ECA reporting Member, Marek Opiola, will present the findings and conclusions of his Special Report on EU institutions and COVID-19, to the CONT and COVI Committees.

At the end of January 2020, the first case of COVID-19 was officially recorded in Europe. In a matter of weeks, the disease spread across the EU, forcing most Member States to put in place measures to slow down the rate of infection. With citizens urged to stay home and telework, the EU institutions had to find ways to ensure business continuity.

The ECA assessed the resilience of the EU institutions: their level of preparedness, how they coped with the COVID-19 pandemic, and what lessons they have drawn from it.

In particular, whether the four audited Institutions (the European Parliament, the Council, the European Commission, and the Court of Justice of the EU) followed recognised standards in their business continuity plans, and whether these plans were adapted to the type of disruption caused by a pandemic; whether they were able to function, minimising disruption and fulfilling their respective roles as assigned under the EU Treaties; and whether they drew lessons to adapt to their post-COVID-19 environment.

Overall, the ECA concluded that the EU institutions demonstrated their resilience in the face of the COVID-19 pandemic. Their response was rapid and flexible, and benefited from previous investments in digitalisation. However, they have not yet fully evaluated the extent to which new ways of working introduced in response to COVID-19 are likely to be efficient or bring savings in the post-crisis environment.

Following its findings and conclusions, the ECA issued three recommendations addressed to the four audited EU institutions.

The European Parliament draft discharge report for the financial year 2021 is based on a wide range of information, which is available on the CONT

website:

- Parliament's accounts for the financial year 2021,
- the report on budgetary and financial management,
- the Secretary-General's Statement of Assurance,
- the Annual Activity Reports by the Authorising Officers,
- the European Court of Auditors' Annual Report 2021,
- the follow-up report drawn up by the Administration in response to the previous year's discharge resolution,
- the questionnaire with the Secretary-General's replies, emailed to Members on 23 November 2022, and
- the exchange of views in CONT on 1 December 2022 with the Vice-President responsible for budgetary affairs, the Secretary General, the Court of Auditors, the Internal Auditor and the Director of the Authority for European Political Parties and Foundations.

The Rapporteur, Ms Isabel García Muñoz, is to present her draft report on the Parliament's management for the financial year 2021.

She welcomed the Court's conclusions in its special report 18/2022 on 'EU institutions and COVID-19' that the institutions audited, including Parliament, demonstrated their resilience in the face of the COVID-19 pandemic and that their response was rapid and flexible and benefited from previous investments in digitalisation.

She then expressed deep disappointment that each year, very concrete demands adopted by Plenary in discharge resolutions are not reflected in the discussions of the Bureau meetings. Furthermore, she recalled the seriously inadequate staffing levels in Parliament's committee secretariats at the end of 2020 due, *inter alia*, to the increased workload, the working methods applied under the COVID-19 pandemic. She also expressed concerns regarding the particular difficulties in finding candidates willing to work for Parliament in Luxembourg, mainly due to the high cost of living and the increasing price of housing while availing of a salary that is adapted to living conditions in Brussels.

She then called for a thorough overhaul of Parliament's ethical framework that integrates lessons learned and strengthens the current rules to ensure that there are stronger deterrents to address effectively current and future threats and interferences, whether they affect Members or staff. To that aim, she called, in particular, for a revision of the Rules of Procedure and the Members' Code of Conduct, as well as for an urgent upgrade of the current European Parliament's Advisory Committee on the Conduct of Members.

The Rapporteur also voiced concerns that the actuarial deficit of the Voluntary Pension Fund (VPF) on 31 December 2021 amounted to EUR 379 million (compared to EUR 371.3 million on 31 December 2020), and that its complete exhaustion is expected by the end of 2024 or 2025 at the latest.

In the framework of the discharge procedure for the 2021 budget, the Rapporteur had submitted the full set of questions to each concerned Institution, taking into account the suggestions and input received from Shadows and other CONT Members. The Secretaries-General of the Other Institutions had received the questions on 28 September and their written replies, provided on 13 October, were circulated to Members on the same day. For the European External Action Service (EEAS) the questionnaire was sent on 10 October 2021 and replies received on 26 October were circulated on 27 October 2021.

Discharge hearings were held on 24 October with the Secretaries General and Director-Generals of the Other Institutions. Council did not send replies and was not present at the hearing. On 8 November, the discharge hearing was held with the High Representative Vice-President of the EEAS. To both the hearings participated the ECA Member Marek Opiola, who informed the CONT on the relevant findings, and related considerations, inspired by the ECA annual discharge audit work.

At this meeting, the CONT Members will have an exchange of views on the 2021 budget discharge for Other Institutions, including the EEAS, based on the draft reports.

The Rapporteur has prepared the draft discharge reports based on the above exchanges of views in the CONT Committee and on the replies given by the institutions concerned. The proposed texts take into account the relevant documents, amongst which the annual reports of the different Other Institutions, the related balance sheets and annual accounts, the internal audit reports and, as every year, they look into the Court of Auditors (ECA) annual report 2021 on Chapter 9 "Administration". The latter ECA report focuses on expenditure on human resources, buildings, equipment, energy, communication and information technology but it does not target the administrative expenditure of each individual Other Institution, instead it refers only to the error level of the administrative expenditure at the aggregated EU budget, that the Court indicates as being, overall, a low-risk expenditure. The European Public Prosecutor's Office, formally audited by ECA as an agency, is included in the OIs discharge for the first time since the starting of its operational activities in June 2021.

The draft reports comprehensively take into consideration performance, internal controls, accountability and ethics, human resources and working conditions, resources and procurement. A specific focus is devoted to digitalization and environment sustainability. Because the current discharge concerns the year 2021, a specific attention is paid, also this year, to the Covid-19 crisis related measures, to the lesson learned and follow up given to the budgetary and work efficiency and organisational matters originated by the pandemic crisis, including staff well-being, staff productivity and work-life balance and the adjustment adopted to adapt the internal functioning and work methods.

It is proposed that the consideration of the draft reports proceeds as follows:

- Presentation of the draft reports by the CONT Rapporteur;
- The Shadow Rapporteurs will present their views on the draft reports, followed by, if time allows, a catch-the eye session;
- Closing remarks by the CONT Rapporteur.

[Article 187](#) of the Treaty on the Functioning of the European Union (TFEU) specifies that the EU may set up joint undertakings (JUs) or any other structure necessary for the efficient execution of EU research, technological development and demonstration programmes.

Article 187 TFEU has been used under the EU's research framework programmes to set up, in particular, public-private partnership bodies in order to integrate industrial research in specific areas.

The members of these JUs are typically the European Union (represented by the European Commission) and industry-led associations, as well as other partners. JUs adopt their own research agenda and award funding mainly on the basis of open calls for proposals.

In some cases, research or intergovernmental organisations and Participating States are also involved. The main mission of JUs is to foster the translation of scientific knowledge into marketable breakthrough innovations within a strategic vision that is shared by the industry and research partners. Moreover, JUs should respond to European social challenges currently insufficiently served by industry.

On 19 November 2021, the Council of Ministers of the European Union adopted a regulation (Single Basic Act) for the establishment of nine Joint Undertakings under Horizon Europe. The European Union, Member States and/or the private sector jointly implement these European Research and Innovation Partnerships.

The regulation aims to make the use of institutionalised European partnerships more effective, in particular by focusing on clear objectives and outcomes that can be achieved by 2030, and by ensuring that there is a clear contribution to related EU policy priorities.

The partnerships, established as European Union bodies for a duration until 31 December 2031 (under the new 2021-2027 MFF), will have a budget of approximately €10 billion until 2027 from the Horizon Europe programme, complemented by an equal amount from the participating partners.

For the financial year 2021, the nine Joint Undertakings subject to the discharge procedure by Parliament are the following:

- The Single European Sky Air Traffic Management Research Joint Undertaking (SESAR 3);

- The Clean Aviation Joint Undertaking;
- The Innovative Health Initiative Joint Undertaking (IHI);
- The Clean Hydrogen Joint Undertaking Clean H2);
- The Key Digital Technologies Joint Undertaking (KDT);
- The Circular Bio-based Europe Joint Undertaking (CBE);
- The Europe's Rail Joint Undertaking (EU-RAIL);
- The European High Performance Computing Joint Undertaking (EurpHPC);
- The European Joint Undertaking for ITER and the Development of Fusion Energy (F4E).

On 15 November 2022, the Court of Auditors (ECA) published its specific annual report on JUs in the form of a single consolidated report on all JUs. The Court has signed off the 2021 accounts of all the EU's Joint Undertakings, and confirmed the positive results reported in previous years.

The draft reports are based on the following set of documents:

- 2021 Annual report on EU Joint Undertakings for the financial year 2021 - European Court of Auditors;
- Joint Undertakings' individual Report on Budgetary and Financial Management;
- Joint Undertakings' individual Annual Activity Report;
- Joint Undertakings' individual Annual Accounts.

The Rapporteurs echoed the European Court of Auditors' opinion, both on the positive results and on remaining weaknesses in internal controls. Furthermore, the Rapporteurs consider that there are aspects in the human resources planning and management that need improvement.

## **27. PRESENTATION OF DG REGIO'S OPEN DATA PLATFORM, AND DG ECFIN'S RRF SCOREBOARD**

At the request of the Directorate-General for Regional and Urban policies, the CONT Committee organises a presentation of the updated Open Data Platform, that allows for a first look at the data coming in from the 2021-2027 programming period. The CONT Coordinators decided to ask the Commission to present also the Recovery and Resilience Scoreboard in this meeting. The aim of these presentations is to be informed about these platforms and to see how they can be used to support the work of the Members.

The **Cohesion Open Data Platform**, visualises and provides open data on hundreds of national, regional and interregional programmes funded by the EU Budget.

Initially the platform was mainly focused on the 2014-2020 funding period and provided common information covering all five European Structural and Investment Funds, as well as the Youth Employment Initiative. In October 2022 the platform was extended to present the 2021-2027 adopted programmes with new navigation functions and navigation pages for 2021-2027 countries, themes and funds.

The **Recovery and Resilience Scoreboard** gives an overview of how the implementation of the Recovery and Resilience Facility (RRF) and the national recovery and resilience plans is progressing. The RRF entered into force in February 2021 to mitigate the economic and social impact of the Covid-19 pandemic.
