The AFCO Committee is preparing a report with proposals from the Parliament on a revision of the Treaties as a follow up to the Conference on the Future of Europe and in line with the Parliament's resolution of 9 June 2022 on a call for a convention for the revision of the Treaties. Many Committees are contributing with opinions within their fields of competence. The final report from AFCO is expected to be voted in Plenary in spring.

The opinion in the form of a letter from the CONT Committee has been approved by Coordinators in a written procedure on 12 January. The summary of Coordinator's recommendations were sent to all CONT members on 26 January. The letter with an annex with a concrete proposal for a revision on article 319 was sent to all CONT Members on 1 February.

The proposal for an amendment of article 319 TFEU would clarify that the Parliament besides giving discharge to the Commission also gives a discharge to other institutions, bodies, offices and agencies in respect of the implementation of their sections of the budget or of their budgets, as appropriate, and in accordance with conditions to be laid down pursuant to Article 322.

As a final vote, the vote will be taken by roll call in line with Rule 218(3) RoP..

The 34 draft reports concerning the 2021 decentralised agencies' discharge will be presented by the Rapporteurs before the Committee.

With regard to the 33 decentralised agencies subject to the 2021 discharge procedure, the ECA issued unqualified (clean) audit opinions on the reliability of the accounts for all agencies, on the legality and regularity of their revenues and on the legality and regularity of the payments underlying all agencies' accounts. The single exception being eu- LISA for which ECA issued a qualified opinion on the legality and regularity of the payments underlying their accounts.

The Rapporteurs' draft reports present various observations on budget and financial management; performance; staff policy; procurement; prevention and management of conflicts of interest, and transparency; internal control; digitalisation and green transition; and, business continuity along the crisis.

Some observations focus on priorities such as setting up a cybersecurity policy in view of the upcoming cybersecurity regulation for EU bodies and institutions, the sharing of available resources in capacity building among agencies, a long term HR policy on work-life balance and career development in the Agencies' staff policy, transparency and equal treatment in recruitment, fair procurement procedures, and the strengthening of the internal control systems, among others.

The 8th to 11th EDF programmes are not funded by the EU budget, but were established by an Internal Agreement of the Representatives of the Member States. The 11th EDF has reached its final stage as its sunset clause came into effect on 31 December 2020 and, as from 2021, the EDF programmes have been included in the Union's multiannual financial framework (MFF), however, specific contracts for existing financing agreements will still be signed until 31 December 2023) and continue to be implemented and reported on separately until their closure.

As of the 2021-2027 MFF period, the EDFs, the Development Cooperation Instrument (DCI) and other instruments with the NDICI (Neighbourhood, Development and International Cooperation Instrument) have been incorporated into the Union general budget under heading 4 'Global Europe', which accounts for 6,6 % or EUR 11,4 billion of the Union budget. Such a new set-up entails new institutional responsibilities and tasks, in particular for Parliament as one arm of the budget authority for the annual budget.

The European Court of Auditors (ECA), in its annual report on the activities funded by the eighth, ninth, tenth and eleventh EDFs for the financial year 2021, concludes that the accounts for the financial year ending 31 December 2021 present fairly, in all material respects, the EDFs' financial position and are in accordance with the provisions of the Council Regulation (EU) 2018/1877 ('EDF Financial Regulation') and the accounting standards for the public sector.

As the EDF programmes are included in the Union's multiannual financial framework (MFF), the ECA's audit on EDF will be phased out as EDF payments decrease, and payments from the EU budget increase. Therefore, the European Court of Auditors will progressively shift resources to audit the EU budget, however, the current approach (separate report on EDF) is maintained for the 2022 statement of assurance exercise.

The Rapporteur welcomed the integration of EDF in EU budget, as this increases to EP's democratic control of EU funds. In his view, EU should support development, for reasons of both solidarity and self-interest. Development of our partner countries will contribute to stability in the region and globally.

Furthermore, the rapporteur considers that visibility of EU funding should be increased, together with the fostering of European core values.

Moreover, he believes that poverty eradication and environmental degradation remain among the greatest challenges we face today. Amongst the several targets for EU funding, the Rapporteur advocates a strong investment in people via the prioritisation of education and training, as the best tools for combating poverty,

social exclusion and inequalities.

In their draft report, Jeroen Lenaers and Monika Hohlmeier highlight the importance of the Union budget for achieving the Union's political priorities, as well as its role in assisting Member States in unforeseen situation, and underline the relevance of reporting on the performance of the Union budget's programmes for the discharge procedure. The rapporteurs reiterate their deep concern regarding the situation concerning the rule of law in a number of Member States, which is deeply worrying in its own right and leads to serious losses for the Union budget, underlining that Union funds must not be used for anti-democratic activities or for strengthening authoritarianism.

The rapporteurs reiterate the need to step up the efforts in the fight against fraud both at Union and Member State level, in close cooperation with the EPPO and OLAF, and remark the need to better balance the further simplification of rules and procedures with better controls over the most repeated areas of irregular spending.

Furthermore, the rapporteurs stress the need to enlarge the areas where the EDES is used beyond direct management and requests the Commission to use it for all Union funds including funds under shared management, and the need to harmonise the indicators in ARACHNE with the exclusion grounds of EDES to ensure that excluded economic operators are also visible in ARACHNE. In this line, the rapporteurs reiterate the imperative need of a single mandatory integrated and interoperable information and monitoring system provided by the Commission, allowing for the electronic recording and storage of data on the recipients of Union funding, including their beneficial owners and allowing for the availability of this information for data-mining and risk-scoring purposes.

Mr Lenaers, as responsible for the MFF chapter of the 2021 discharge report, regrets that the Court has again issued an adverse opinion on the legality and regularity of the expenditure side of the budget, and notes with concern the overall error rate calculated by the Court of 3,0 %, which is 1,0 % point above the materiality

threshold, noting that this is a deterioration in comparison with 2020, when the error rate was 2,7 %. The rapporteur notes with concern that the Court of Auditors considers that the Commission's risk assessment is likely to underestimate the level of risk in several areas, expresses his support for the audit methodology of the Court, and regrets the lack of alignment between the Court's and the Commission's approaches.

Ms Hohlmeier, as responsible for the RRF chapter of the 2021 discharge report, welcomes the RRF's contribution to preventing a strong economic downturn following the COVID-19 pandemic, but is concerned by the findings of the Court in its first annual assessment of the RRF. The rapporteur notes the successful efforts of the Commission to raise funds on the financial markets to provide the financial means for the RRF, but is concerned by the resulting debts, the rising interest rates and the resulting uncertain capacity to repay the loans and the risk this poses for the Union budget and Union policies.

40. LARGE TRANSPORT INFRASTRUCTURE PROJECTS IN THE EU - IMPLEMENTATION OF PROJECTS & MONITORING AND CONTROL OF EU FUNDS

In his draft report, the rapporteur, Mr Novakov, explains that large projects play a key role in transport networks, delivering great socio-economic benefits, creating and sustaining employment, improving productivity and competitiveness, enhancing infrastructure and affecting the everyday lives of citizens. The rapporteur highlights that large transport projects are tangible examples of EU budget's impact and solidarity and therefore, that effective monitoring and control and sound financial management of this type of project is one of the keys to their successful implementation.

The rapporteur underlines that Member States' transport networks cannot be looked at in isolation; stresses that the proper connectivity within and between European regions is crucial, especially with regard to Russia's war of aggression against Ukraine and the critical need to establish alternative logistics routes using various transport modes.

The rapporteur also highlights that international experience as regards the financing and implementation of large infrastructure projects is worth analysing, and calls for the lessons from this analysis to be considered in the architecture of future policies (post-2027). A systematic risk-based monitoring system for large transport projects would help to better address the significant delays of large transport infrastructure projects in the EU and would contribute to further improvements in managing cost overruns. The rapporteur expresses its concern that there is a lack of systematic evaluation of large transport projects in the EU and that existing monitoring is focused mainly on financial inputs and outputs rather than outcomes.

The Financial Regulation is the 'single rulebook' laying down the principles and general financial rules for establishing and implementing the EU budget and controlling EU finances. With the entry into force of the 2021-27 MFF, the Financial Regulation needs to be aligned. On 24 November 2021, Parliament adopted a resolution on the revision to express its views on what it should address.

On 16 May 2022, The Commission published its proposal for the revision, targeted to the MFF alignment and to specific improvements and simplifications that mostly build on the lessons learned from the COVID-19 pandemic and focus on crisis management, the protection of EU financial interests, and simplification. In their draft report, the co-rapporteurs propose a number of amendments to improve the Commission proposal in line with the views expressed by Parliament.

They propose that future activation of assigned revenue provided for in a basic act (as was for instance the case for NGEU) be subject to a decision of the budgetary authority. A much needed form of oversight of the Commission's borrowing and lending operations is also introduced, in the form of an annual 'debt ceiling' that the budgetary authority can set in the context of the annual budgetary procedure. In addition, an amendment generalises the reuse of de-committed appropriation in the budget, making it automatic.

The rapporteurs also propose to reinforce the link between EU finances and Union values, and the tracking and mainstreaming of EU policies (climate, biodiversity, social aspect and gender equality).

Several amendments are devoted to improving the tracking of EU funds via the introduction of a single integrated interoperable reporting and monitoring system to be set up by the Commission, allowing for the electronic recording and storage of data on the recipients of Union funding, also in an aggregated format, including their beneficial owners and allowing for the regulator making of those data available for data-mining and risk-scoring.

41. CONT MISSION TO SPAIN (20-22 FEBRUARY 2023)

A delegation of the CONT Committee will be in Madrid from 20-22 February 2023 to assess the implementation of Spain's National Recovery and Resilience Plan including milestones and targets and particularly the management, audit and control systems in place. This is the first such mission that the CONT Committee undertakes on the implementation of the Recovery and Resilience Facility (RRF) and comes at a crucial stage, now that the RRF is well past its inception and the first payment, to Spain, is under scrutiny in the annual discharge procedure for the year 2021.

In order to prepare for the mission, the Commission has been invited to share the latest insights it has in the implementation of the RRF in Spain. The two involved Commission Services, the Recovery and Resilience Taskforce of the Secretary-General (SG RECOVER) and the Directorate-General for Economic and Financial Affairs (DG ECFIN) will be represented by Director-General Céline Gauer and deputy Director-General Declan Costello respectively.

The Court of Auditors, represented by Member Ivana Maletić, will present its experience resulting from recently performed audits and reviews, with a particular focus on Spain. The European Anti-Fraud Office has been invited to present, as far as possible, its investigative work and most recent experience in its cooperation with the Spanish authorities.

Presentation of the special report by ECA reporting Member Ivana Maletić

The ECA reporting member Mrs. Ivana Maletić will present the main findings and recommendations of the Special Report on Synergies between Horizon 2020 and European Structural and Investment Funds, to the CONT members.

Between 2014 and 2020, the EU dedicated 12 % of its budget to R&I, more than ever before. Of this, €76.4 billion came from Horizon 2020, and almost €41 billion from the ESIF.

According to the 2014-2020 legal frameworks of the main EU programmes supporting research and innovation - Horizon 2020 and the European Structural and Investments Funds- the Commission and national authorities are legally required to establish synergies between them.

The auditors checked whether the Commission and managing authorities in EU Member States had taken the requisite steps to create synergies between the funds in order to ensure that they produced a greater effect than individual interventions.

The ECA's overall conclusion is that the implementation of synergies between Horizon 2020 and the European Structural and Investment Funds (ESIFs) varied between the different types of synergies: for example, while planned measures to create upstream synergies were well implemented, measures to create downstream synergies were hardly implemented. This is due to a number of reasons: the lack of alignment between rules and regulations, limited cooperation between the two programmes' research and innovation stakeholders, and the absence of interoperability between their databases limited the scope for the Commission and national/regional authorities to create synergies. In addition, there was no system for monitoring synergies, meaning that the Commission was not in a position to systematically identify and promote examples of good practice.



The Court issued four recommendations to address the identified issues that the Commission accepted.
