## 4. DISCHARGE 2021: PRESENTATION OF THE COUNCIL RECOMMENDATIONS BY THE SWEDISH PRESIDENCY

Administrator: Kaare Barslev

On 22 February 2023, Coreper II approved the recommendation that the European Parliament grants discharge to the Commission for the implementation of the EU's 2021 budget. The recommendations are expected to be finally adopted by the ECOFIN Council on 14 March.

The recommendation has been prepared on the basis of the Court of Auditors' annual report concerning the financial year 2021, including its report on the performance of the EU budget - Status at the end of 2021. In its annual report, the ECA concluded that the revenue for the financial year 2021 is legal, regular, and free from material error. At the same time, the ECA, as last year, issued an adverse opinion on the legality and regularity of expenditure after finding that high-risk expenditure (mainly spending on a reimbursement basis, which is subject to complex rules) is affected by material error and represents over half of the audit population. The ECA therefore, considered that the error in expenditure is pervasive.

The Council is also adopting recommendations on the discharge to be granted to the Commission for the implementation of the EDF, to the Directors of the EU's decentralised agencies, executive agencies and the joint undertakings for the implementation of their 2021 budgets. These recommendations follow the ECAs 2021 annual reports on EU Agencies and Joint Undertakings.

The recommendations require a qualified majority for adoption by Council.

The presentation by the Council Presidency on the main features of the recommendation will be followed by an exchange of views with the Members of the Committee and the representatives from the Presidency.

### Consideration of draft report

In his draft report, the rapporteur, Mr Novakov, explains that large projects play a key role in transport networks, delivering great socio-economic benefits, creating and sustaining employment, improving productivity and competitiveness, enhancing infrastructure and affecting the everyday lives of citizens. The rapporteur highlights that large transport projects are tangible examples of the EU budget's impact and solidarity and therefore, that effective monitoring and control and sound financial management of this type of projects are

some of the keys to their successful implementation.

The rapporteur underlines that Member States' transport networks cannot be looked at in isolation; stresses that the proper connectivity within and between European regions is crucial, especially with regard to Russia's war of aggression against Ukraine and the critical need to establish alternative logistics routes using various transport modes.

The rapporteur also highlights that international experience as regards the financing and implementation of large infrastructure projects is worth analysing, and calls for the lessons from this analysis to be considered in the architecture of future policies (post-2027). A systematic risk-based monitoring system for large transport projects would help to better address the significant delays of large transport infrastructure projects in the EU and would contribute to further improvements in managing cost overruns. The rapporteur expresses his concern that there is a lack of systematic evaluation of large transport projects in the EU and that existing monitoring is focused mainly on financial inputs and outputs rather than outcomes.

The BUDG Committee is expected to adopt Parliament's guidelines for the 2024 Budget - Section III on 27-28 March. The deadline for opinions from other committees to the Parliament's guidelines report is 9 March.

The opinion in the form of a letter from the CONT Committee has been approved by Coordinators in a written procedure on 21 February. The letter was sent to all CONT Members on the same day.

Notably, the CONT Committee letter to the BUDG Committee deplores the fact that in 2021, the implementation of commitments was very low, at 68 % of the total available, and that the late adoption of sectoral regulations during 2021 delayed the launch of new programmes. It also welcomes the successful efforts of the Commission to raise funds on the financial markets to provide the financial means for the Recovery and Resilience Facility (RRF), making it an important instrument to provide support in a time of extreme crisis, but expresses some concerns about the rising interest rates and the resulting uncertain capacity to repay the loans and the risks this poses to the Union budget and agreed Union policies.

As a final vote, the vote will be taken by roll call in line with Rule 218(3) RoP.

On 24 January 2023, the Rapporteur presented the draft reports for the Other Institutions and the External Action Service in the CONT Committee. For the first time also the European Public Prosecutor's Office was included, having become operational in June 2021 and integrated amongst the Other Institutions for the process of discharge to the general budget of the EU. The draft discharge reports were prepared on basis of the exchanges of views in the CONT Committee following the hearings of the Secretaries General and Director-Generals of the Other Institutions and on the written replies given to the questionnaires by the institutions. The texts presented had taken into account the annual reports, the related balance sheets and annual accounts, the internal audit reports and the results of the work of the European Court of Auditors (in particular, its annual report 2021, Chapter 9 on "Administration").

By the deadline of 31 January 2023, a total of 202 amendments were tabled to the nine draft reports. The tabled amendments cover all the areas of interest: human resources (gender and geographical balance), performance and budget execution, digitalization, environment, accountability and ethics, working conditions and the issues related to the pandemic outbreak.

In addition to the amendments tabled to the draft reports, the JURI, LIBE and AFET Committees have provided opinions respectively to the discharge of Court of Justice (Rapporteur, Adrián Vázquez Lázara), Data Protection Supervisor and European Public Prosecutor's Office (Rapporteur, for both, Saskia Bricmont) and European External Action Service (Rapporteur Carina Ohlsson). These contributions have also been integrated in the voting lists for the vote.

Following exchange of views at a technical meeting, and further written consultations, a total of 17 compromise amendments have resulted from the continuous exchanges and cooperation between the Rapporteur and the Shadows, and will be put to the vote.

On 19 July 2022, the Commission put forward a proposal for a regulation establishing the European defence industry reinforcement through common procurement act (EDIRPA). On 1 December 2022, the Council adopted its general approach. On 18 January 2023, the rapporteurs from the AFET and ITRE joint committee published their draft report. EDIRPA is a short-term joint defence procurement instrument worth €500million. It seeks to address the most urgent and critical defence capability gaps and to incentivise Member States to procure defence products jointly.

The rapporteurs welcomes the Commission's proposal, and concurs that without coordination and cooperation, increased Member State investments into defence risk to deepen the fragmentation of the European defence sector, to limit the potential for cooperation throughout the life cycle of the equipment, to intensify external dependencies and to hamper interoperability.

In this proposal for a CONT opinion, the rapporteur focuses on three main areas: the types of financing and the choice on its implementation methods, key elements of the definition of the Work Programme and the award criteria, and the protection of the financial interests of the Union, including enhancing the role of the Court of Auditors, OLAF and the EPPO.
