Coordinators approved the proposals by the Secretariat/the Chair.

### 2. Proposals for public hearings, missions and interparliamentary committee meetings for the second half of 2023

The CCC Secretariat has asked for requests concerning missions, public hearings and inter parliamentary committee meetings for the second semester of 2023 to be submitted by 5 April 2023.

Coordinators already decided by written procedure on 6 September 2022, to request a mission to Romania from 24 to 26 July 2023. The objective of the fact-finding mission to Romania would be to look into the implementation of EU funds in shared management, including the possible fraud linked to the ITI instrument for the Danube Delta and the implementation of the RRF-programme.

At their meeting on 28 February 2023, Coordinators expressed their interest in organising a mission to Luxembourg in week 44 with a view of combining the annual meeting with the ECA with a visit to other Luxembourg based EU organisations.

With the mission programme for 2023 comprising Spain, Hungary, France, Romania and



Luxembourg, the quota for missions in 2023 (25 MEPs) is expected to be fully exhausted.

Coordinators are invited to prepare for the choice of a last mission under this legislature that could be granted during the first three months of 2024.

**Decision:**

Coordinators approved to request the authorisation of the following missions for the second semester 2023:

- a mission to Romania (Bucharest and the Danube Delta) from 24 to 26 July 2023 (week 30) and
- a mission to Luxembourg from 30 to 31 October 2023, including the annual meeting with ECA and visits to the EIB and the EPPO (week 44).

**3. *Appointment of a rapporteur (OLAF and OLAF SC annual reports)***

In accordance with usual practice, upcoming CONT meetings are expected to include the following items:

- Annual report 2022 of OLAF and annual report of the OLAF Supervisory Committee

These items will be organised as an exchange of views. Last year a rapporteur was appointed for these items (without costing points). For the sake of consistency, the Secretariat would propose to appoint again a rapporteur for both reports.

**Decision:**

EPP, S&D and the Greens expressed interest in having the rapporteurship for one of these reports. Coordinators from the three groups will coordinate who will take the rapporteurships and inform the Secretariat.

**4. *Meeting with the new OLAF Supervisory Committee during an upcoming CONT meeting***

The OLAF Supervisory Committee has been completely renewed at the end of last year. The new members of the Supervisory Committee have expressed an interest in meeting the CONT committee for a general exchange of views.

**Decision:**

Coordinators approved that an exchange of views with the new members of the OLAF Supervisory Committee is organised for an upcoming CONT meeting, possibly at the occasion of the presentation of the annual report of the OLAF Supervisory Committee.

**5. *Possible topics for the annual Inter-Institutional Exchange of Views with OLAF***

The EP is responsible for organising this year the inter-institutional exchange of views with OLAF, as required by Article 16 (1) of the OLAF Regulation. Usually this meeting is taking place in autumn, when Spain will hold the Council Presidency.

**Decision:**

Coordinators approved that topics for the annual inter-institutional exchange of views with OLAF should be communicated to the Secretariat before 1 June 2023.

**6. Meeting and cooperation with representative(s) of the Budget Committee of the Ukrainian Parliament****Decision:**

Coordinators approved that a meeting with members of the Budget Committee of the Ukrainian Parliament is organised at one of the upcoming CONT meetings subject to possible guidelines/recommendations for such meetings from the CCC.

Since budgetary control and fight of corruption will be essential for Ukraine's development, it was agreed that the Chair should write a letter to President Metsola stressing that CONT should play an important role in the institutional cooperation between the EP and the Ukrainian Parliament.

**7. Prolongation of delegation to the Chair to decide on remote Coordinator's meetings**

**Decision:**

Coordinators approved to prolong the delegation to the Chair to decide on remote Coordinator's meetings until the end of October 2023. In line with the CCC guidelines for hybrid meetings, a request has to be made at least five working days ahead of the meeting.

**8. CONT contribution to the summary report 2023**

A every year, committees are requested by the CCC to provide input in their areas of competence to feed the yearly Summary Report designed a) to assess the implementation of the current Commission work programme, b) to signal the priorities to be reflected in the work programme for the next year and c) to assess if/how the Commission has followed up on the commitments made by the Commissioners-designate at their hearings.

In the case of CONT, the input should focus on:

- exchanges of views with Commissioner Hahn
- the implementation of the Commission Work Programme 2023
- the general state of play of legislation in the CONT field of competence
- expectations/requests for new initiatives in the remit of CONT until the end of the legislative term

**Decision:**

Coordinators agreed to send to the CONT secretariat possible input to the 2023 summary report by close of business on 13 April in view of discussion and endorsement of the CONT contribution at the Coordinators meeting on 24-25 April.

**9. Requests for expertise for the rest of the legislature**

In line with the practice of other policy-departments it is suggested that proposals for expertise should first be discussed in a technical meeting with policy advisers, the policy department and the CONT Secretariat. The outcome should then presented to Coordinators in the form of a consolidated list of proposals for further discussion and approval.

**Decision:**

Coordinators approved the updated process concerning expertise for the rest of the legislature with a view of deciding on a consolidated list of expertise at their meeting on 24-25 April.

**10. Feedback to ECA on two requests for CONT's opinion in relation to upcoming audits**

Two members of ECA have recently sent letters to the Chair asking for feedback from CONT in relation to upcoming audits:

- One requesting feedback for the ECA performance audit on the application of the Rule of law Conditionality Regulation.
- The other requesting feedback for the ECA audit concerning the recovery of irregular expenditure from beneficiaries of EU funds.

The first letter has also been sent to the Chair of the BUDG Committee.

Both letters indicate that the feed-back provided may be included in the audit reports ECA intends to publish at the end of the year.

It is a novelty that the CONT Committee is asked to contribute to a stakeholder consultation for an audit procedure.

**Decision:**

A majority of Coordinators wished to first clarify the procedure before replying in substance.

On 28 March, BUDG Coordinators have decided unanimously not to reply in substance on the letter regarding the application of the Rule of law Conditionality Regulation for which both committees are jointly responsible.

A total of 46 amendments have been tabled to the CONT opinion to ITRE and AFET/SEDE on the Commission proposal for a regulation establishing the European defence industry reinforcement through common procurement act (EDIRPA), including 18 tabled by the rapporteur.

On 1 December 2022, the Council adopted its general approach. On 18 January 2023, the rapporteurs from the AFET and ITRE joint committee published their draft report. EDIRPA is a short-term joint defence procurement instrument worth €500million. It seeks to address the most urgent and critical defence capability gaps and to incentivise Member States to procure defence products jointly.

The rapporteur welcomes the Commission's proposal, and concurs that without coordination and cooperation, increased Member State investments into defence risk to deepen the fragmentation of the European defence sector, to limit the potential for cooperation throughout the life cycle of the equipment, to intensify external dependencies and to hamper interoperability.

In this proposal for a CONT opinion, the rapporteur focuses on three main areas: the types of financing and the choice on their implementation methods, key elements of the definition of the Work Programme and the award criteria, and the protection of the financial interests of the Union, including enhancing the role of the Court of Auditors, OLAF and the EPPO.

CONT Members tabled 378 amendments to the draft report, resulting in 63 compromise amendments that cover the main areas of the report, including its political priorities and the role of the EU budget in assisting Member States in unforeseen situations, as well as the relevance of reporting on the performance of the Union budget's programmes for the discharge procedure. The shadow rapporteurs also discussed the situation concerning the rule of law in a number of Member States, which is deeply worrying in its own right and leads to serious losses for the Union budget, underlining that Union funds must not be used for anti-democratic activities or for strengthening authoritarianism.

The rapporteurs reiterate the need to step up the efforts in the fight against fraud both at Union and Member State level, in close cooperation with the EPPO and OLAF, and remark the need to better balance the further simplification of rules and procedures with better controls over the most repeated areas of irregular spending.

Mr Lenaers, as responsible for the MFF chapter of the 2021 discharge report, regrets that the Court has again issued an adverse opinion on the legality and regularity of the expenditure side of the budget, and notes with concern the overall error rate calculated by the Court of 3,0 %, which is 1,0 % point above the materiality threshold, noting that this is a deterioration in comparison with 2020, when the error rate was 2,7 %.

Ms Hohlmeier, as responsible for the RRF chapter of the 2021 discharge report, welcomes the RRF's initial contribution and its further potential to preventing a strong economic downturn following the COVID-19 pandemic, but is concerned by the findings of the Court in its first annual assessment of the RRF. The rapporteur notes the successful efforts of the Commission to raise funds on the financial markets to provide the financial means for the RRF, but is concerned by the rising interest rates and the resulting uncertain capacity to repay the loans and the risk this poses for the Union budget and Union policies. The Rapporteur also welcomes the recent steps made by the Commission to increase transparency, with the publication of the 100 largest beneficiaries and the interactive map showing Member States' projects funded by the RRF, and the adoption of a methodology for partial payments, that she considers however should still be improved.

On 13 October 2022, the European Court of Auditors (ECA) issued unqualified (“clean”) opinions on the reliability of the accounts and the legality and regularity of the underlying transactions for the financial year 2021 for the 8th, 9th, 10th and 11th European Development Funds (EDFs), as well as observed various matters needing improvement.

On 1 December 2022, in the framework of the 2021 discharge procedure, the CONT Committee held an exchange of views with Commissioner Urpilainen responsible for International Partnerships in the presence of ECA reporting member Baudilio Tomé Muguruza.

On 9 February 2023, during the consideration of the draft, the Rapporteur outlined the main points of his draft report and emphasised the following issues: (i) the adverse opinion of the Court of auditors on the legality and regularity of expenditure, which, with an estimated level of error of 4.6 %, surpassed the materiality threshold and which concern mainly recurring errors; (ii) the absence of reservations for 2021 due, inter alia, to a ‘*de minimis*’ threshold, taking away a relevant indicator for the EP’s scrutiny of the EDFs’ operations. In addition, he called for a multidimensional and holistic approach to fighting poverty and stressed the importance of investing in education and training.

On 30 January 2023, the Committee on Development (DEVE) delivered an opinion on the EDFs 2021 discharge exercise for which Mr Charles Goerens was Rapporteur.

35 amendments were tabled to the draft report. Amendments tabled concerned among others, the need for cooperation between the public and private sectors to address poverty, respect for the rule of law and the need to fight corruption. Amendments also specifically re-iterated the Court’s criticism on the study on the Residual Error Rate by the Commission.

Rapporteur and Shadow Rapporteurs agreed on three compromise amendments.

The Rapporteur is in favour of granting the Commission discharge in respect of the implementation of the budget of the 8th, 9th, 10th and 11th European Development Funds (EDFs).

For the 2021 discharge of the EU Agencies, the Rapporteurs tabled 34 draft reports, which were considered in Committee on 9 February 2023. It is to be noted, in particular, that the European Labour Authority is subject to discharge this year. A total of 359 amendments were tabled to the draft reports, of which 72 amendments to the

draft report on Frontex, showing that the interest on the latter is still significant. A total of 26 opinions from other committees were also received. ...

Amendments were related to gender and geographical balance, encouraging the agencies to pursue a better representation in particular among senior management, and to digitalisation, performance, and staff policy, among others.

In preparation for the vote in Committee, the Rapporteurs and Shadow Rapporteurs have worked on a number of compromise amendments that will be put to the vote, aimed at reaching political consensus on topics, and a clear, structured text in the final reports. The final reports will be voted in Plenary during the session of May.

The ECA President and reporting Member Tony Murphy will present the ECA Special Report on the Commission's Control System for the RRF. The Court chose as subtitle for the Report 'Assurance and accountability gap remains at EU level in the new delivery model, despite extensive work being planned'.

This audit report fits into a series of audits on the RRF performed by the Court that assess various elements of this new, performance based instrument that has a financial value of almost 70 % of the total value of the MFF 2021-2027.

The Court concludes that the Commission's control system, though extensive in its set-up as regards verification of milestones and targets, provides limited information at EU level that RRF funded investment projects comply with EU and national rules. The Court states that this impacts the assurance that the Commission can provide on the protection of the EU financial interests and results in an EU-level accountability gap.

The Court further concludes that the verifications that the Commission performs before payments are made to Member States are also extensive. The Court however observes that there were limitations in the documentation of these verifications, and that their scope and objectives at different stages of the preliminary assessment should be improved.

The Court made five recommendations to remedy the observed weaknesses. The Commission however rejects most recommendations, only fully accepting one. Most notably, the Commission contests that there is an assurance and accountability gap at EU level as regards compliance with EU and national rules, as the RRF Regulation in Article 8 stipulates that the RRF is managed under Direct Management, with the Member States as final beneficiaries, and the principal responsibility for compliance with the said rules resting with the Member States.

The CONT Rapporteur has prepared a Working Document on this Special Report that will be available in a draft version shortly before the meeting.

The Commission will be represented by Ms Céline Gauer (SG RECOVER) and Ms Bernadette Frederick (DG ECFIN). Members of the committees for Budgets (BUDG) and Economic and Monetary Affairs (ECON), and the special committee on the COVID-19 pandemic (COVI) have been invited to participate in the presentation.

The Members of the European Court of Auditors are appointed for a term of six years. In accordance with Article 286(2) of the TFEU the Council, after consulting the European Parliament, shall adopt the list of Members drawn up in accordance with the proposals made by each Member State.

Appointments to the ECA are submitted to Parliament's plenary on the basis of a report from CONT. The report takes into account the requirement of Article 286(1) of the TFEU: *"The Members of the Court of Auditors shall be chosen from among persons who belong or have belonged in their respective States to external audit bodies or who are especially qualified for this office. Their independence must be beyond doubt."*, as well as other considerations.

In Parliament, the procedure is defined in Rule 129 RoP. According to Rule 129 (1), "candidates nominated as Members of the Court of Auditors shall be invited to make a statement before the committee responsible and to answer questions put by members. The committee shall vote on each nomination separately by secret ballot."

In preparation for the hearing, the candidate has been asked to answer a questionnaire prepared by CONT.

The hearing is structured as follows:

- Opening of the hearing by the Chair;
- The candidate will give an opening statement (maximum of 8 minutes);
- The CONT Rapporteur and shadow-rapporteurs will put questions to the candidate using the ping-pong system;
- Other members will question the candidate (catch-the-eye if time permits);
- Concluding remarks by the Chair.

After the hearing, the committee will hold an evaluation of the candidate, if required and then proceed to vote on his appointment.

According to Rule 129 (1), the committee shall vote by secret ballot. Members shall indicate whether they give a favourable opinion, a negative opinion or abstain.

The format of reports on candidates for membership of the Court of Auditors is defined in Parliament's resolution of 4 February 2014, which implies that amendments cannot be tabled for this report.

The draft report will be finalised, according to the outcome of the evaluation and the vote in committee. The candidate's CV and the answers to the questionnaire are annexed to the report.

The report for plenary will state that Parliament delivers either a favourable or a negative opinion on the appointment of the candidate. The vote in Plenary is planned for March II (29 - 30 March). The draft report is available on the CONT website.

### 45. THE ANNUAL REPORT 2022 OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE (EPPO)

The European Chief Prosecutor, Ms Laura Kövesi, will give to the CONT and LIBE Members an update on the activities of the EPPO. In its 2022 annual report, the Office highlights that there is a clear focus on EU fraud affecting public revenue, in particular cross-border VAT fraud. By the end of 2022, the EPPO had 1117 active investigations with overall estimated damages of €14.1 billion, nearly half of which (47%) resulted from VAT fraud.

In 2022, the EPPO received and processed 3318 crime reports and opened 865 investigations. Moreover, judges granted the freezing of €359.1 million in EPPO investigations (compared to €147.3 million in 2021), which represents more than seven times the organisation's 2022 budget.

The report also highlights some of the key activities of EPPO in 2022, including Operation Admiral, where EPPO, in cooperation with law enforcement agencies of 14 EU Member States, carried out simultaneous investigative measures, including more than 200 searches, in relation to a complex VAT fraud scheme based on the sale of popular electronic goods.

In 2022, the EPPO's activity brought about a first positive evolution, with regard to the level of detection of fraud affecting the financial interests of the EU in some Member States. EPPO claims that even if a comparable dynamic could not be observed on the side of the institutions, bodies, offices and agencies of the European Union, there are now more investigations into EU fraud initiated in the 22 participating Member States than the historical average before the EPPO's establishment.

Ms Kövesi finally concludes remarking that the EPPO is far from having reached its full potential, and that for the EPPO to make a lasting difference, organisational and legal adjustments are needed. This includes, according to the European Chief Prosecutor, the revision of the EPPO Regulation, and the assignment to the EPPO cases of dedicated and specialised financial fraud investigators in all the participating Member States.

The reporting ECA Member, Ms Iliana Ivanova, will present her review on the adaptation of the cohesion rules to respond to COVID-19 to the members of the CONT Committee and invited members of the BUDG, REGI and COVI Committees.

As part of the wide range of actions taken by the EU to address the challenges presented by the COVID-19 pandemic, three initiatives, the Coronavirus Response Investment Initiative (CRII), the Coronavirus Response Investment Initiative Plus (CRII+) and the new budgetary instrument “Recovery Assistance for Cohesion and the Territories of Europe” (REACT-EU), were adopted in 2020 to adapt the Cohesion Policy rules for the 2014-2020 programme period. Based on these measures, existing funds under the cohesion policy were re-oriented and new funds made available in all EU countries and regions to tackle the crisis.



ECA assessed whether the Commission adapted well the 2014-2020 cohesion policy rules through CRII/CRII+ and REACT-EU to provide greater flexibility to Member States in using cohesion policy funds in response to the COVID-19 pandemic. The audit covers the ERDF, ESF and CF within cohesion policy.

The Court concluded that, in general, the Commission adapted well the 2014-2020 cohesion rules so that Member States could make use of cohesion funds more flexibly.

ECA recommends that the Commission:

1) analyses the appropriateness of cohesion policy as a budgetary crisis response tool, notably the impact of the use of cohesion policy as a short-term budgetary crisis response tool on the long-term objectives of the policy (by the end of 2024),

2) monitors closely REACT-EU absorption and, where necessary, provides targeted support with a focus on results so that the co-financed operations effectively contribute to the achievement of objectives and performance targets (immediately).

To date, 1 473 individuals and 205 entities appear on the EU-Russia sanctions lists. In addition, the EU has excluded Russia from public contracts and EU funding. The CONT members will hear from the European Commission what are the tools and mechanisms in place to protect the financial interests of the Union in the implementation of EU sanctions against Russia.
