

AMENDMENTS

The Committee on Culture and Education calls on the Committee on Civil Liberties, Justice and Home Affairs, as the committee responsible, to incorporate the following amendments in its report:

Amendment 1

Proposal for a decision Recital 1

Text proposed by the Commission

(1) Article 20(1) of the Treaty provides for citizenship of the Union as additional to national citizenship of the respective Member States, stipulating that every person holding the nationality of a Member State shall be a citizen of the Union. The second paragraph of Article 20 specifies that citizens of the Union shall enjoy the rights and be subject to the duties provided for in the Treaties, and that they shall have, inter alia, the right to move and reside freely within the territory of the Member States. The right of Union citizens to free movement and residence is further enshrined in Article 21 of the Treaty.

Amendment 2 Proposal for a decision Recital 1 a (new)

Text proposed by the Commission

Amendment

(1) Article 20(1) of the Treaty provides for citizenship of the Union as additional to, and not a replacement of, national citizenship of the respective Member States, stipulating that every person holding the nationality of a Member State shall be a citizen of the Union. The second paragraph of Article 20 specifies that citizens of the Union shall enjoy the rights and be subject to the duties provided for in the Treaties, and that they shall have, inter alia, the right to move and reside freely within the territory of the Member States. The right of Union citizens to free movement and residence is further enshrined in Article 21 of the Treaty.

Amendment

(1a) Citizens and the associations that represent them are central to the functioning of the Union, as provided for in Articles 10 and 11 of the Treaty on European Union, which underline the importance of all aspects of participatory democracy.

Amendment 3 Proposal for a decision Recital 1 b (new)

Text proposed by the Commission

Amendment

(1b) The essential rights of Union citizenship are also connected to the European dimension of education, in particular through the promotion of multilingualism and the mobility of students, teachers, persons undergoing vocational training and their instructors, as specified in Articles 165 and 166 of the Treaty on the Functioning of the European Union.

Amendment 4 Proposal for a decision Recital 1 c (new)

Text proposed by the Commission

Amendment

(1c) In the interest of its citizens, the Union should take the cultural dimension into account in all the measures it introduces, so as to encourage mutual respect between cultures, promote diversity, protect the common cultural heritage and improve knowledge of the history of the European peoples, as provided for in Article 167 of the Treaty on the Functioning of the European Union.

(2) The entry into force of the Lisbon Treaty strengthened the status of Union citizenship and complemented the rights

Text proposed by the Commission

(3) The rights inherent to citizenship of the Union are incorporated in the Charter of Fundamental Rights of the European Union. According to the Charter's Preamble, the Union 'places the individual at the heart of its activities, by establishing a citizenship of the Union and by creating an area of freedom, security and justice'. Chapter V of the Charter sets down "Citizens' rights", including, in its Article 45, the right of every citizen of the Union to move and reside freely within the territory of the Member States.

Amendment

(3) The rights inherent to citizenship of the Union are incorporated in the Charter of Fundamental Rights of the European Union. According to the Charter's Preamble, the Union 'places the individual at the heart of its activities, by establishing a citizenship of the Union and by creating an area of freedom, security and justice'. Chapter V of the Charter sets down "Citizens' rights", including, in its Article 45, the right of every citizen of the Union to move and reside freely within the territory of the Member States and, in its Article 41, the right to write to the institutions of the Union in one of the languages of the Treaties and to receive an answer in the same language.

Amendment 7 Proposal for a decision Recital 3 a (new)

Text proposed by the Commission

Amendment

(3a) As stated in the Charter's Preamble, the Union is founded on the indivisible, universal values of human dignity, freedom, equality and solidarity, which are of fundamental importance for the exercise of citizenship. The Union should also contribute to the preservation and development of those common values,

while respecting the diversity of the cultures and traditions of the peoples of Europe, and help to uphold freedom of expression and information, the right to education, the freedom of the arts and of research and academic freedom.

Amendment 8 Proposal for a decision Recital 3 b (new)

Text proposed by the Commission

Amendment

(3b) The UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions of 20 October 2005 (the Convention) provides that cultural diversity plays an important role in the full realisation of human rights and fundamental freedoms and in maintaining social cohesion. Under Article 10 of the Convention, the Member States and the Union are committed to encouraging and promoting understanding of the importance of the protection and promotion of the diversity of cultural expressions, inter alia, through educational programmes and programmes intended to raise public awareness.

Amendment 9 Proposal for a decision Recital 4 a (new)

Text proposed by the Commission

Amendment

(4a) Since it was set up, the Council of Europe has played a leading role in the educational and cultural domain by promoting and establishing European cultural networks and through intercultural dialogue and the promotion of linguistic diversity. The Union should therefore develop synergies with the Council of Europe's work in this field and, in particular, the recommendations

made in the Council of Europe's Charter on Education for Democratic Citizenship and Human Rights Education of May 2010 should be promoted in connection with a European Year of Citizens in 2013.

Amendment 10 Proposal for a decision Recital 6 a (new)

Text proposed by the Commission

Amendment

(6a) Since the Treaty of Maastricht, which specified the means whereby the Union could play a role in the fields of education, culture and youth policy, the main aim of the programmes set up by the Commission has been to encourage meetings and exchanges between citizens living in the Union and to promote dialogue and mutual understanding and respect. In the context of the European Year, those programmes should be developed to take account of the cultural and educational aspects of Union citizenship.

Amendment 11 Proposal for a decision Recital 6 b (new)

Text proposed by the Commission

Amendment

(6b) Education, provided it is accessible to all, plays a vitally important role in the formation of future citizens by enabling them to acquire a solid basis of general knowledge, including an informed understanding of European integration and of the history and cultures of the European peoples. In this respect civic education is essential as a means of enabling individuals to participate fully in democratic, social and cultural life and regard themselves as true citizens of the Union from as early an age as possible.

Amendment 12 Proposal for a decision Recital 6 c (new)

Text proposed by the Commission

Amendment

(6c) Non-formal and informal education play a vitally important role in both the teaching and the exercise of citizenship, as it promotes individual empowerment, solidarity and mutual understanding and strengthens social cohesion. The European Year of Citizens should be seen, therefore, as building on the European Year of Volunteering 2011. In this context, it is important to encourage recognition of the commitment of volunteers, to validate the skills and expertise acquired in this field and to remove obstacles relating to cross-border activities, including those involving third countries and their nationals, particularly those living in the Union. Obtaining recognition for European association status is also important and could, moreover, facilitate the development of cross-border projects.

Amendment

(6d) The exercise of citizenship is predicated on the full and unimpeded exercise of social, economic and cultural rights, and also requires the recognition of cultural diversity and the development of cultural activities in which all members of the public can take part, including the most vulnerable groups (such as people with disabilities, people of immigrant descent and people who are socially and economically disadvantaged).

Amendment 14 Proposal for a decision Recital 6 e (new)

Text proposed by the Commission

Amendment

(6e) Freedom of thought, expression and information, and media pluralism and independence, are essential principles for the exercise of citizenship. The communications policy of the Union institutions, and in particular that of the Commission, should take greater account of the need to inform, and be understood by, as many people as possible. The Commission should liaise more closely with representatives of local, regional and national authorities, the information offices of the Union institutions in the Member States, representatives of civil society and the media, including local and regional media, to help increase citizens' understanding of the impact of European policies on national and local policies and to enable them to assume ownership of such policies.

Proposal for a decision Recital 6 f (new)

Text proposed by the Commission

Amendment

(6f) Since 1979, when the first direct elections were held, the European Parliament has acted as a direct interface between citizens and the Union. The Members of the European Parliament have played a crucial role in communicating the rights and benefits of Union citizenship and in bringing citizens' concerns to the fore in the formulation of policy.

Text proposed by the Commission

(7) In particular, free movement and workers' mobility help addressing the consequences of demographic change on the labour market, while also increasing the employability of people and improving the competitiveness of European industries. At the same time, free movement either enables, as an essential condition, or stimulates the exercise by citizens of a broad range of rights available to them under Union law, such as their rights as consumers to access goods and services or their rights as passengers and tourists. Facilitating free movement has therefore the potential to enhance citizens' possibilities to fully benefit from the single market, whilst being a key driver for growth.

Aside from an uncertainty over the advantages of being mobile, Union citizens perceive too many practical obstacles with regard to living *and* working elsewhere in the Union.

(9) Despite the fact that the right to free movement and residence is firmly anchored in primary Union law and substantially developed in secondary law, a gap still remains between the applicable legal rules and the reality confronting citizens when they seek to exercise this right in practice. Aside from an uncertainty over the advantages of being mobile, Union citizens perceive too many practical obstacles with regard to living, working and studying elsewhere in the Union. This is particularly apparent in those regions close to the internal borders, where it is especially common for people to live in a different Member States from the one in which they work. With a view to strengthening economic and social cohesion, information about "crossborder jobs'' -therefore needs to be made more transparent and accessible. Facilitating access, through more regular arrangements for exchanging information between Member States in ways that are clearer and more easily understandable to job seekers, is also urgently necessary in

relation to the recruitment of skilled workers.

Amendment 19 Proposal for a decision Recital 9 a (new)

Text proposed by the Commission

Amendment

(9a) The mobility of students and research workers is strongly encouraged, inter alia, under the Lifelong Learning programme. Serious obstacles to mobility remain, however, particularly in terms of social rights, financial resources and sociocultural stereotyping, and the mutual recognition of diplomas and qualifications is still a work in progress.

Amendment 20 Proposal for a decision Recital 9 b (new)

Text proposed by the Commission

Amendment

(9b) Freedom of movement for those working in the cultural sector, including artists, plays a decisive role in the discovery of different forms of cultural expression and mutual understanding and respect. The exercise of that freedom should be generally facilitated, therefore, for example by introducing ad hoc procedures and working towards recognition at European level of a statute for artists.

(15) Awareness of the electoral rights guaranteed to Union citizens is of primary importance in this respect. Union citizens should be fully aware of their right to vote and stand as candidates in the municipal and European Parliament elections in their Member State of residence. At the same time, political participation can contribute to the integration of Union citizens into the society of their chosen Member States of residence.

Amendment

(15) Awareness of the electoral rights guaranteed to Union citizens is of primary importance in this respect. Union citizens should be fully aware of their right to vote and stand as candidates in the municipal and European Parliament elections in their Member State of residence. From childhood onwards, they should learn about the history of Europe and its peoples and about the Union institutions, to enable them to play a full role in participatory European processes. At the same time, political participation can contribute to the integration of Union citizens into the society of their chosen Member States of residence.

Text proposed by the Commission

(16) Enhanced citizens' awareness of the benefits of these rights for them individually and for society can also contribute to a stronger sense of belonging *and adherence* to the Union.

In this context, the European Year shall focus, among others, on the opportunities for civic and political participation, access to rights, exchanges and mobility available to all Union citizens, including in particular students, workers, consumers, and providers of goods and services, whatever the Member State in which they live.
