1. Points system for appointing rapporteurs for reports & opinions

2. Chair's announcements

The Coordinators heard the Chair:

- **Report on a series of actions undertaken with respect to Covid-19 and the CULT sectors following the last CULT Coordinators' meeting. These included detailed letters to the Commissioners and two press releases. At the request of Ms Yenbou, it was agreed that all the letters and press releases would be sent to all CULT Members and that, henceforth, all such communications would be emailed to all CULT Members for information.**
- **Explain that the CULT committee meeting on 4 May 2020 would be devoted entirely to an exchange of views with Commissioners Gabriel and Breton and that guidelines had been sent to all Members. She reminded political groups of the need to follow the guidelines scrupulously. She also explained that no votes would take place on 4 May, but would almost certainly need to be held before the end of May when the plenary voting system - adapted for committees - would have to be used. A briefing for political group staff will be organised to explain the system.**
- **Refer to the note on the LUX prize and the changes made this year owing to the exceptional situation.**
- **Remind political groups to communicate the names of Rapporteurs and Shadows to the secretariat without delay once a decision on report/opinion allocation has been made so as not to slow down committee business.**
- **Report that the former Member of the CULT Committee, Krystyna Lybacka, had passed away.**
