- heard the Chair (i) report that Members had received an email from a school in Germany complaining about the tight deadline for applying for Erasmus+ accreditation and (ii) provide a detailed report on the situation and agreed to a) write a reply to the email explaining the full facts and promising to explore with the Commission the possibility for enabling an ongoing (i.e. non deadline-limited) accreditation process and b) to write to the Commission to that effect, pointing out, as well, that there is a need for flexibility for ongoing projects paused owing to Covid-19 to continue into 2021 and reiterating its demand for the Commission to put in place contingency measures given the inevitable late adoption of the 2021-2027 Erasmus+ programme;
- heard the Chair announce that, owing to the Covid-19 instructions, it is sadly not possible to host the European Youth Capital award ceremony on the EP premises.

- **relay concerns from Hungarian NGOs alleging that Erasmus+ funds in Hungary are available only to organisations that comply with the ‘Transparency Law’, which was the subject of a CJEU ruling (Case C-78/18) on 18 June 2020, and request that the CULT Chair write to the Commission to investigate the matter;**
- **refer to the June 2020 Venice Commission Opinion on recent amendments to the legislation on education in minority languages in Latvia and convey concern at the findings, proposing that the Chair write a letter to the Latvian authorities;**

**Owing to the late submission of the three AOB points and the need for a sound evidence base before deciding on a course of action, Coordinators decided to ask the CULT secretariat to obtain information and to revisit the questions at the next meeting.**
