 - **2 July - at 10:00:** deadline for resubmission of PPPAs as budgetary amendments to the CULT Committee (*English only*)
 - **12-13 July:** Vote on budgetary amendments in CULT, including PPPAs. The adopted amendments will be put to the vote in BUDG.
