The Coordinators:

- heard the Chair inform them about the legal prosecution of the international historical educational charitable and human-rights society *International Memorial* in Russia, and decided to entrust the Chair to draft an open letter addressed to the Russian authorities, expressing the CULT Committee's support for *International Memorial*;
- heard the Chair inform them about the availability of English and French translations of a letter received from a Polish trade-union representative regarding the politicisation of the Polish school system, and decided to entrust the Chair to contact the European Commission with a view for the Commission to assess the points of complaint put forward by the petitioner;
- heard the Chair inform them about the PETI draft motion for a resolution on *A new aid mobility scheme for EU students at UK universities* and a letter sent by her on behalf of CULT to President Sassoli in that regard; repudiated the PETI draft as inadequate and detrimental to the EP's position during and in the aftermath of the Brexit negotiations; and decided to request the CoP via the respective political groups to abstain from putting that draft motion for a resolution on the agenda of the December plenary;
- heard the Chair inform them about the EMPL draft motion for a resolution on *Empowering European youth: post-pandemic employment and social recovery*, and that an agreement has been found with EMPL avoiding potential conflicts of competence between the CULT and EMPL committees;
- heard the Chair inform them about the draft programme of the EMPL hearing on *The importance of lifelong learning, digital education and active ageing as tools to increase employability, active participation in the society*

as well as to battle social exclusion scheduled to take place on 9 December 2021, for which CULT had nominated one expert;
