2. Chair's announcements

The Coordinators:

- took note of the final draft programme and the final list of participants of the forthcoming CULT Mission to Kaunas, Lithuania, from 18-20 July 2022;
- heard the Chair report that a formal request has been made by CULT to draft an INI report on "The System of European Schools";
- heard the Chair recall the CULT hearing/special event on 5 December 2022, in collaboration with the Czech presidency, on the occasion of the European Year of Youth, and that the event will highlight best practices in the teaching of arts in schools from different Member States; heard Michaela Šojdřová indicate that an expert for the hearing from Czechia has been identified, and were solicited to identify another three to four experts from other Member States; were informed that the musical performances, following the hearing, will be by musicians from schools, and heard the suggestion to hold the performances in the Espace Yehudi Menuhin; agreed to the deadline of 9 September 2022 for nominations and instructed the Chair to send a letter to the EP President to ask for her support for the event and to authorise the use of the Yehudi space for the musical performance.
