## 2. Chair's announcements

### **The Coordinators:**

- **heard the Chair 1) brand the insufficient presence of Committee Members in the latest CULT meetings, 2) urge the political groups to guarantee adequate presence in future meetings, and 3) reserve the right to reduce the Committee's future activities merely to core business should no adequate presence of Members be ensured;**
- **heard the Chair report on CULT missions in 2023 and the re-distribution of mission places in line with the CULT Quality Charter, with the ID Group losing two places in 2023 due to late cancellations of two of their Members registered for missions having taken place in 2022; decided to change the dates for the planned missions to Poland (now: turquoise week in May 2023) and Timisoara (now: turquoise week in April 2023), and endorsed the deadline of Friday, 15 December 2022, 12:00, for the political groups to send updated information on which of their Members are planning to take part in the 2023 CULT;**
- **heard the Chair report on the current state of the EP's scrutiny of the EU-UK Trade and Cooperation Agreement (TCA), with the AFET and INTA committees being mainly responsible;**
- **heard the Chair present the current state of play of the European Media Freedom Act proposal at the EP, with the LIBE Committee having requested association pursuant to Rule 58, the IMCO Committee pursuant to Rule 57 of the EP's RoP; entrusted the Chair to continue negotiations with these two committees in order to defend CULT's interests and CULT's exclusive competence on this dossier;**
- **heard the Chair inform them about a discussion on a revision of Annex VI of the EP's RoP being envisaged at CCC level in the forthcoming months, with more information to follow in due time;**
- **heard the Chair report on an invitation to the 10th meeting of the Commission's Expert Group on "Return of cultural objects" scheduled for 8 December 2022, and decided to entrust the current CULT observers in the Commission's Cultural Heritage Expert Group to represent the Committee at that occasion.**
