  - **taking measures to ensure a strong presence and active involvement of CULT Members at the upcoming European Youth Event (EYE) from 9 to 10 June in Strasbourg and at future EYEs;**
  - **taking measures to ensure closer cooperation with DG COMM and in particular its “Youth Outreach” unit;**
  - **envisioning more systematic CULT Committee missions to the European Youth Capitals, starting with a visit to Lublin, the 2023 European Youth Capital, as part of the forthcoming CULT mission to Poland; and**
  - **taking measures to ensure proper coordination with other EU institutions to mainstream the youth perspective across policy fields and promote an active participation of youth in building the future of Europe.**
