- heard Mr Niyazi Kızılyürek, the head of delegation who had replaced the Chair at this occasion, report on the recent CULT mission to Scotland;
- heard the Chair report about the dedicated CULT session *Engaged4YOUth* in the context of the recent EYE2023 event in Strasbourg on 9 and 10 June 2023;
- heard the Chair recall that in order for the CULT motion for a resolution on the new European strategy for a better internet for kids (BIK+) to be dealt with in the September plenary session, the Coordinators need to actively advocate for this agenda item to be put on the agenda;
- heard the Chair inform them that the portfolio of former Commissioner Gabriel is currently managed by Commission Vice-President Schinas, but that a new Bulgarian Commissioner nomination is imminent, which would necessitate a formal EP hearing;
- heard the Chair inform them that the planned CULT ICM on 27 and 28 November 2023 has not yet been confirmed by the COP, given that too many ICMs have been proposed for that week by different EP committees; decided to entrust the Chair to inform the CCC that CULT would abstain from organising an ICM in 2023 should the planned date of 27/28 November not be authorised, considering that the CULT agenda for the remainder of 2023 does not allow for a change of dates;
- heard the Chair report on a letter received from the Hungarian Teachers' Union, branding attempts of the Hungarian government to further politicize the education system in Hungary, and decided to entrust the Chair to prepare a draft reply, expressing the Committee's dedication to help upholding free and independent education systems throughout Europe;
- heard the Chair inform them that no nominations for potential CULT representatives in the new Policy Coherence for Development (PCD) network organised by the DEVE Committee have been received from the political groups so far.
