- **heard the Chair inform them that the planned CULT interparliamentary committee meeting on European citizenship education, scheduled to take place on 27 and 28 November 2023, has finally been authorised by the CoP, and that the Secretariat has already started preparatory work;**
- **heard the Chair a) inform them about the European Gender Equality Week 2023 taking place in the last week of October, and b) invite political groups to send potential ideas for CULT activities during that week to the CULT Secretariat by 31 August 2023 at the latest, provided adequate attendance of Members can be ensured for any such activity;**
- **heard the Chair inform them about her intention to organise another joint meeting with representatives of the Ukrainian Rada, and decided to consider potential topics for such an exchange at one of their next meetings;**
- **heard the Chair report about the state of preparation of the CULT-supported BRUMUN event of the European School Brussels II from 16-18 October 2023, and decided to entrust the Chair to express the Committee's support vis-à-vis the EP administration for all fees to be waived for this event;**
- **heard the Chair inform them that for the planned CULT mission to Veszprém (Hungary), only one CULT Member has registered so far; agreed on the deadline of 20 July 2023 for further nominations to be sent to the CULT Secretariat, with the EPP, S&D and ID groups offering the places at their disposal to other groups in case they do not have enough volunteers in their ranks; and decided to cancel this mission if less than three Members will have declared their interest in participating in this mission by 20 July 2023.**
