- heard the Chair recall the new EP rules on integrity and transparency, especially regarding the declaration of potential conflicts of interest, which to fill out falls into the sole responsibility of Rapporteurs and Shadow Rapporteurs, and decided that the political groups should inform the CULT Secretariat about whether this declaration has been filled in the email notifying the Secretariat about which Member has been appointed as Rapporteur/Shadow Rapporteur for a particular file;
- heard the Chair inform them that a social conditionality clause has been incorporated in the revised Financial Regulation, subject to the inclusion of that clause in the respective sectoral legal base, and that a presentation by the Commission on the potential application of this clause to the CULT MFF programmes has been scheduled for the Coordinators' meeting on 13 February 2024;
- heard the Chair inform them about ITRE's request to establish a more permanent EP group on the Internet Governance Forum, and entrusted the Chair to co-sign a letter addressed to the EP President to that effect on behalf of the CULT Committee;
- heard the Chair invite CULT Members to take part in a planned joint BUDG-CULT meeting on the financing of the Erasmus+ programme, scheduled to take place in the afternoon of 14 February 2024, and agreed on a deadline of Wednesday, 24 January 2024, 12:00, for the political groups to communicate the names of their Members intending to participate in that joint meeting to the CULT Secretariat.
