### 3. Chair's announcements

#### The Coordinators:

- heard the Chair inform them that the dates for the CULT meetings in the new term have not yet been confirmed by the relevant EP services, and expressed their wish for the constituent meeting of the new Committee to be held on either a Monday or Tuesday;
- heard the Chair inform them that during the upcoming break, the Secretariat will update the CULT Quality Charter with additional Coordinators' decisions taken during the current term that have complemented the Charter so that a revised Quality Charter can be presented to the newly constituted Committee in autumn, potentially including also a set of deadlines for committee procedures (including the tabling of amendments and the sending of voting lists) and good practices for the drafting of compromise amendments;
- heard the Chair emphasize the importance of the CULT political priorities 2019-2024 for the work of the Committee during the 9<sup>th</sup> legislature and strongly recommend the continued use of this instrument also in the next term, as it has proven extremely helpful for streamlining the work of the Committee, including for the decisions on own-initiative reports, hearings, workshops and studies;
- heard the Chair inform them on the note received from the EP's Legal Service on the ECJ ruling on the "European Superleague", expressed their disappointment about the lack of detail of that note, and decided to request an additional analysis from the relevant EP research services.
