The Coordinators:

- heard the Chair remind them again about the importance of completing the DACI immediately and the need of sending an email, including the link to the completed declaration, when communicating the name of the rapporteur or shadow rapporteur to the CULT secretariat;
- heard the Chair report back about the Committee visit to ARTE premises during a plenary session in Strasbourg on 18 December 2024 and thanked all the MEPs who joined the Chair in this visit and to the secretariat for organising it together with ARTE;
- heard the Chair remind them about the nominations of shadow rapporteurs for several files or fields where Standing rapporteurs were already nominated and encouraged them to nominate a shadow as quickly as possible so that activities on the various fields can start with the full group of interested Members;
- heard the Chair report back on EMFA group and its constitutive meeting of 22 January 2025 in Strasbourg where the functioning and working methods as well as the working programme were discussed; the minutes from the meeting will be sent to the members of WG and to the Coordinators shortly;
- heard the Chair refer to the Extraordinary Conference of Committee Chairs with the Commission's Executive Vice Presidents happening on 29 January 2025 and her intervention in this meeting which will be based on the CULT political priorities and the evaluation meetings CULT has had on the hearings of the Commissioners-designate and her intention to raise once more the question of the portfolio title for Ms Minzatu, and also to ask about the progress the Youth Policy Dialogues are making and her referring to the next generation of MFF programmes under CULT committee remit;
- heard the Chair inform them about a letter from all EU Ministers of Culture that was sent to Commissioners Virkkunen, Micallef and Serafin on 14 January, as it is of a big relevance for the CULT committee to know how the Member States see the future of the Creative Europe Programme for the CULT committee deliberations on the matter and the appraisal of the future Commission proposal.
