Linda McAvan introduced the subject

Pedro Silva Pereira, Rapporteur on Financing for Development and Chair of the Hearing welcomed the guest speakers and opened the Hearing.

First Panel: Financing for Development - a "To do list for the EU"

Neven Mimica, European Commissioner for International Cooperation and Development presented and commented upon the main proposals in the Commission communication "A Global Partnership for Poverty Eradication and Sustainable Development after 2015". He stressed, in particular, the importance of the means of implementation, global partnerships, domestic mobilization of resources, fight against illicit financial flows, public - private partnerships, transparency and effective monitoring mechanisms.

Jesse Griffiths, Director of the European Network on Debt and Development (Eurodad) called for an agreement in the Financing for Development conference in Addis Ababa in July 2015 on the creation of an intergovernmental body for international tax cooperation within the UN system. He warned of multiple risks associated with the use of public funds for leveraging private capital in the pursuit of development and drew attention to the need to prevent excessive debt burdens of developing countries and for a permanent framework for dealing with such debt burdens when they occur. Mr Griffiths called upon the EU to re-confirm and honour the commitment to give 0,7 % of the Gross National Income in Official Development Assistance. He criticized the strategy and negotiation approach outlined in the Commission communication.

Chris West, Director of the Shell Foundation, Member of the Board of the Overseas Development Institute gave a business perspective, calling for the use of public money to make private investments less risky. This could not least open important possibilities for innovation, Mr West argued.

**Second panel: The global development financing landscape - who can contribute what?**

Gail Hurley, UNDP's team on the post-2015 development agenda gave further insights into the preparatory process for the Addis Ababa conference and the ongoing negotiations in New York. The Conference would be an extremely important occasion to reinvigorate aid (quantitatively and qualitatively). She pointed to the complexity of the issues of private/public financing, illicit financial flows and technology transfers. Ms Hurley also highlighted the importance of agreeing upon and putting in place good follow-up mechanisms.

James Zhan, Director, Enterprise and Investment, UNCTAD, presented an Action Plan for investments in the Sustainable Development Goals included in UNCTAD's 2014 World Investment Report prepared under his leadership. This Action Plan included estimated figures for the overall as well as for sectorial investment needs. Investments could be channelled into Sustainable Development Goals sectors through six action packages focusing on investment promotion strategies, incentives, regional cooperation, new forms of partnerships, innovative financing and indicators and business education.
