Coordinators' meeting of 14 June 2022
Coordinators' decisions and recommendations

1. New INIs

Decision:

With the upcoming adoption in plenary of the INI on food security, one slot for a new INI will soon become available. A second slot for a new INI will become available once the INI on 'The future European Financial Architecture for Development' is adopted in plenary in October (TBC).

On the assumption that DROI Coordinators would decide to request authorisation to draw-up an INI on 'Human rights violations by mining companies worldwide', the decision was made to request either the application of rule 58 to the DROI report or to propose an alternative DEVE proposal to the CCC on the 'Extractive industries: Promoting development through responsible business practices in extractive industries in the context of the green and digital transition'. As DROI Coordinators decided to request INIs on different topics, the authorisation process for a DEVE INI on extractive industries will be launched.

A discussion on future INIs should take place at the next DEVE Coordinators' meeting to agree on one more INI which could be requested in advance. Work could then start as soon as the slot becomes free. It is recalled that in the second half of a parliamentary term, each parliamentary committee may simultaneously draft up to three own-initiative reports only. Political groups will be requested to submit a limited number of proposals for a decision to be taken after the summer break.

2. Appointment of rapporteurs for opinions

i) Revision of the Multiannual Financial Framework

Decision: Opinion attributed to RENEW for 1 point.

ii) Council decision on the conclusion of the Voluntary Partnership Agreement between the European Union and the Co-operative Republic of Guyana on forest law enforcement, governance and trade in timber products to the European Union

Decision: Opinion attributed to the Greens for 1 point.

iii) EU strategy for sustainable and circular textiles

Decision: Opinion attributed to EPP for 1 point

iv) Motion for a resolution under Rule 143 on poliomyelitis eradication

Decision: No follow up action

3. Programme of missions for the second half of the year

Decision:

- For the September Green Week, political groups were requested to send, by Friday 1 July, the names of Members participating in the DEVE mission to Indonesia and the FEMM-DEVE mission to Ethiopia.
- For the November DEVE mission to Nigeria, Members were informed that a security assessment would have to be carried out as it is a high risk destination (level 5), which might impact on the preparation of the mission.

4. Appointment of moderators for the hearings to be organised in the second half of the year

Decision:

- Education in emergencies and protracted crises: providing access to education and training for young people: the moderation of the hearing is attributed to György Hölvényi (EPP) in his capacity as Standing Rapporteur for education.
- The implementation of NDICI-Global Europe: how to involve local and regional authorities and communities: the moderation of the hearing will be shared between S&D and Renew.

5. Nomination of candidates for the 2022 North-South Prize of the Council of Europe (finalised by written procedure)

Decision:

The two DEVE nominees for the North-South prize are Vandana Shiva (for the South) and Olivier De Schutter (for the North). These two names will be communicated to the EP President, who will inform the North South Centre.

6. Appointment of a Member responsible for gender mainstreaming (finalised by written procedure)

Decision: The position will be held by Soraya Rodriguez Ramos (RENEW).

7. Requests from groups (finalised by written procedure)

Decision:

- Organise an exchange of views on the situation in Ethiopia at one of the upcoming DEVE meetings (possibly with AFET).
- Organise an exchange of views on humanitarian assistance to Ukraine at one of the upcoming DEVE meetings (possibly with AFET).
- Organise an exchange of views on the impact of the war in Ukraine on access to energy in developing countries at one of the upcoming DEVE meetings.

Coordinators' decisions and recommendations

1. New INIs

Decision:

- The request for authorisation of the proposed INI on 'Extractive industries: Promoting development through responsible business practices in extractive industries in the context of the green and digital transition' will be prepared. The report is attributed to RENEW for two points.
- With a view to taking an early decision on the next topic, political groups are requested to send a limited number of proposals by Wednesday 14 September.

2. Appointment of rapporteurs for opinions

i. Opinion on AGRI report on 'Ensuring food security and long term resilience of the EU agriculture'

Decision: The opinion is attributed to RENEW for one point.

ii. 2021 EU budget and EDF discharges (CONT)

Decision: The decision is postponed to the next meeting.

3. DEVE's participation in the European Gender Equality Week

Decision: DEVE will organise an exchange of views on gender on 26 October as part of the third edition of the European Gender Equality Week. The exchange of views will be organised with the involvement of the DEVE gender focal point.

4. Programme of missions for the second half of the year

Decision: In view of the alarming security situation, the mission to Nigeria is postponed to a later date and replaced by a mission to Liberia, which was already chosen as a back-up option. A mission to Nigeria will be included in the programme of missions for the first half of 2023.

5. Programme of committee travel activities in the first half 2023

Decision: Political groups are requested to send a limited number of proposals by 8 September, with a view to a decision being taken by written procedure. Three DEVE missions could be organised in the first half of 2023 (February, April and May).

6. Programme of public hearings in the first half of 2023

Decision: Political groups are requested to send a limited number of proposals by 8

September, with a view to a decision being taken by written procedure. Two DEVE public hearings could be organised in the first half of 2023.

7. European Development Days 2023

Decision: An event at the European Development Days will be included in the planning of missions and hearings for the first half of 2023.

8. Programme of activities with national parliaments

Decision: No activity with national parliaments will be organised in the first half of 2023.

9. NDICI-Global Europe regulation: evaluation of scrutiny modalities and HLGD exercise and way forward

Decision: Follow-up coordinators discussions, in DEVE and jointly with AFET, will be organised to take stock of the process so far and confirm the modalities for the November High Level Geopolitical Dialogue.

10. Request from the RENEW group on the SDGs

Decision: The principle of preparing an annual joint report on the implementation and delivery of the SDGs is agreed. However, further consultations are needed to examine the different options for an 'hors quota' report on SDGs. The ENVI Secretariat will also be contacted.
