##### **A. Modalities of DROI Working Group on the thematic programme on Human Rights and Democracy of Global Europe**

With regards to its composition, it was proposed that the Working Group be composed of DROI Coordinators and chaired by DROI Chair. Coordinators could also delegate this role, on a permanent or ad-hoc basis, to another DROI Member.

Coordinators were invited to reflect on the suggested recommendations to be presented by DROI Chair at the HL geopolitical dialogue of 15 June.

**I. Decisions**

**A. Annual Report on human rights and democracy in the world and the European Union's policy on the matter**

**Decisions:** Coordinators decided to assign the report to the Renew Europe group for 3 points and to align the “year of reference” of DROI annual report with AFET and SEDE’s annual reports as it follows: “*Human Rights and Democracy in the world and the European Union’s policy on the matter - annual report 2021*”. Any further clarification needed will be provided subsequently by the secretariat.

**B. Own-Initiative Report on the protection of journalists around the world and the European Union's policy on the matter (EPP proposal)**

**Decision:** Coordinators decided to endorse the EPP’s proposal for 3 points.

**C. Legislative opinion(s)**

**1. European Commission Proposal for a new GSP (Generalised scheme of preferences) Regulation**

**Decision:** Coordinators decided to assign the opinion to the S&D group for 3 points and to request an opinion to the INTA report, once this is procedurally possible. The precise nature of DROI’s request and the type of cooperation sought with INTA would only be determined once the referral arrives.

## 2. **European Commission proposal for a Corporate Sustainability Reporting Directive (CSRD)**

**Decision:** Coordinators decided that DROI would request an opinion on the Commission proposal for a Corporate Sustainability Reporting Directive. A rapporteur for 3 points should be appointed at a future meeting, after the respective endorsement of this decision by the AFET committee.

## II. **Any other business**

### 1. **DROI Delegations**

#### **Decisions:**

- Coordinators took a principled decision to request to join the planned **AFET mission to the United Nations Headquarters** (New York City) in the green week of November (1 - 5 November). The number of DROI members joining the delegation will be decided later.
- Coordinators took a decision regarding a possible delegation to Afghanistan. The Secretariat is willing to provide additional information upon request.

### 2. **Requests for exchanges of views**

#### **Request by the Greens/EFA group to hold an exchange of views in relation to the Berlin Conference on Libya on 23 June**

**Decision:** in view of the urgency of the request, Coordinators decided to hold an exchange of views on this matter, in association with the DEVE committee.

#### **Request by the S&D group to hold an exchange of views to follow up the urgency resolution on Kazakhstan**

**Decision:** Coordinators decided that this proposal would be considered, along with the other groups' proposals, at the discussion of the strategic orientation for DROI activities for the 2nd half of 2021, which is foreseen to take place at the next DROI Coordinators meeting of 13 July.

#### **Request by the ID group to hold an exchange of views on the situation in Ukraine**

**Decision:** Coordinators decided that this proposal would be considered, along with the other groups' proposals, at the discussion of the strategic orientation for DROI activities for the 2nd

half of 2021, which is foreseen to take place at the next DROI Coordinators meeting of 13 July.

### **Request by the Left group to follow up on the trial for murder of Berta Caceres in Honduras**

**Decision:** Coordinators decided that this proposal would be considered, along with the other groups' proposals, at the discussion of the strategic orientation for DROI activities for the 2nd half of 2021, which is foreseen to take place at the next DROI Coordinators meeting of 13 July.

### **3. Communicating DROI work**

**Decision:** Coordinators took note of the request by the Greens/EFA group to improve the communication of DROI's work in general but in particular towards the Council's Working Party on Human Rights (COHOM), national parliaments, and human rights organisations and decided to invite a representative of European Parliament's Directorate-General on Communication to discuss this matter and possible improvements to communication tools (e.g. research tool for urgency resolutions).
