# Extraordinary Coordinators' Meeting Final Decisions

4 October 2021

## I. Decisions

Coordinators held an exchange of views on the Conference of Presidents decision on **the programme of Committee missions this year**, in particular the decision to limit the membership of all missions to the U.S. during the November green week to 7 Members. AFET-DROI mission to the UN general Assembly would therefore be composed of 7 Members plus AFET and DROI Chairs, with the following distribution of places according to rolling d'Hondt: 3 EPP, 1 S&D, 1 Renew, 1 ID, 1 ECR. Coordinators considered that this decision would substantially weaken the DROI component of the programme and that the mission to the UN General Assembly would not be comparable in scope to other Committees' missions to the US. A letter will be sent to the CoP asking for the extension of the joint AFET-DROI mission to the UNGA to 11 Members as originally requested.

### A. DROI travel activities for first half of 2022

**Decision:** The Coordinators took a decision of travel activities for the first half of 2022, with a view to be endorsed by the AFET coordinators at their meeting of 6 October. Coordinators agreed on the following missions:

#### **1) The Hague, the International Criminal Court (ICC) - possibly week 8 (21-25 February) or week 21 (23-27 May)**

A workshop on the ICC since its foundation and possible scenarios for the future has been scheduled for the meeting of 28 October 2021 and the new ICC Prosecutor was invited for one of the DROI meetings of 2021. The visit to the ICC would complement all the work done by DROI in this area.

Coordinators also recalled their earlier decision to send a delegation to **Geneva** in order to follow the activities of the **UN Human Rights Council** and meet with Geneva-based relevant international organisations during one of the UNHRC sessions.

The visits to The Hague and Geneva could be combined and organised during the same week.

#### **2) Turkey - (Istanbul, Ankara and Gaziantep) - week 15 (11-15 April)**

Explanation: In recent years, the country has seen a severe backsliding on fundamental freedoms and the continued erosion of democracy and the rule of law, contrary to what should be expected from a candidate for EU membership. The shrinking space of civil society organisations, the never-ending impact of the restrictive measures of the state of emergency, the lack of independence of the judiciary, the abuse of anti-terror provisions to silence any critical voice, the backlash against gender equality, the crackdown on opposition parties are just a few examples revealing the dire human rights situation in the country. A visit of the

Subcommittee on human rights could be helpful to bring attention to this overall situation and, to some specific cases, bringing support to Turkey's civil society and Turkish society, which remains strongly pro-European and pro-democracy. It would also help to place the human rights dimension and the situation of fundamental freedoms and the rule of law at the core of the relations between the EU and Turkey, as too frequently in the recent past, other EU institutions such as the Council has tended to a more pragmatic, interest-driven policy towards the country. The visit will also allow for the possibility of addressing migration aspects in the context of DROI work on the protection of the international human rights framework and the EU external migration policy.

### **3) Tunisia (Tunis), possibly week 21 (23-27 May) or week 8 (21-25 February)**

Explanation: The visit to Tunisia is a concrete follow up to the recent exchange of views on the recent developments in the field of fundamental freedoms and the rule of law in the country. Key objectives of the DROI visit is to meet with a broad range of officials, parliamentarians and civil society representatives to have a better sense of the current human rights and democracy challenges in Tunisia and explore and seek the best ways of cooperation in this area.

## **B. DROI hearings during first half of 2022**

**Decision:** The Coordinators agreed on the following hearings for the first half of 2022, with a view of them to be endorsed by AFET Coordinators at their meeting of 6 October:

**1) Improving the protection and lives of people with disability as well as dependent elderly and other dependent persons**

**2) Business in Disputed Territories**

In addition, Coordinators decided to follow up its previous decisions to hold hearings on **3) Human Rights and Artificial Intelligence** and **4) the Death Penalty** but which could not take place during the Covid-19 pandemic.

## **C. DROI programme with National Parliaments during the first half of 2022**

The Coordinators were invited to reflect on the opportunity to organise an ICM during the first half of 2022 and on the possible topic of an inter-parliamentary meeting.

## **D. Pending files**

**1. European Commission proposal for a Corporate Sustainability Reporting Directive (CSRD)**

**Decision:** The file was allocated to Renew for 1 point.

**2. Urgent request on external expertise**

a) “Commission proposal on sustainable corporate governance: analysis from a human rights perspective

b) “Commission proposal on reforming the Generalised System of Preferences: analysis of human rights incentives and conditionalities”

**Decision**: Coordinators agreed to request the two briefings.
