DROI COORDINATORS' MEETING
17 March 2022, 10.30 - 12.00
Final Decisions

I. Programme of DROI activities for the second half of 2022 (July-December)

A. DROI travel activities for the second half of 2022

Decisions: The Coordinators decided to request authorisation for the following missions during the second half 2022:

- 1) **Kazakhstan** (Nur Sultan and Almaty), week 34, from 22 to 24 August 2022, 3 days, including journey time.
- 2) **Great Lakes-Democratic Republic of the Congo** (Goma, Bukavu and Panzi), week 38, from 19 to 22 September 2022, 4 days, including journey time.
- 3) **El Salvador** (San Salvador), week 44, from 30 October to 2 November 2022, 4 days, including journey time.
- 4) **Pakistan** (Islamabad), week 51, from 19 to 21 December 2022, 3,5 days, including journey time.

The Coordinators also decided to plan early 2023 missions to the **Colombian/Venezuelan border** (turquoise week of February 2023) and to the **Philippines** (turquoise week of April 2023).

B.DROI hearings during second half of 2022

Decisions: The Coordinators decided to organise the following hearings during the second half 2022:

- 1) **the OSCE Office for Democratic Institutions and Human Rights (ODIHR)**, 2 paid experts, 26 September 2022,
- 2) **The African Union and its human rights and democracy mechanisms**, possibly jointly with DEVE, 2 paid experts, 10 October 2022,
- 3) **Protecting indigenous peoples' rights in Brazil**, 2 paid experts, 11 July 2022,
- 4) **The human rights situation in Sahel following the series of (attempted) coup d'états**, possibly jointly with SEDE, 2 paid experts, 26 October 2022,

5) **Human rights violations by mining companies in Guatemala**, 2 paid experts, 5 September 2022.

C. DROI programme with National Parliaments during the second half of 2022

Decision: The Coordinators decided to request authorisation for an Inter-parliamentary Committee on “**the principle of universal jurisdiction**” on 12 July 2022.

D. DROI programme for urgency resolutions’ follow-up

Decisions: The Coordinators decided to organise a follow-up session with the EEAS and/or EC for the urgency resolutions on **Egypt, Ethiopia, the Philippines, Sudan, Turkey, Saudi Arabia and Wagner Group**.

II. DROI non-legislative and legislative Own-Initiative reports

A. Report on Human Rights and Democracy in the world and the European Union’s policy on the matter - annual report 2022

Decision: The annual report was allocated to EPP for 3 points. The EPP is invited to nominate a Rapporteur by the end of March 2022.

III. DROI opinions

A. DROI Legislative opinion on the Proposal for a directive of the European Parliament and of the Council on corporate sustainability due diligence and amending directive (EU) 2019/1937

Decision: The opinion was allocated to S&D for 3 points. The S&D is invited to nominate a Rapporteur by the end of March 2022.

B. DROI opinion on the LIBE own-initiative report on the Recommendations on the negotiations for a cooperation agreement between the European Union and the International Criminal Police Organization (ICPO-INTERPOL), 2022/2025(INI)

Decision: The opinion was allocated to EPP for 1 point. The EPP is invited to nominate a Rapporteur by 25 March 2022.

C. Opinion in the form of a letter to the JURI own-initiative report on Better Regulation: Joining forces to make better laws (COM(2021)0219).

Decision: The opinion was allocated to the Chair in her capacity as Chair by written procedure. The draft letter will be circulated to DROI Coordinators for comments/amendments in the coming days and will be subsequently endorsed by AFET Coordinators by written procedure.

IV. DROI Expertise budget for 2022

Decision: The Coordinators endorsed suggested working methods. Decisions on external expertise will be taken at the Coordinators' meeting of 10 May 2022.

V. AOB

Decision: The Coordinators decided to send DROI priority to AFET for the work programme of the European Commission. A draft paragraph will be submitted to the Coordinators by written procedure by the end of the week.

VI. Date of next meeting

Next Coordinators' meeting will take place on 10 May 2022.
