Subject: The European Parliament's single seat is in Strasbourg

According to the Treaty on European Union (TEU), particularly the Protocol (No 6) on the location of the seats of the institutions of the European Union, '[-t]he European Parliament shall have its seat in Strasbourg where the 12 periods of monthly plenary sessions, including the budget session, shall be held. The periods of additional plenary sessions shall be held in Brussels.' ¹

Article 17(1) of the Treaty on European Union stipulates that '[-t]he Commission shall promote the general interest of the Union and take appropriate initiatives to that end. It shall ensure the application of the Treaties, and of measures adopted by the institutions pursuant to them.'

Every month, on Thursdays during plenary sessions in Strasbourg, hardly any issue directly affecting Europe is placed on the agenda 2 .

- 1. Given the goals it proclaims for ecology and sound financial management, did the Commission take the initiative of making its statement on its 'European Green Deal' at Parliament in Brussels, instead of in Strasbourg during an extraordinary part-session on 11 December 2019? ³
- 2. Has the Commission calculated the cost of this extraordinary part-session?
- What arrangements has the Commission made to present in Strasbourg, in line with the EU
 Treaties, those of its initiatives and actions that account for a significant share of the EU budget 4
