5. **Chair's announcements**

Summary of decisions and recommendations of the Coordinators' meeting of 13 July 2020 (videoconference)

1. Planning of ECON work in the coming months

- General principles: it was agreed that priority should be given to legislation, obligatory hearings (SSM, SRB, ESA Chairs, Monetary Dialogue, ESRB) and INIs that may play a central role in public debate, in particular with respect to upcoming Commission proposals.
- For other types of events (exchange of views with EFB Chair, ECA reports, study presentation on the options for the ECB's monetary policy review), the Open Coordinators' format should be used where possible.
- In view of the constraints and challenges involved, it was decided not to proceed with the organisation of the meeting with national parliaments on the Semester this year.

2. Public hearing on improving the accountability of the ECB

Following a discussion, the Chair will send her proposed list of speakers for the two panels to Coordinators. The Chair expressed the wish to have gender-balanced proposals (e.g. one woman, one man) from each group for future similar events.

3. Economic governance

The Chair will write to the newly elected Eurogroup President, reiterating ECON's requests for enhanced cooperation, and inviting him to an exchange of views in ECON as soon as possible after the summer recess.

4. iVote

The Secretariat was asked to provide Coordinators with further information on the matter.

5. Dates for Coordinators' meetings until the end of 2020

The suggested dates for September and October were endorsed. The Secretariat was asked to suggest other dates for November and December.
