## **2. ECON Contribution to Summary Report / Commission work programme**

Coordinators agreed on the ECON contribution to the Summary Report, including a part on taxation based on a contribution from the FISC Subcommittee.

## **3. Visit to the ECB, Frankfurt: 10 July 2023**

The general topics for the visit as suggested by the ECB were agreed:

- monetary policy;
- banking supervision;
- digital euro.

## **4. ECON's cooperation with the Verkhovna Rada of Ukraine**

Following background information given by the Chair, in particular that two Rada committees fall in ECON's field of competence (Committee on Economic Development and Committee on Finance, Tax and Customs policy), Coordinators agreed in principle on cooperation with Rada and decided that each group should nominate a Member who would be responsible for relations with Rada.

## **5. Economic Governance Package**

Coordinators agreed to hold an exchange of views with the Commissioners in charge of the review of the economic governance framework in the format of an Open Coordinators' Meeting.

## **6. Restructuring the Union framework for the taxation of energy products and electricity (recast) (2021/0213(CNS))**

It was agreed that the ECON Chair and the Rapporteur would write a letter to the Commission, requesting the speedy delivery of an impact assessment and emphasising that ECON wishes to conclude the work on the file before the elections.

## **7. DAC 8**

In view of the fact that Council reached a political agreement on the file without waiting for Parliament's position, Coordinators agreed to send a letter to the Commission and the Council Presidency to remind them of Parliament's role and the Framework Agreement in order to avoid any similar situations in the future.

## **8. FISC Subcommittee**

Coordinators endorsed the summary of the FISC Coordinators' meeting of 25 April 2023.
