of the meeting from Wednesday 28 June 2023 to Thursday 29 June 2023

Brussels

The meeting opened at 10:10 with Irene Tinagli, Chair, presiding.

The Chair made a brief announcement on the interpretation facilities available for the meeting.

4. Report on ongoing interinstitutional negotiations

AIFMD/UCITS - Trilogue of 13 June 2023

Co-legislators held a 3rd trilogue on the revision of the Alternative Investment Fund Managers and UCITS directives on 13 June in Strasbourg. Progress was made on

some issues including liquidity management tools, the use of depositories in a different Member State from the fund, sharing of information with tax authorities, and non-cooperative jurisdictions. However, obstacles to agreement remained and could not be solved at that meeting, in particular as regards the rules concerning loan originating funds and supervisory reporting on delegation arrangements. A date was identified for a fourth trilogue before the end of the month, but the Swedish presidency decided unilaterally that they would not attend it and would hand the file to the Spanish presidency. I wrote to the Ambassador to express concern about how this was handled.

Banking package: CRR 3 and CRD 6 – Trilogues of 6 June, 15 June and 26 June 2023

The fourth and fifth trilogues on amendments to the Capital Requirements Regulation (CRR 3) and the Capital Requirements Directive (CRD 6) took place on 6 and 15 June 2023 respectively. During this two trilogues co-legislators already provisionally agreed on a large number of issues, including ERM II Currencies, Shadow Banking, large parts of OpRisk, Information Exchange between Tax authorities, Reports and Reviews, large parts on Market Risk, on Credit Risk and large parts on ESG Risk, Crypto assets, and Prudential relevant transactions.

Following intense and difficult negotiations, the trilogue parties finally reached in the morning of 27 June also a provisional political agreement on the major remaining political issues: the level of application of the output floor, fit and proper requirements and the supervisory regime of third country branches.

The provisional political agreement reached reflects major requests of the Parliament. In particular, the ESG risk framework could be strengthened and a transitional prudential treatment for crypto assets could be established, until the Commission is putting forward a dedicated legislative proposal. In addition, stronger requirements for third country branches and a strengthened fit and proper framework could be achieved.

Central Securities Depositories (CSDR) review - trilogue of 27 June 2023

On 27 June 2023, the second trilogue on the CSDR took place. During the trilogue, co-legislators reached a provisional political agreement on the outstanding matters, in particular on colleges, the role of ESMA and the regime for third-country CSDs. The work at technical level will now continue in order for co-legislators to vote on the provisional agreement in COREPER and ECON, respectively.

ECON-LIBE file: Anti-Money Laundering Regulation - Trilogue of 14 June 2023

On 14 June 2023, the second trilogue on the Anti-Money Laundering Regulation took place in Strasbourg. On this occasion, Co-legislators discussed measures relating to Targeted financial sanctions (TFS), notably risk assessment/internal controls/CDD, scope of TFS provisions, and bridging mechanism. They also discussed the scope with regard to obliged entities subject to AML/CFT obligations, notably the inclusion of intermediaries in Non-Fungible Tokens (NFTs), dealers in precious metals, stones and

other luxury articles, and football clubs - and addressed exemptions for certain providers of gambling services. Finally, they discussed prohibition of disclosures and measures related to data processing. A mandate for conducting further technical work has been agreed on.

ECON-LIBE file: Regulation establishing the Authority for Anti-Money Laundering and Countering the Financing of Terrorism - Meeting of 28 June 2023

At a meeting this morning, an agreement in principle was reached on the selection criteria for the seat of the AML authority, and technical work was mandated on the application procedure.
